BILL.

An Act to amend and consolidate the Usury Laws of this Province, and for the better regulating the Rate of Interest.

HEREAS it is expedient to amend the laws relating to Interest of Money, Preamble, and for that purpose to repeal the Act of the Parliament of this Province, passed in the sixteenth year of Her Majesty's Reign, and intituled "An Act to modify the Usury Laws," as to future contracts: Therefore Her Majesty, by and with the 5 advice and consent of the Legislative Council and Assembly, enacts as follows:

I. From and after the passing of this Act, the Act mentioned in the preamble of leave contracts this Act, shall be, and the same is hereby repealed, except only as to contracts future contracts, made after it came into force and before the passing of this Act, as to which it shall remain in force: Provided always, that any Act or any part of any Act, ordinance Provise.

VI. Nothing in this Act shall be construed to apply to any Corporation or Association of persons heretofore authorized by law to lend or borrow money, at a rate of Interest higher than six per cent. per annum; Provided always that it shall not be lawful for any Chartered Bank in this Province to take or receive as agency, exchange or commission on the discount of any note, bill or other negotiable 5 security or paper payable at a different place in this Province other than that at which the same is discounted, more than one quarter per cent. in addition to the discount, any law of the Province to the contrary notwithstanding.
