

An Act to amend An Act to incorporate the Pilots for and below the Harbor of Quebec.

WHEREAS it is expedient to amend the Act passed in the twenty- Preamble. third year of Her Majesty's Reign, chapter one-hundred and twenty-three, intituled, "An Act to incorporate the Pilots for and 23 V., c. 123. below the Harbor of Quebec"; Therefore, Her Majesty, &c., enacts as 5 follows:

1. From and after the passing of this Act, the words "twenty-fifth Sect. 13 and day of November," in the thirteenth and nineteenth sections of the Act first above mentioned, shall be repealed and replaced by the words "tenth day of December."

2. The twenty-first section of the Act first above mentioned is here- New Section 10 by repealed, -- and replaced by the following which shall bear the same substituted for Sect. 21. number:

"21. From and after the passing of this Act, the income of the said The New Sec-Corporation shall consist of all sums of money arising; 1st, from the Income of 15 pilotage of all ships and vessels required by law to take a pilot in and Corporation. below the Harbor of Quebec ; 2nd, from the other services rendered by the pilots and for which they could, previous to their incorporation, claim a salary or remuneration; 3rd, from all fines, penalties or condemnations which previous to the passing of the said incorporation Act, 20 would have belonged to the pilot sueing for the same or to which he would have been entitled."

3. It shall be lawful for the Board of Directors, from and after the Penalties for contravenpassing of this Act, by one or more By-laws, to impose fines and pen- tion of Byalties not exceeding in any case forty dollars, on any person violating laws. 25 any requirement or provision of their By-laws.

4. The twenty-eighth section of the said Act first above mentioned Scct. 28 to shall apply to the claim and recovery of the above mentioned fines and apply. penalties, and of the sums to which the said Corporation may be entitled by virtue of this Act or the Act hereby amended.

7. This Act shall be a public Act.
