With reference to our conversation this afternoon regarding the co-operation of the Pulp and Paper Association with McGill University in the matter of the establishment of a Chair in Chemical Engineering, I think it well to commit to paper our understanding:

(1) McGill University will assign to the development of this Department the whole of the income to be derived from Mrs. Eddy's bequest of \$200,000. This amount has not yet been received by the University authorities, but we hope it will be available before the end of this year, in as much as Mrs. Eddy died in 1921 and the four years limitation will have expired this year.

(2) The University will proceed immediately to procure the services of Mr. Johnsen as Professor of Chemical Engineering, will provide him with laboratory space and instruct him to direct his researches altogether in the field of problems pertaining to the pulp and paper industry. It is understood that Mr. Johnsen may be induced to join the staff of McGill University if he receives an annual salary of \$15,000. The University suggests that half of this amount be contributed by the Pulp & Paper Association for a term of five years, Edward Beck, Esq., -2 -

when the relation between the Association and the University will be examined and revised if necessary.

(3) In case of Mr. Johnsen's retirement at any time, thus rendering the position filled by him vacant, the University undertakes to engage as his successor an expert agreeable to the Pulp & Paper Association. In fact, in the conduct of this Department we shall always appreciate the advice of the Association, and in this connection I would suggest that a small committee of, say, three be named by the Association to sit with a University committee to consider all matters pertaining to the work of the Department about to be inaugurated.

Mr. Kynoch, Director of the Forest Products Laboratories, tells us that in a conversation he had with you today you expressed some concern regarding the certainty of the government's willingness to assume its share of the cost of upkeep, administration and maintenance of the Pulp& Paper Research Institute which our Association has undertaken to build in conjunction with the University and the Forest Products Laboratories.

May I say that the Association, in this matter, is relying upon representations made to us by Mr. E.H.Finlayson, Director of Forestry, Department of the Interior, Forestry Branch, Ottawa, who is chief of the service which controls the operations of the Forest Research Laboratories. Both verbally and in writing Mr. Finlayson has given us to understand that his Department will be agreeable to seeing that provision is made for its share of the expense in question out of the annual appropriations. In a letter to the Association, under date of May 26th, 1926, Mr.Finlayson wrote:

"Notwithstanding the difficulties I see in providing <u>capital</u> expenditure from government sources, the question of annual expenditures for rentals, operations and research are as a rule quite readily provided. Rentals, light, heat, power and janitor service are a matter for the Public Works Department, but these are readily provided for in current expenditure. Operation and research are readily provided for in our annual appropriations. Providing, therefore, that reasonable arrangements could be made, I foresee little difficulty in providing these annual expenditures."

While this does not by any means constitute a guarantee upon the part of the government or of the Department, we look upon it as an assurance that when the time arrives there will be little difficulty in coming to a satisfactory understanding with them.

Unfortunately Mr.Finlayson is away on leave of absence just at present. He is expected back shortly, however, and if the question could be held in abeyance pending his return we do not think any interest would be sacrificed, while to take it up with Ottawa in his absence might conceivably result in complications.

I just had an interview with Mr. D. R. Cameron of the Forestry Department, Dominion Government, Ottawa. He called to discuss arrangements as to the maintenance charges of the new building to be erected by the Pulp and Paper Association and which will house the Pulp and Paper Division of the Forest Products Laboratories, the Cellulose Institute and the Pulp and Paper Association offices and research laboratories.

We have always estimated the maintenance charges for such a building to be about \$18,000 per annum, and have considered that each party interested should pay one-third. Mr. Cameron pointed out that it . would be difficult to induce the Government to agree to pay a lump sum, as charges for gas, power, heating, etc. are usually paid by the Public Works Department, while certain other charges for janitor service, minor repairs were borne by the Pulp and Paper Division. I agreed with him that the University would furnish gas, power, heating, light, water and steam at rates charged for such services, and that the University would control the janitor services charging each unit concerned with cost based on space. The University was to submit a proposal to the Government and Mr. Cameron promised to see it through. I may also add that Mr. Finlayson assured me yesterday that anything Mr. Cameron agreed to would be made effective by the

Mr. Cameron also informed me that with reference to the Forest Products Laboratories the Government would only agree to keep them in Montreal on the same basis as now existed, namely, that the University should supply the space and the Laboratories would pay the maintenance cost. I told him that in these circumstances there was no use negotiating any further in this matter, as the University felt it was in no way obligated and could not afford to construct new laboratories for the Forest Products people.

MEMORANDUM

DRAFT AGREEMENT REGARDING USE AND MAINTENANCE

of

THE PULP AND PAPER RESEARCH BUILDING.

Generally speaking this Agreement provides as follows :-

1. As regards research and our relations concerning staff, etc., with the Pulp and Paper Corporation, the arrangement indicated by this agreement is what we proposed.

2. As regards maintenance, the Fulp and Paper Research Corporation is to give us a lump sum of \$100,000. which means that according to this Agreement their total contribution would never be more than \$6,000. Paragraph 4 provides that if the Government comes in, we each get one half of the Government contribution. This means, of course, that according to this Agreement, if the Government came in the Pulp and Paper Corporation would pay \$6,000. and we \$12,000., against which the Pulp and Paper Corporation would receive \$3,000. and we \$3,000. from the Government.

In order to make an arrangement satisfactory to us, three things are necessary:-

- a. Paragraph 4 must be altered and the provision about the division of Government subvention between ourselves and the Pulp and Baper Corporation must be taken out.
 - b. An Order in Council must be passed, providing a definite contribution by the Government of \$6,000. a year.
 - c. A contract must be made between ourselves, the Pulp and Paper Association and the Government.

If the Government do not make a definite agreement, then the amount paid over in bonds or otherwise by the Pulp and Paper Corporation would have to be \$150,000. not \$100,000.

So far as I can see, they have put us into the position where we must make an arrangement with the Government. MEMORANDUM OF AGREMENT made and entered into this day of February, One thousand nine hundred and twenty-seven,

BY AND BETWEEN:

THE ROYAL INSTITUTION FOR THE ADVANCEMENT OF IEARNING, herein acting and represented by one of its Governors, (hereinafter called "the University"),

Party of the First Part,

AND

CANADIAN PULP & PAPER RESEARCH CORPORATION,

herein acting and represented by

(hereinafter called "the Corporation"),

Party of the Second Part.

WHE MAS, firstly, the University obtained an amendment to its statutory powers enabling it to grant emphyteutic leases of any of its immoveable property for any term of years not exceeding ninetynine, nor less than nine.

WHE REAS, secondly, the University has this

day executed in favour of the Corporation an emphyteutic lease of certain property therein described for the term of forty years for the purpose of the erection upon the property so leased of a building to be used for the purposes hereinafter set forth; and

WHEREAS, thirdly, the Corporation has been incorporated under the laws of the Province of Quebec for the purposes hereof.

NOW, THE REFORE, THIS AGREEMENT WITNESSETH AS FOLLOWS: -

1. The Corporation shall erect upon the premises so conveyed to it by the University a building to provide permanent, separate and adequate accommodation, firstly, for a Cellulose Institute to be operated by the Department of Industrial and Cellulose Chemistry of McGill University (hereinafter called "the University Department"), and, secondly, for a Technical Organisation maintained for research by the Corporation.

2. The building above referred to shall be offonce erected on the site in question and fully equipped. All plans and specifications are to be subject to the approval of the University and of the Corporation. The contract for the building is to be made by, and the construction thereof carried out at the expense of the Corporation.

3. The building shall be maintained and administered by the University at its own cost and charges.

save that the Corporation shall, as soon as the building has been erected and is ready for operation, pay over and convey to the University, the sum of \$100,000, partly in cash and to the extent of \$,000. in Bonds of the issue to be referred to hereafter, bearing interest at the rate of 6% per annum, the said cash and Bonds to remain the property of the University which shall apply the income and interest thereof to the administration and maintenance charges.

4. Should any arrangements be made during the term of the above mentioned Lease by the parties hereto with the Dominion Government for the use by the latter of any portion of the buildings to be erected. or of the operations or research facilities therein, any consequent contribution or payment by the Dominion Government shall enure to the benefit of the parties University hereto in equal shares.

5. At the termination of the Lease above referred to, the buildings and equipment shall become the property of the University, provided that should the building be paid for out of the proceeds of a Bond Issue made by the Corporation, and should the Bonds be redeemed in less than forty years, the building shall become the property of the University immediately upon the redemption of such Bonds.

6. During the life of this agreement and of the Lease, the University shall have one representative on the Board of Directors of the Corporation.

7. Graduates and graduate students of McGill University selected by the Director of the University Department, may carry on research and study with the Technical Organisation, and members of this Organisation who are to undertake any teaching duties or the direction of research work by graduates qualifying for higher degrees in McGill University, shall be on the staff of the University, and shall be entitled to its facilities, and shall be appointed by the University and the Corporation jointly.

8. The Cellulose Institute shall be under the sole control of the University, and its activities shall be primarily directed to research and teaching of general scientific value. The Technical Organisation shall be under the sole control of the Corporation and its activities shall be mainly industrial and technical. It is, however, the intention of the University and the Corporation not to make any conditions which will limit or hamper the work of the Cellulose Institute or of the University Department on the one hand, or of the Technical Organisation or of the Corporation on the other, but to co-operate as efficiently as possible, and for that purpose the Directors of the Corporation shall form an Administrative Committee for the Government of the Technical Organisation, and on that Committee, if satisfactory, arrangements can be made therefor, the Dominion Government shall also be represented for so long as it contributes to the work and costs of administration and maintenance as aforesaid.

MEMORANDUM

POWER REQUIREMENTS - EXPERIMENTAL MILL

C. P. P. R. C. Building.

The total power requirements of the mill may best be divided by Departments as follows:-<u>I</u>} Groundwood Department -

Wood Pulp Grinder 150 K.W.

2) Paper Making Department -

Beaters, jordan, stock chests, pumps, paper machine etc.

50 K.W.

3) Screening Department -

Knotter, decker, Rotary screen, centrifugal screen wet machines, pumps, etc. 38.1 K.W.

4) Wood Room Department -

Chipper and chip screen. 22.35 K.W. 5) Machine shop -

Machine shop tools. 4.47 K.W.

The groundwood department has been designed to investigate the mechanical grinding of wood over a wide range of conditions and to accomplish this great latitude must be allowed in power demand. It is estimated that the demand of the grinder motor will vary from 100 K.W. to 225 K.W. with a normal operating demand of 150 K.W. For accuracy in power readings this motor will be operated on Direct Current and to furnish this current a suitably designed motor generator set will be installed to operate on the 4000 volt primary(A.C.)current from the Montreal Light, Heat and Power Consolidated lines.

The grinder, howeyer, will only be operated occasionally, probably not more than six hours per week based on a five year contract and for the large majority of the tests it will not consume more than its normal demand of 150 K.W.

From the point of view of staff requirements it is very improbable that the Screen Department and the Paper Making Department will be operated simultaneously. On this basis 60 K.W. may be taken as the probable maximum for mill power requirements exclusive of the grinder. As this is based on connected load the normal operating requirements would probably be from 45-50 K.W.

With these peculiar operating conditions it would seem reasonable to hope that a power contract could be devised which would meet with the approval of the Montreal Light, Heat and Power Consolidated Co. and at the same time be fair to us under our exceptional conditions of operation.

Such a contract might be based on the following points:-

- I That we pay stand-by charges on 115 K.W., our total connected load exclusive of the grinder.
- 2 That we pay for all power consumed on some mutually agreed scale of rates.
- 3 On the basis of payment as outlined in I and 2 above that we be allowed to increase our power demand up to 150 K.W. for a maximum of six hours a week, accumulative, but said demand never to exceed 18 hours in any one week.
- 4 On the same basis of payment that we be allowed to increase our demand up to a maximum of 225 K.W.

Dear Mr. Robb :-

Sir Arthur has asked me to write you regarding the history of our Pulp and Paper Building the corner stone of which you are to lay on October 13th.

The Canadian Pulp and Paper Association has for some time been interested in the possibilities of research, and a brief account of the work carried on up to this year is given in a booklet published to explain the present scheme. "The members have long realized that in respect to scientific research into the problems of forestry, cellulose chemistry, thermodynamics and the like their interests were practically identical. From its foundation the Association has always taken an active interest in such research, and the Technical Section, formed in 1913, has done a great deal to encourage and forward it. It was not, however, until 1928 that definite steps were taken to establish research as one of the Association's major activities, when a committee under Col. C.H.L. Jones of the Spanish River Fulp and Paper Mills Limited was appointed to inquire into certain proposals regarding the Forest Products Laboratories. In 1924 this committee reported in favour of a co-operative arrangement between the Association and the Dominion Government for the control of the Pulp and Paper Division of the Laboratories for five years at an expense to the Association of \$20,000. for the first year and not less than that amount for each succeeding year. This report was adopted and at the same time

the Woodlands Section of the Association was granted \$2,000. to assist in certain researches into the utilization of decayed wood. Two years later, in January 1926, the committee reported that the Laboratories scheme was in full operation except that one or two important staff positions remained temporarily vacant owing to difficulty in finding the right men. A budget was submitted calling for \$50,000. for two years 1926-7, and was voted; and at the same meeting \$6,000. was voted to the Woodlands Section for investigational work".

-2-

Closely connected with the work carried on by the Technical Section of the Canadian Pulp and Paper Association has been that of the Pulp and Paper Division of the Forest Products Laboratories of the Dominion Government which has for some years been housed at McGill and has thus enjoyed the facilities of the University. Since 1915 this section has carried on research in the mechanical properties of Canadian woods, and in the physics and chemistry of wood pulp. Investigation of the highest importance into the anatomy of woods has been made and recorded not only in figures but in thousands of Lantern slides.

When the University was enabled to found its Department of Industrial Chemistry it became evident that possibilities existed for cooperation between the Government, the industry and the University which must be of the greatest value to all concerned, and at a meeting held on June 25th of the present year the Association resolved to offer to provide on the University grounds adequate accommodation for the three organizations concerned and to join in arrangements for their maintenance. The site is being leased at a nominal rental by the University and the cost of construction is to be borne by the Pulp and Paper Association. Maintenance charges will be carried by the different authorities interested. The new building will provide permanent, separate and adequate accommodation, first for a Cellulose Institute to be operated by the Department of Industrial and Cellulose Chemistry of McGill University and second for the technical organization maintained for research by the Pulp and Paper Association and so long as it co- perates by making the Pulp and Paper Division of the Forest Products Laboratories part of such organization - the Dominion Government.

Graduate and undergraduate students of McGill University selected by the director of the University Department may carry on research and study with the technical organization, and members of this organization who are to undertake any teaching duties or the direction of research work by graduates qualifying for higher degrees will be on the staff of the University and will be entitled to its facilities and will be appointed by the University and Association jointly. Honourable James A. Robb.

While the Cellulose Institute will be under the sole control of the University and its activities primarily directed to research and teaching of general scientific value, and while the activities of the technical organization will be mainly industrial and technical, the intention of the University and the Association is not to make any condition which will limit or hamper the work either of the Department or of the technical organization, but to comperate as efficiently as possible.

-3-

Dr. Harold Hibbert who has been appointed head of our new Department is one of the best known industrial chemists. He has studied and carried out research in England, Germany and the United States. He is thoroughly acquainted with industrial requirements and in touch with most industrial concerns.

While it is somewhat difficult to make distinctions, the persons particularly interested and enthusiastic have been Mr. Wilson of the Abitibi Company, Colonel Jones of the Spanish River Company, Mr. Hovey of the Abitibi Company and Mr. Beck.

So far as the University is concerned we hope that the foundation of this Institute will initiate a still broader plan of co-operation with industrial concerns in the application of science to industry. We expect that before long another building will be erected on University Street in which our staff will carry on researches definitely asked for and of value to scientific industries.

May I venture to take this opportunity of saying how much we appreciate the interest which we know you to take in the University and how pleased we are that you will officiate on this occasion.

MEMORANDUM

DRAFT AGREEMENT REGARDING USE AND MAINTEMANCE

of

THE PULP AND PAPER RESEARCH BUILDING.

Generally speaking this Agreement provides as follows :-

1. As regards research and our relations concerning staff, etc., with the Fulp and Paper Corporation, the arrangement indicated by this agreement is what we proposed.

2. As regards maintenance, the Pulp and Paper Research Corporation is to give us a lump sum of \$100,000. which means that eccording to this Agreement their total contribution would never be more than \$6,000. Paragraph 4 provides that if the Government comes in, we each get one half of the Government contribution. This means, of course, that according to this Agreement, if the Government came in the Pulp and Paper Corporation would pay \$6,000. and we \$12,000., against which the Pulp and Paper Corporation would receive \$3,000. and we \$3,000. from the Government.

In order to make an arrangement satisfactory to us, three things are necessary :-

- a. Paragraph 4 must be altered and the provision about the division of Government subvention between ourselves and the Pulp and Paper Corporation must be taken out.
- b. An Order in Council must be passed, providing a definite contribution by the Government of \$6,000. a year.
- c. A contract must be made between ourselves, the Pulp and Faper Association and the Government.

If the Government do not make a definite agreement, then the amount paid over in bonds or otherwise by the Mulp and Maper Corporation would have to be \$150,000. not \$100,000.

So far as I can see, they have put us into the position where we must make an arrangement with the Government.

In conference with Mr. Kynoch, following your suggestion of this morning, we wish to advise as follows:-

In order to clarify the situation as much as possible, Mr. Beck, Secretary of the Canadian Pulp and Paper Association has forwarded you this afternoon memorandum giving you a resume of the correspondence and negotiations with Mr. Finlayson of Ottawa who represents the Department of the Interior.

The contract to which you referred us this morning dealing with the appropriations to be paid by the three parties proposing to occupy the new Cellulose Institute was drafted by the firm of Brown, Montgomery & Co., presumably at Col. Bovey's request, so that we may assume it represents a tentative draft only.

The maintenance charges of the Cellulose Institute will be considered first.

The question of allocating a definite sum as rental has not been placed before Mr. Stewart, or Deputy Minister, by Mr. Finlayson because it is considered that such a step would be inadvisable and judicious at the present moment.

Nevertheless, Mr. Finlayson feels that there should be no question of the willingness of his department to pay out from their annual grant the sum of approximately \$6,000.00 for the specific purpose of maintenance

charges, and it is Mr. Kynoch's understanding that Mr. Finlayson intends to bring this to the attention of Mr. Stewart in the near future in the form of a request for the definite allocation of a fixed proportion of their annual grant - approximately \$6,000.00 - for annual maintenance charges.

It should be noted that Mr. Finlayson is unfortunately away from Ottawa at the moment and would undoubtedly much prefer to handle this matter himself since it is very important that Mr. Stewart be given to understand we are not calling upon the Government for any gift to McGill, but merely the defraying of certain definite maintenance charges as specified above.

We are therefore both of the opinion that until Mr. Finlayson's return, you should leave over the definite settlement of the manner in which this agreement is to be concluded as relates to the new Cellulose Institute. Sir Arthur W. Currie....#2.

The second point relates to the maintenance charges to be borne by Mr. Finlayson's department in connection with the building in which it is suggested that Mr. Kynoch and his staff should be present.

It seems desirable to bring to the attention of Mr. Stewart tomorrow the fact that the University is considering the erection of a new Industrial Institute in which arrangements could be made to accommodate Mr. Kynoch's department, provided the Government were willing to assume the maintenance charges for that portion occupied by them.

These charges, according to a rough estimate, would be approximately \$7500.00, and the University would not be willing to go ahead with any additional building scheme unless it could receive the assurance of Mr. Stewart that this money would be forthcoming. This assurance thus becomes largely the determining factor influencing the University in their decision to proceed with the new building.

Mr. Kynoch will be glad to go over this matter in greater detail with you prior to the meeting.

My dear Sir Arthur:-

Very many thanks for your letter of May 4th. on the subject of the proposed appointment to the Pulp & Paper Chair and intimating the attitude of your people towards Dr.Johnsen.

We have all been giving this matter a great deal of thought during the past few months and it has recently reached the point where Dr.Johnsen is prepared to accept the appointment, commencing next year. In the meantime he would finish up with the Hammermill people and then spend a few months in Europe in preparation for taking up the work at McGill. I think we will be very fortunate indeed if we are able to secure Dr.Johnsen.

The matter of the Association contributing \$7,500. annually, one-half of the proposed salary, is now being actively followed up and we hope very shortly to have something definite on this. Personally, I am very much in favor of closing the whole matter up and getting Johnsen definitely appointed and I believe a great many of our Association members have the same feeling. I am glad to know that this is your feeling as well and I am confident that something will be accomplished.

Our whole Research situation in conjunction with the Government has progressed very well indeed and if we can now bring about the McGill appointment everything will be in fine shape.

We hope to have something definite from the Association at an early date and I shall write you further at that time.
