KING'S COLLEGE,

WINDSOR, NOVA SCOTIA.

THE GOVERNORS of King's College present the following Statement of their proceedings during the past year, and of the present condition of the Institution,—for the information of its supporters, and of the public at large.

1.—The Act of the Provincial Legislature passed in the year 1789, establishing and endowing King's College, Windsor, having been repealed in 1853,—and another Act having passed the Legislature and received the assent of the Queen, abolishing the former Board of Governors, and making various other alterations in reference to the Institution, a new Board was elected according to the terms of this Law, at a general meeting of the Incorporated Alumni, held at Halifax, on the 10th day of February, 1854, when the following gentlemen were duly elected:—

Of these Governors two retire each year, but may be re-clected. The Bishop of Nova Scotia for the time being, is President of the

Board, and Visitor of the College.

The Hon. Brenton Halliburton, Mc Hon. James B. Uniacke, the Hon. Lewis M. Wilkins, and the Rev. Dr. McCawley, members of the former Board, are continued in office for life, by the 2d Section of the new Act.

Mr. Justice Parker, having subsequently resigned, the Rev. J. W. D. Gray, D. D., of St. John, N. B. was elected in his place.

The Archbishop of Canterbury for the time being, is Patron of the College.

2.—The first meeting of the new Board was held at HALIFAX, on the 17th day of February, 1854, when John C. Halliburton, Esq., was appointed Treasurer, and the Rev. James C. Cochran, A. M. Secretary.

Committees were immediately formed for examining the financial affairs of the College, for revising and remodelling the Statutes, and for the management of the Lands belonging to the Corporation. These Committees have given laborious attention to the various matters entrusted to their care. The result has been the careful investment of the Funds, handed over by the late Board, the compilation of a new code of Statutes, adapted to the circumstances of the Institution and of the country, and embracing many important improvements as regards the discipline and the internal management of the College.

3 .- The resources of the Institution being found wholly inadequate to the maintenance even of the former limited establishment, and it being deemed essential to add at least a Professorship of Chemistry and Natural History, and one of Pastoral Theology, it was resolved to attempt at once to raise Ten Thousand Pounds, as a permanent endowment. Appeals to that effect were accordingly circulated throughout the country, early in the year, and the Secretary was sent forth as agent, to follow up this appeal. A vigorous impulse was given to the liberality of contributors by the generous offer of the Hon. Mr. Collins, to pay the sum of £1000 so soon as the remaining nine thousand pounds were secured. In the discharge of his duty, the Secretary visited with few exceptions, the whole of Nova Scotia, besides Charlottetown, P. E. I., and part of New Brunswick. By the divine blessing on these endeavours the whole of the proposed sum has been raised and invested for the benefit of the College; and the Governors take this opportunity of returning their warmest acknowledgements to all those who have so generously and so readily responded to the call made upon them, thereby rescuing from impending dissolution a Seminary of vital importance to the Church of England in this Province, in particular, as well as to the country at large.

nowpondnding nd in 4.—The Agent was every where cheered in his progress, by the good feeling which he met with in behalf of the undertaking committed to him; and it is believed that the Institution is now more than ever regarded with affectionate interest by our people.

5.—Thus much having been accomplished, the Governors lost no time in seeking for suitable persons to fill the vacant Professorships. The Rev. G. W. Hill, M. A. was appointed to the chair of Pastoral Theology; Mr. John M. Hensley, B. A. to that of Mathematics and Natural Philosophy; Henry How, Esq. of the University of Glasgow, to that of Chemistry and Natural History; and Henry Stiefelhagen,

Esq. to the Professorship of Modern Languages.

These gentlemen have now been engaged for some months, in the duties of their respective departments, devoting themselves assiduously and effectively to the advancement of the young men, and fully justifying the high testimonials as to their ability and character, which had been submitted to the Board. Under these four Professors, together with the accomplished scholar who has for nearly twenty years presided over the Institution, the students enjoy educational advantages far beyond those which fell to the lot of their predecessors; and it is satisfactory to find in the recent examinations, abundant evidence, at once of the laborious diligence of the Professors, and of the proficiency of the students. Still more pleasing is it to be assured by the officers of the College, that the moral condition of the Institution was never better.

6.—It is to be hoped, that when the important improvements which have been introduced are more generally known and considered, a much larger body of students will be attracted to the Institution; and especially that the valuable privilege of exemption from fees, secured to so many of the contributors to the Endowment Fund, will not be suffered to lie dormant.

7.—The Governors would call particular attention to the permission now granted to the young men, to devote their time to any one or more branches of study, without being obliged to go through the whole Curriculum; and, also, to the fact, that students may now, with the President's sanction, reside out of College, while pursuing their studies; and, moreover, that no religious test is required of them, but that they may attend such place of worship as their friends desire.

8.—His Grace the Lord Archbishop of Canterbury, the Patron, in a letter to the Visitor in the early part of the present year, was pleased to express himself in the following kindly terms in reference to the College. "I rejoice that you are able to speak so satisfactorily of Windsor College. The Statutes appear to be such as are likely to secure their object; and I will endeavour to testify my interest in your College, by sending, on some early opportunity, a copy of my works, to the Library, which I beg you to accept as coming from the Patron for the time being." These works are now on the shelves. The following resolution was placed on the minutes. "Resolved, That this Board gratefully acknowledges the kind expressions of interest in the Institutions of this distant part of his Province, contained in the letter of the Lord Archbishop of Canterbury, and confirmed by his valuable donation to the Library, for which the best thanks of the Board are due. The Governors beg to assure his Grace that no exertions shall be wanting on their part, to render the College efficient towards the purpose for which it is designed, and they trust that as its Patron he will always have reason to be satisfied that its system and management are well adapted to promote the advancement of true religion, and sound learning, and the welfare of this branch of the Church, over which his Grace presides."

9.—Early in the last summer, at the request of the Alumni, as expressed in the following resolution, an effort was made to revive the Collegiate Academy, which has always been regarded as a nursery for the College.

"Resolved, That the Governors be requested to adopt measures towards the opening of the Academy, by the engagement of a competent Master. And the Association pledges itself to appropriate the sum of £50 currency, to aid in the payment of his salary, for the year ending 30th June, 1855, and to continue the same for another year."

In accordance with their request, the Rev. D. W. Pickett, A. M., a gentleman highly recommended to the Board, was appointed to the situation of Principal. He opened his school in October last, and is rapidly raising it in public estimation.

The recent examinations have elicited satisfactory, evidence of progress in useful knowledge; and the domestic management is such as cannot fail to relieve parental anxiety, the strictest attention being paid to the moral and religious training of the boys. The Governors

strongly recommend this subsidiary branch of the Collegiate Institution to more general patronage.

It may be added that besides the usual branches of education taught at the Academy, the University Professor of Modern Languages gives instruction to the pupils in French, Spanish, Italian and German.

10.—Among the various subjects to which the attention of the Governors has been turned, the question of discontinuing the salary hitherto given to the Steward, has engaged their careful consideration. The Governors in consequence of the existing high prices of the necessaries of life, have thought it just to defer for the present, any reduction of that allowance. But they have required the Steward to provide additional meals for the students, and to perform new duties without any extra charge.

11.—The College Buildings and the Academy have undergone extensive repairs during the year.

It was satisfactory to find that after standing for nearly sixty years, the old edifice is still substantial and strong. The propriety of erecting suitable houses on the College grounds, for the additional Professors has occupied the frequent and anxious attention of the Governors. A pressing necessity exists for such accommodation, and they hope to be enabled ere long to supply it.

12.—In the appendix, will be found various items of information in reference to the College, and if more is required, it will be gladly afforded, on application to the Secretary.

13.—In concluding this sketch of their proceedings during the past year, the Governors hope that it will be considered as affording satisfactory evidence, that much has been done, during the short period of their stewardship, to increase the usefulness and efficiency of the Institution under their care. They will only add, that it is their earnest desire, to make it, under the divine blessing, still more efficient, and attract within its walls, a yet larger number of the youth of these Provinces; assured that they may there acquire a religious, sound, practical, and liberal education.

No Undergraduate shall resort to any inn, tavern, or public house, except for some special cause, to be approved by the President, or shall spend his time in the streets of the town.

All Bills of Undergraduates are to be sent by the tradesmen with whom the debts are incurred, to the Bursar, at the end of every term; and parents are particularly requested to refuse payment of any bills not thus sent in.

The introduction of spirituous liquors into the College, is absolutely prohibited. [Pages 16 and 17.]

The Academical year shall begin in September, and shall contain three terms, in which all scholastic exercises shall be performed and all degrees conferred. Michaelmas term shall extend from the first Monday in September to December 15th;—Lent term, from the first Monday after January 15th to the Saturday before Palm Sunday;—Easter term, from the Monday after Easter Monday to July 1st.

REPORT

OF THE

EXECUTIVE COMMITTEE OF THE ALUMNI,

FOR THE YEAR ENDING JUNE, 1855.

The period has again come round when the Executive Committee are required, by the Act of Incorporation, to render an account to the Alumni of King's College, of their acts during the past year.

The most important event of the year as the members are of course aware, has been the carrying out of the plan contemplated at the general meeting of last year, for the permanent endowment of the College.

The appeal was met in a most liberal spirit by the members of the Church throughout this Province, as well as in New Brunswick and Prince Edward Island, and many gratifying instances of sympathy and aid were received from members of other denominations.

One inconvenience has, however, resulted from the peculiar mode in which the fund was raised, to which the Committee would draw the attention of the Association: It is no doubt known to all present that the whole amount was raised in the name of this Incorporation; by our Act, donors of £20 or upwards are life-members without the payment of the usual annual subscription of twenty shillings. A number of those who had been annual subscribers became contributors of £20 and upwards to the endowment, and by so doing felt that they ought not to be called on any longer for the annual subscription; this Society was thus deprived of a portion of its income—for the endowment fund, though raised in its name, was really contributed to the general funds under the control of the Governors.

The Executive Committee would therefore call the serious attention of the Society to the present state of its income. The sum required for the ensuing year will be as follows:—

If the means of the Association permitted it the Committee would feel gratified in recommending an extension of the aid now afforded to the College; but it is evident that however pleasing such a step would be, the more urgent duty must first be discharged, of securing an income sufficient to meet the engagements to which the Association is already pledged.

The Committee have much pleasure in announcing to the Association that they have recently received from Charles Merritt, Esq. of St. John, N. B. the very handsome donation of tracts of Land containing in all 800 acres, part of which is under contract to be sold on very favourable terms.

The President and three members of Committee go out of office by rotation, and the Association will now proceed to elect successors.

5. Powers of Matter connected with Chemical Changes, Attraction, Aggregation, Crystallization, Heat, Light and Radiant Matter, Expansion, Specific Gravity, Chemical Affinity, Theory of Combination and Decomposition, Equivalents and Atomic Theory.

MODERN LANGUAGES.

5. The School of Modern Languages is revived and classes will be formed, both in the College and in the Collegiate School, for German, French, Spanish and Italian.

Rev. Professor Hill reports that "the moral behaviour of the students has been excellent throughout the term." Professor Hensley testifies in his report most fully to the same effect. All the Professors have expressed their satisfaction at the general attention paid to the subjects of their respective lectures. Professor How in a detailed account of his department, dwells with gratification on the great interest with which his explanations in Natural Science have been received.

The Chapel lists have been carefully inspected and noted as usual. The written exercises in each department daily, weekly and terminal, testify to the general diligence and assiduity of the students.

J. C. Cogswell, Esq., B. A., has presented the College with a useful Manual of Chemistry, just published in London. In this clear and comprehensive volume is compressed as far as possible, all that is essential to a general view of Chemistry in its relation to Medicine and General Physiology, and it is particularly shewn how these studies have been recently advanced by the aid of Chemical investigations. The Author in his introduction expresses his obligations to Dr. Cogswell (B. A. of this University) for his valuable assistance.

The statutable observances have terminated the Academical year. On Thursday, June 21st, the B. A. Examination commenced in the College Hall, and was continued for three days, from 10 A. On Thursday 28th, THE ENGENIA was celebrated. The President and Professors, the Examiners, Scholars and Students, proceeded to the University Church, where they met the Right Rev. Visitor, the Governors and Alumni, including numerous Doctors, Masters and Bachelors, habited for the most part in the robes and hoods of their degrees. Divine Service commenced at 10 o'clock, the Rev. E. Maturin, M. A. saying the Prayers, and the Rev. T. Leaver, M. A. and Rev. R. H. Bullock, B. A. reading the Lessons. A Sermon appropriate to the occasion was preached by the Rev. the Professor of Pastoral Theology. After Service the Members of the University returned to the College, when the Governors met together in deliberation for a few moments, and precisely at noon entered the Hall. usual commemoration in accordance with the Statute was pronounced by the President; after which the Rev. R. H. Bullock, B. A. performed the exercise required for his degree, and Mr. Randall read his Prize Essay on "Mahometanism compared with Christianity," &c. The Bishop gracefully presented the Prize, with an earnest address directed particularly to the Divinity Students and Scholars. The Convocation for conferring degrees was then opened in solemn form; and the Governors having signified their desire to confer the Honorary degree of D. C. L. on Andrew Mitchell Uniacke, Esq. B. A., for his unwearied and successful exertions in behalf of the College, it was received by Convocation with a loud and unanimous Placet. Mr. Uniacke was then presented by Harry King, Esq. D. C. L., and formally admitted "Honoris Causa." In an animated recognition of the honor, he convinced the assembly that he is still bent on promoting the interests of the College "nil actum reputans dum quid superesset agendum."
