MEETINGS.

The Regular Meetings of the Society are held quarterly, on the 25th March, or Lady Day; 24th June, or Midsummer Day; 29th September, or Michaelmas Day; and the 26th December.

Annual Election of Officers and Committees takes place on 5th January.

The Members meet also on 23rd April -St. George's Day.

The Meetings of the Committee of Management are held on the second Monday in every month.

The Meetings of the Sub-Committee-of Charity are held weekly.

RELIEF.

Application for Relief should be made on a Printed Form, stating the particulars of the case, &c., signed by any two members of the Society as a recommendation, and handed to the Sub-Committee of Charity.

Members may also bring up any case of distress within their knowledge at any of the above meetings.

The Printed Forms above mentioned may be had on application to any of the officers.

There are six beds, with the necessary bedding, all the property of the Society, in the Finlay Asylum for the use of persons who may be sent to that institution by the Society.

FIFTY-SIXTH ANNUAL REPORT

OF THE

Committee of Management of St. George's Society

FOR THE YEAR 1891.

The Committee of Management, in placing before the members of the Society the Fifty-sixth Annual Report, herewith submit a synopsis of its charitable work for the year 1891, the Treasurer's report containing full information as to the Society's financial affairs.

Donations of \$50 each have been given to the following four institutions, viz.: Finlay Asylum, Ladies' Protestant Home, Women's Christian Association and Jeffery Hale's Hospital.........

Six new members have been admitted during the past year, two life, four ordinary—and two ordinary members have become life members.

It is with deep regret that your Committee has to record the removal from amongst us by death of several old and valued members. Alexander Pope, for two years Secretary of the Society, and from the 5th January, 1890, its second Vice-President, and for twenty-two years a life member, died on the 10th March; a resolution, expressive of the high esteem in which he was held by the members, was unanimously adopted at a general meeting of the Society, on the 25th March last. ecord l and etary cond nber, f the was iety, aber since 1845, died at Hamilton, Ont., on the 14th July, at the advanced age of 81 years. Of ordinary members, we regret to record the death of P. A. Shaw, on the 21st February, and J. H. Anderson, on the 23rd March.

By removal from the city, the Society loses two members, both ordinary.

From the foregoing it will be seen that the numerical strength of the Society is the same as it was at this time last year; continued efforts to secure new members should therefore be made, so as to prevent any falling off in numbers. The exact number of members resident in the city and vicinity at date is 185—61 life and 74 ordinary.

Mr. Richard Turner was elected second Vice-President to replace the late Mr. Pope.

A proposal to secure, by amendment of By-laws, the retirement by regular rotation of members of the Committee of Management, was discussed at a largely attended general meeting held on 23rd April, when the proposal was negatived, a resolution however being adopted approving of the principle.

The usual Anniversary Church Service was held in the Cathedral on St. George's Day, in the evening; the Rev. Canon Richardson, M.A., preached the Sermon, which, in pursuance of resolution, will be printed and bound with the Report for this year. The Rev. L. W. Williams, M.A., Rev. T. A. Williams, Rev. H. J. Petry, M.A., and Rev. E. B. Husband assisted in the Service. The Dean of Quebec, who had kindly granted the use of the Cathedral, was unavoidably absent, owing to an engagement out of the city. The Lord Bishop of the Diocese was also prevented from attending, having important business in the country. The collection amounted to \$71.65.

In connection with this Service, the Society has again, as so often in the past, to record with gratitude the valuable aid generously given by the ladies and gentlemen of the Cathedral Choir and others, under the able direction of Mr. E. A. Bishop, organist and choir master of the Cathedral, to all of whom the Society tenders its best thanks.

The Annual Reports of the Society from 1852 to 1890 inclusive have been collected and bound; this volume, with the two previous volumes of reports, form an almost uninterrupted record of the Society's history since its foundation in 1835 to the present time.

Your Committee has been in treaty with the Directors of the Mount Hermon Cemetery Co. for the purchase of an additional burying lot in the cemetery; no decision has been arrived at, owing to a difference as to price.

Our Society continues to be affiliated with the North America St. George's Union; the connection is occasionally found to be useful and desirable.

SERMON

PREACHED BEFORE ST. GEORGE'S SOCIETY, AT THE ANNI-VERSARY SERVICE HELD IN THE CATHEDRAL OF THE HOLY TRINITY, QUEBEC, 23RD APRIL, 1891,

BY THE

REV. CANON RICHARDSON.

"Love the brotherhood,"-I Peter, ii-17. In preaching on St. George's Day, and before St. George's Society, the question that naturally rises in one's mind is: Who was St. George, and how came he to be adopted as the Patron Saint of England? And this is not an easy question to answer, for fact and fiction, history and legend, are so mixed up and interwoven one with another that it is hard to disentangle them and arrive at the truth. St. George is supposed to have been born in the year A.D. 280. His parents were rich and good Christians. His father was in the service of the Emperor Diocletian, and being the greater part of his time away from home the young lad's early education devolved upon his mother. At the age of 17 he entered the Roman army, and the loyal services of the father, who had lately died, were recompensed in his son. He is described as a young man of much intelligence, great beauty, and exquisite courtesy, and he soon became a favorite with the Emperor, who quickly raised him from rank to rank till he made him the military tribune of his guards. Soon after this the persecution against the Christians, which had been dormant for a while, broke out again with redoubled fury. An Imperial edict was issued, ordering that all the Christian churches throughout the Empire should be destroyed, that the Scriptures and all books of devotion should be burnt; that all Christian officials might be stripped of their dignities and deprived of their civil rights, and that all private persons professing Christianity should be reduced to slavery. This savage order excited the indignation of the young soldier and he boldly denounced the cruel edicts against his brethren. In vain did his friends recommend him to be prudent and recalled to his memory the many favours he had from time to time received from the Emperor. He knew full well that his own call to confess and suffer might

come at any moment, and so he distributed his money and goods to the poor, let free all his slaves, and left directions to provide for those who were in any way dependent upon him. And thus prepared for death he approached the Emperor and pleaded for the innocent Christians, demanding as the least that could be granted to them liberty to worship as they pleased since, said he, this liberty could hurt no one. The Emperor was furious at his demand and ordered his immediate arrest, and after many months of imprisonment and torture he was beheaded on the 23rd day of April A. D. 303, and twenty years afterwards a magnificent church was built in his honor and called after his name by the Emperor Constantine the Great. After this, he was selected as the Patron Saint of soldiers and military men, and thus stands for ever before the young manhood and Christendom as one of its great champions, a true soldier of Christ, whose order and decoration was that of the Cross and not the Crown. St. George, in the course of time, became the Patron Saint of England, supplanting King Edward the Confessor in that capacity. And since St. George was a foreign saint and St. Edward a truly national one, Saxon by birth, and Norman by breeding, it must have required a strong impulse to dislodge such a saint from the position which he held in the national regard, and set up another in his stead. And such an impulse was formed in the Crusades, which stirred to the very depths the pious enthusiasm of the martial spirit of England. When the Norman nobles under Robert, Duke of Normandy, son of William the Conqueror, joined the Crusades, they became acquainted with legends and myths connected with the name of St. George, a martyr, who is mentioned in all the martyrologies both of east and west. It is said that when the Crusaders were hard pressed by the Saracens, they saw, or imagined they saw, the Martyr St. George coming to their assistance, and a subsequent appearance to Richard I, in a dream during his campaign in Palestine, under the Norman and Plantagenet Princes, to put themselves under the patronage of St. George, but he was not finally appointed as the Patron Saint of England, till the time of Edward III., who in the year 1348 founded the Royal Chapel at Windsor, and dedicated it to the memory of St. George. But his crowning triumph was reserved for the time of King Henry V. On the field of Agincourt St. George was supposed to have appeared once more, and supported the

British army, and Henry issued instructions that fresh honours should be conferred upon St. George, and from that time forward the cry "St. George for England" has connected itself inseparably with the national sentiment. So much so, that when our Prayer Book was revised in what may be called a Protestant direction in 1552, so strong was the national feeling concerning St. George that it was impossible for any mere theological considerations to leave his name out of the calendar, and so St. George's Day was retained as one of the Minor or Black Letter Festivals of the Church. Now here we are met together to-night as English people, as sons and daughters of Albion's Isle, to celebrate our national Festival, and fulfil our part of England's national characteristic of helping and relieving those in distress, and cementing that bond of union that binds us all together, as one nation and one people, through that magnetic influence that unites us all to our Mother Country. In these days of travel wherever we go we carry the love of our country with us. However far off we may be, or however long we may have been absent, we always think and talk of England as home, and speak of going to England as going home. And this is not all, for besides the feeling of patriotism, there is the feeling of loyalty, which is preeminently English, and this feeling binds every Englishman to England's Throne and England's Queen. The history of that Throne is woven into the very texture of our memories, and gives substance to the national imagination and national sentiment by its glorious traditions, its ancient interests and its world-wide significance, while it is dignified and endeared to the hearts of us all by her whom we delight to call our Gracious Queen, who through all these long years lasting for more than half a century, years of turmoil and change, of tumult and disaster, has litted on high a name, unblemished by suspicion, untarnished by reproach. As a wife, as a mother, and as a Queen, she is the object of love and reverence from us all, whilst her condescension, her interest in all that concerns the welfare of her subjects, her kind and loving sympathy with those who are in distress, kindles and evokes a feeling of love and devotion from the heart of every Englishman. Occasionally we hear of a great disaster at sea, some hundreds of sailors meet with a watery grave, poor men it may be, of no account in the history of the world, whose names perhaps are never known beyond the village wherein they lived, but we hear

of a kind message of sympathy and coudolence sent to the bereaved relatives from England's Queen, and the feelings of all aroused and the prayer goes up from each one's heart "God save our gracious Queen." Or again, it may be that some mining disaster happened, and several hundreds of poor men are ushered into eternity at a moment's notice and a cry of distress goes up from that neighborhood, which is soothed and comforted by the kind enquiries and substantial help from our beloved Monarch, and again the feelings of loyalty and devotion are aroused, and the cry goes heavenward as from one heart and voice: "Long live our noble Queen." Thus it is that bound to our country and our Queen by the threefold cord of chivalry, loyalty and religion, we are as a necessary consequence bound to one another by an indissoluble bond, which no distance or time can affect, teaching us all that the love of our country outweighs even the love of self, and thus it is, why Englishmen throughout the world meet together on such a day as this, in order that they may commemorate the memory of their Patron Saint and keep the festival of St. George, and we cannot do this more effectually, than by assisting with our prayers, our sympathies and our alms, that noble Society which has for its object the relief of our countrymen and countrywomen who are in distress. My brethren of the Society of St. George, I could tell you of several instances where the assistance that has been afforded by your means has been a solace and a comfort to many and many a family, who, through the help that you have so generously given them, have been enabled to tide over their difficulties and start afresh in the world, and many as have been the occasions that I have applied to St. George's Society for help for others, I have never met with one refusal. Truly it may be said of this Society that "it has comforted the poor, and made the widow's heart to leap for joy." And I have no doubt that the great prosperity that has attended it from its conception to the present time has been partly in answer to the prayers of those who have been relieved by its means. And I know that I can appeal to you all to continue your good work in God's name, and when I look around me tonight I know I must be speaking to several young men who are English by birth or English by descent, who have not joined this Society of ours, and to them I would say will you not join us. Remember that as years roll on, our members must naturally decrease either by death or by re-



If you did not approve of our object in view you would not be here, and so, we ask you to contribute to our funds, as largely as you can afford to do in the sight of God, and He, who has said; "For as much as ye have done it unto one of the least of these my little ones, ye have done it unto me," He will receive the gift and bless the giver.
