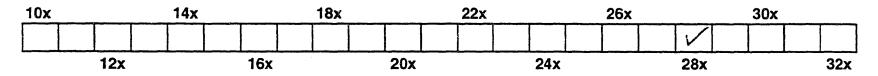

TER Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:

25 shall die before the said first of July, one thousand eight hundred and fifty-seven.

XXXII. That this Act shall extend and apply only to Upper Act limited to U. C. Canada.
