

SPEAKERS' PROGRAMME 1977/78

Each year, the Department of External Affairs, under its Academic Relations Programme, draws up a list of officers who are prepared to give talks or participate in seminars at the invitation of the universities. The Department would also welcome invitations for speakers from other groups, including community groups, clubs, associations and organizations interested in international affairs.

Following is the list for the current academic year. The list contains suggestions for topics and short biographical notes. Bilingual texts indicate topics which can be presented either in English or French. While the formal type of lecture is not excluded, we would like to express a preference for the informal type of gathering, such as the seminar or working group. Such gatherings are generally found to be more satisfying to the participants and to yield better results. Although our speakers are not expected to perform as spokesmen in the official sense, they will refer to government policies, comment on subjects of Canadian interest and analyse world affairs in a speculative way against their professional backgrounds. The speakers would be prepared to answer questions during ensuing discussions. Unless prior consent from the Department has been obtained, these talks are not to be reported or attributed in the media. In this way, it is hoped that a more frank and effective dialogue can be developed.


The ability of the Department to respond to invitations is subject to the availability of travel funds, pressure of work in Ottawa and prior commitments by speakers. Due to current budgetary constraints, it will not be possible to guarantee acceptance of invitations relating to a particular subject and individual. Wherever possible, however, every effort will be made to fill requests for speakers. In most cases, it would be desirable to make arrangements for the speaker to visit several centres or universities on a circuit, as this would represent a more economical use of resources and might help to meet requests on a fair basis.



Not all major themes of foreign policy appear on the following list. The list need not, however, be regarded as exclusive in regard to either topics or individuals, and special requests are always welcome.

In all cases, requests for speakers should be directed to the Academic Relations Division. Travelling expenses required to implement the programme are met normally by the Department.

We would also like to draw your attention to the services provided by the Public Relations Division, within the Bureau of Public Affairs, of which the Academic Relations Division is also a unit. The Public Relations Division has, as one of its prime functions, the fostering of a greater awareness of foreign policy matters among the Canadian public. In this regard, the Division is prepared to provide written and other information material on Canada's external relations to members of the public, on request.



PROGRAMME DE CONFERENCIEURS 1977/1978

Dans le cadre de son programme de relations avec les universités, le ministère des Affaires extérieures dresse, chaque année, une liste de ses fonctionnaires disposés à donner des causeries ou à participer à des séminaires sur invitation des universités. Le Ministère favoriserait également des invitations destinées à des conférenciers d'autres groupes tels les groupes communautaires, clubs, associations et autres organisations intéressées aux affaires internationales.

Cette brochure contient la liste de ces conférenciers pour l'année universitaire en cours ainsi que les thèmes de discussion et de brèves notices biographiques. Les textes bilingues indiquent des sujets qui peuvent être traités en anglais ou en français. Bien que nous n'excluions pas la conférence de type traditionnel, nous avouons préférer le séminaire ou le groupe de travail; de telles rencontres s'avèrent ordinairement plus profitables aux participants et donnent de meilleurs résultats. Quoique nous ne nous attendions pas à ce que nos conférenciers agissent à titre de porte-parole officiels, ils parleront inévitablement de la politique du Gouvernement, commenteront des sujets d'intérêt pour le Canada et analyseront les affaires mondiales, à la lumière de leur formation professionnelle. Les conférenciers répondront également aux questions qui leur seront adressées à la suite de leur exposé. A moins d'autorisation préalable du Ministère, les organes d'information ne devront pas faire état de ces rencontres ni y faire allusion. Nous espérons susciter de cette façon un dialogue plus franc et plus fécond.


Avant d'accepter de telles invitations, le Ministère doit tenir compte des fonds disponibles pour les voyages, de la somme de travail à Ottawa et des engagements antérieurs des conférenciers invités. Devant les contraintes budgétaires actuelles, il ne sera pas toujours possible d'assurer une réponse affirmative aux demandes touchant un sujet ou un conférencier en particulier. Nous nous efforcerons, toutefois, d'y satisfaire dans la mesure du possible. Dans la plupart des cas, il serait préférable qu'un conférencier visite plusieurs centres ou universités lors d'une même tournée, ce qui permettrait d'utiliser les ressources d'une façon plus économique et de répondre aux demandes d'une manière plus équitable.



La liste ne comporte que quelques thèmes de politique étrangère, aussi invitons-nous toutes suggestions quant aux sujets à traiter ou aux conférenciers à inviter. Les demandes de conférenciers doivent être adressées à la direction des Relations avec les universités. Les frais de déplacement engagés dans le cadre de ce programme sont normalement assumés par le Ministère.

Signalons également les services rendus par la direction des Relations publiques au sein du bureau des Affaires publiques, dont la direction des Relations avec les universités fait aussi partie. Le rôle principal de cette direction consiste à susciter dans le public canadien un plus grand intérêt pour les questions de politique étrangère. La direction des Relations publiques est en mesure de faire parvenir, sur demande, une foule de renseignements à ce sujet.








SLYFIELD, Philip


A graduate of the University of Toronto, Mr. Slyfield has held postings in Canberra and the OECD Paris. He is Director of the United States General Relations Division.
