




THE CANADIAN PEACE CENTENARY ASSOCIATION

The project of commemorating the hundredth anniversary of the signing of the Treaty of Ghent in 1814 having been discussed for some time, and steps having been taken in Great Britain and the United States to form organizations for that purpose, the following circular was issued from Ottawa under date of 30th April, 1912:—

My dear Sir,—

You may be aware that, last year, a National Committee was formed in New York, looking towards a joint celebration by Great Britain and the United States of a Century of Peace among English-speaking peoples, and that, recently, a similar movement has taken place in the United Kingdom, and an Association has been organized under the able and zealous chairmanship of our late Governor General, Lord Grey.

This Century of Peace will have been completed on the One Hundredth Anniversary of the Treaty of Ghent, which was concluded on Christmas Eve, 1814, and ratified on the 17th of February, 1815. It naturally possesses a special interest for Canadians, inasmuch as Canada is immediately adjacent to the United States, and is the portion of the British Empire that witnessed the actual conflicts of the War of 1812-14. The bitterness engendered by those feuds has happily long since passed away, and it seems fitting that we should participate in celebrating the blessings of peace which for a period of one hundred years will have existed between us and our neighbours. It is not quite apparent to what extent this movement has taken concrete form in the United States, but the favourable manner in which the proposal has been received there, as evidenced by the representative character of the National Committee, and the enthusiasm with which the idea has been taken up by our friends in Great Britain, indicates that the time has arrived when some tentative step may with propriety be taken by Canada.

Realizing that upon occasions of this character some one must be prepared to assume the initiative, we, at the request of many of those interested, have undertaken to send an invitation to a number of representative Canadians to meet at Ottawa on Tuesday, the 4th of June next, at 11 a.m., in the Railway Committee Room of the House of Commons, for the purpose of having an interchange of views upon this subject in its various aspects, and of forming, if deemed advisable, a Canadian National Association or Committee to co-operate with the Committees in Great Britain and the United States for the purpose of furthering this joint celebration.

We earnestly hope that you may find it convenient to attend this meeting and would ask you to kindly send a reply to George Burn, Esq., General Manager of the Bank of Ottawa, Ottawa; and if, unfortunately, you are unable to be present, we shall be glad if you will state your views regarding the proposed Peace Celebration and whether you are willing to give your assistance to an Association, if one is formed for that purpose.

Letters, telegrams and messages expressing regret at being unable to attend, and avowing sympathy with the object of the gathering were received from the Rt. Hon. R. L. Borden, P.C., Prime Minister of Canada, the Rt. Hon. Sir Wilfrid Laurier, P.C., G.C.M.G., Sir William Van Horne, Sir William Mackenzie, Sir Donald Mann, Sir Edward Clouston and many others. Mr. George Burn announced, in a letter apologizing for his absence owing to an imperative business engagement, that replies of a sympathetic nature had been received from nearly 300 persons to whom the circular had been sent.

The meeting was called to order at 11.15 a.m. by Mr. S. Barker, K.C., M.P., who moved that Sir Edmund Walker take the chair and that C. F. Hamilton act as Secretary. This was carried.

Sir Edmund Walker took the chair and addressed the meeting. He referred to the organization and work of the National Committee in the United States, and to the correspondence which had taken place between individual Canadians and the National Committee. It had become necessary, he said, for some one to take the first step, and the gentlemen who had signed the circular had ventured to issue a call for a meeting.

Nothing could be more natural, Sir Edmund Walker continued, than that the English-speaking peoples in the world should desire to celebrate, in 1915, or at Christmas in 1914, the signing of the Treaty which had ushered in such a wonderful record of peace. No people were more interested in this than those of Canada; none had been more influenced in their development by the continuance of peaceful relations; none had benefited more. If there was to be such a celebration, Canada should take part in it.

In the United States, the Chairman said, an influential Committee was undertaking organization work which included

proposals contemplating the expenditure of large sums of money. In Great Britain only the initial steps had been taken, a Committee having been formed having in view the suspending of relations with the American Committee. The status of Canada in this matter was co-ordinate with the status of Great Britain. Canadians should take part in such a ceremony only if Great Britain took part in it. Therefore, the meeting assembled in his judgment should confine its action to the appointment of a Committee which should act in conjunction with the Committee in Great Britain. It was doubtful if Canadians would care to participate in a celebration if Great Britain stood aloof. The American invitation was not to Canada alone, but to the constituent Nations of the British Empire.

Sir Edmund Walker concluded his address by moving, seconded by Hon. W. T. White, M.P., Minister of Finance, the resolution constituting the Association.

Hon. W. T. White seconded the resolution, welcoming those present, and expressing on behalf of the Government its interest in and sympathy with the object which they had in view. Dwelling upon the importance of peace and the increasing good feeling which made war between the great English-speaking powers increasingly improbable, he observed that he hoped that the celebration might take the form of a visible memorial which would proclaim for all time that two great Nations had lived in peace and harmony for a century.

Hon. George H. Perley spoke briefly, adding his welcome to that of the Minister of Finance, and stating that the Prime Minister, the Rt. Hon. R. L. Borden, P.C., unable through another engagement to attend in person, had asked Mr. White and himself to be present and to assure the meeting of his sympathy. Mr. Perley added an expression of regret at the indisposition which had prevented Rt. Hon. Sir Wilfrid Laurier from attending.

The resolution moved by Sir Edmund Walker was debated at some length, the discussion being led by the Hon. Mr. Justice Riddell.

A change in the phraseology suggested by the Hon. Mr. Justice Riddell having been accepted by Sir Edmund Walker, the resolution finally was passed, unanimously and with applause, in the following terms:—

"Resolved: that this meeting constitute itself into a Canadian National Association to join with the kindred Association in Great Britain for the purpose of co-operating with the National Committee in the United States, or any other body formed for a similar purpose, in commemorating the

centenary of the signing of the Treaty of Peace between Great Britain and the United States in 1814; that such Association be known as The Canadian Peace Centenary Association; and that membership be open to all persons in sympathy with the object thereof."

Chief Justice Sir William Mulock, K.C.M.G., moved the following resolution, seconded by Mr. Justice Riddell:—

"That the work of the Association be placed in the hands of a General Committee, with power to add to its number;

"That the President and Secretary of the Association be *ex officio* President and Secretary of the General Committee;

"That the General Committee (of whom ten shall form a quorum) shall, among other things, appoint such other officers of the Association as may be deemed advisable, elect a small Executive Committee, and in general further the object of the Association, in conjunction with the British Committee formed for a like purpose."

The resolution was carried.

Mr. S. Barker, K.C., M.P., moved that Sir Edmund Walker be President of the Association. This was carried.

Mr. S. Barker, K.C., M.P., moved that C. F. Hamilton be the Secretary of the Association. This was carried.

Hon. W. L. Mackenzie King moved, seconded by Senator Frost, that a Striking Committee be appointed to prepare a list of the General Committee, composed of the President, the Secretary, Sir William Mulock, Hon. Geo. H. Perley, M.P., Mr. S. Barker, M.P., Hon. Rodolphe Lemieux, M.P., and Hon. W. L. Mackenzie King. This was carried.
