SECT. VI.—The Sheriff shall, immediately upon the receipt of his copies, cause the same to be posted up in a conspicuous place in the Court House; the Clerk of the Peace, after receiving his copies, shall cause one of them to be posted in a conspicuous place in his Court House; the School Board, the School Head Master or Mistress shall in like manner cause one of his copies to be posted on the door of the school house; and every Justice of the Peace shall cause one of his copies to be posted in his post-office.
