Daily Meetings.

Printing of Reports.

Leave for Presbyteries to meet. It was agreed that the Synod should meet daily at 10 o'clock, continuing in session until 3; resume business at 6 P. M., and continue until 10 P. M.

On motion made and seconded, it was agreed that the Reports of the College Committee, the Committee on Foreign Missions, Home Missions, and the Widows' Fund, be printed and circulated twentyfour hours before the said Reports are laid before the Synod for discussion, and that a Committee be appointed to consider what may be done in the matter this year; the Committee to consist of Messrs. McRuar, Geikie, Dr. Irvine, and Mr. McTavish, Ministers; and Messrs. M. C. Lutz and James Ross, Elders.

The Synod granted leave to Presbyteries to meet in Toronto during the intervals of the sessions of Synod.

It was agreed, that to-morrow the Committee on Bills and Overtures should meet at 10 A. M., and that the Synod should meet at half past 11, the first hour to be spent in devotional exercises.

The diet was closed with prayer.

# SECOND SESSION.

WEDNESDAY, 15th June, 111/2 o'clock, A.M.

The Synod again met, and was constituted with prayer, praise, and the reading of the Word.

The minutes of last diet were read and sustained.

The Committee on Bills and Overtures presented a Report. The same was received and sustained.

On motion made and seconded, it was unanimously and cordially agreed, that the thanks of the Synod be tendered to Mr. T. Wardrope, Moderator for the past year, for the excellent and suitable sermon preached by him at the opening of the Synod. The thanks of the Synod were accordingly conveyed to Mr. Wardrope by the Moderator.

On similar application, leave was granted to Presbyteries to take on trials for license, Messrs. W. Millican, C. Cameron, James Robertson, Thomas Fenwick. George Craw, James Campbell, Peter McDiarmid, John McEwen, Robert Leask, A. Currie, and William Lochead.

Application having been made by the Presbytery of Montreal, for leave to take on trials for license, Mr. C. McKerracher, Student, who had attended three sessions in the New College, Edinburgh, besides six years in the University, but had not delivered two of the discourses required in the Divinity Hall; it was moved by Mr. McTavish, and seconded,—That the Synod refuse the application of the Presbytery of Montreal to take Mr. McKerracher on public probationary trials, till he has attended a session at Knox College, and has delivered the usual discourses. It was moved in amendment by Mr. Kemp, and seconded,—That in all the circumstances of the case, and without constituting a precedent, the Synod grant leave to the Presbytery of Montreal to take Mr. McKerracher on trials.

On a division, the amendment carried, and the Synod accordingly granted the leave applied for.

The diet was then closed with prayer.

#### THIRD SESSION.

#### WEDNESDAY, 15th June, 6 o'clock, P.M.

The Synod again met, and was constituted with praise and prayer. The minutes of last diet were read and sustained.

The Synod proceeded to take up appeal of the Kirk Session of Appeal of Session St. Andrew's Church, Sarnia, against a finding of the Presbytery of of Sarnia against London.

The papers in the case having been read, the following motions were duly submitted.

1. It was moved by Mr. A. F. Kemp, seconded by Mr. G. Cheyne, Mr Kemp's that the Synod proceed to hear parties in the case.

2. It was moved by Mr. W. J. McKenzie, seconded by Mr. D. Mr. McKenzie's Wardrope, -- "That a Committee of five members be appointed to motion meet at Sarnia to cite and hear parties, and finally adjudicate in the case."

3. It was moved by Mr. McLaren, seconded by Dr. Irvine,—"That Mr McLaren's the case be referred to a Select Committee, to mature a decision and motion. report to the Synod at an early day."

On a division Mr. McLaren's motion was carried, and in terms of Mr. McLaren's it the Synod appointed the following Committee, viz :--Mr. Topp, motion carried Convener, Dr. Bayne, Mr. W. B. Clark, Mr. Stark, and Dr. Boyd, Committee Ministers, and Messrs. McMurrich and Court, Elders, to mature a appointed decision and report to the Synod at an early day.

The Synod then took up a memorial from several members of celebration; Synod with reference to the proposed celebration of the ter-centenary of the Reformation in Scotland, in the course of the year 1860. Other documents on the same subject were also read. The Synod unanimously and cordially approved of the object brought forward in the documents before the Synod, and referred the matter to a small Committee to report thereon at a future diet ; the Committee to consist of Dr. Willis, Dr. Burns, Messrs. Cheyne, Scott, J. B. Duncan. J. Smith, and A. Young,-Dr. Willis, Convener.

> Thereafter the Synod proceeded to hear memorials from various Temperance Associations, and also a memorial from Mr. J. J. E. Linton, Stratford, on the subject of Temperance. After discussion, the following resolution, on motion of Mr. R. F. Burns, seconded by Mr. W. B. Clark, was unanimously adopted, viz :-

> "The Synod, without committing itself to any opinion respect-ing the organizations from which the memorials emanate, hereby renew the testimony which for a succession of years they have borne against the enormous evits of intemperance. Every year gives increasing force to their conviction that it is the chief cause of poverty and crime, disease and death, throughout our land; that it is the principal occasion of discipline throughout our church ; and that there exists no more formidable obstacle to the spread of the Gospel among us. The Synod rejoice in the passing by the Legislature of a Sabbath Liquor Law. The Synod bail with satisfaction every well designed and well directed effort to arrest the progress of intemperance, counsel the employment of moral suasion, and the exhibition of a consistent example, with this view, on the part of all office-bearers and members of our Church, and earnestly deplore the sanction given by the authorities of the land to a traffic fraught with effects so disastrous. The Synod further recommend to Presbyteries and Sessions to have special regard to the sources of intemperance within their respective bounds and to use every legitimate means for their removal; and feeling on many accounts it would be desirable to have a Standing Committee on this subject, they resolve to appoint the following Committee, viz: Mr. John Smith, Convener, Messrs. R. F. Burns, D. Inglis, John Alexander, Gregg, and Nisbet, Ministers, and Messrs. Elder, Court, Young, Hassock, and McLellan, Elders "

Probationer.

Mr. Kirkland to The Synod took up application from Presbytery of Toronto, for be received as a leave to receive as a Probationer of this Church, Mr. Thomas Kirkland. Certificates and other documents having been read, the Synod granted leave to the Presbytery of Toronto to receive Mr. Kirkland.

The Synod on application from the Presbytery of Montreal, granted leave to that Presbytery to receive Mr. Julius Straus as a Probationer of this Church.

> In consequence of the inability of Mr. J. M. Roger to attend the Synod of the United Presbyterian Church, as appointed by last Synod, the Synod appointed Mr. W. B. Clark to attend the Synod of the United Presbyterian Church now in session, with Mr. J. B. Dancan, formerly appointed.

> In consequence of the absence of Mr. D. Inglis, the Convener of Committee on Colportage, the Synod appointed Mr.A. J. McKenzie to act as Convener pro tempore.

In order to allow time for the meeting of various Committees, the Synod agreed to meet to-morrow at 11 o'clock, A.M.

The diet was closed with prayer.

### FOURTH SESSION.

#### THURSDAY, 16th June, 11 o'clock, A.M.

The Synod again met and was constituted with prayer, praise and reading of the Word.

The minutes of last diet were read and sustained.

Mr. T. McPherson asked leave to enter his dissent from the action Mr T. McPherson of Synod in the matter of the appeal of the Kirk Session of Sarnia, against finding of the Presbytery of London.

On motion of Mr. J. Gillespie, seconded by Dr. Burns, it was agreed :

"That Mr. McPherson be allowed to record his dissent." This he did accordingly.

The Synod proceeded to take up an application from the Presbytery of London, for leave to receive as a minster of this Church, Mr John Stewart, formerly of Nova Scotia. The Synod granted leave to the Presbytery to receive Mr. Stewart.

On motion made and seconded, it was also agreed :

"That, inasmuch as the Presbytery of London had moderated in a call to Mr. Stewart from the congregation of Kincardine and Bruce, previously to the dissolution of the pastoral tie between him and his late congregation, the Presbytery be authorized to proceed with his induction, without requiring him to continue as a Probationer for a year."

The Synod then took up dissent and complaint of Mr. F. Andrews, against a finding of the Presbytery of Cobourg, and also a reference from the Presbytery of Cobourg in connexion with the same case.

The Synod appointed the following Committee to consider the case, and report to the Synod, viz :- Dr. Burns, Messrs. G. Smellie, W. Gregg, J. Scott, W. B. Clark, T. McPherson, J. McKinnon, T. Lowry, and Dr. Boyd, Ministers, and Messrs. McMurrich, McAlister, Ross, Hossack, and A. Mitchell, Elders.

The Synod then took up an overture from the Presbytery of Hamilton, on the subject of the mode of the ordination of elders and deacons. The following motions were duly submitted :----

1. It was moved by Mr. Cheyne and seconded - "That this Synod recognize the imposition of hands in the ordination of elders and deacons as in accordance with the practice of the apostles, and recommend that the imposition of hands in future be observed in their ordination,-but in as far as the practice has fallen into dissuetude, that where there is a prejudice against it, the imposition of hands may be dispensed with, and the former practice followed."

2. It was moved by Dr. Burns and duly seconded-" That the Synod feeling satisfied with the mode hitherto followed in the ordination of

Reports were given in by the Committees appointed to examine Reports on Presthe Records of the Presbyteries of Cobourg, London, Kingston, bytery Records. Hamilton, Toronto and Montreal. These Reports were severally sustained and the Records ordered to be attested in usual form.

The Synod having heard the Report of the Committee appointed Record of Presbytery of Ottawa to examine the Record of the Presbytery of Ottawa, and having heard the explanations of the Presbytery of Ottawa, enjoined the Presbytery to cause the Record to be re-written so far as the transactions for the past twelve months are concerned, taking care that the narrative of transactions be in accordance with the facts in each particular case.

The Synod then proceeded to consider the various clauses of the ration of subject Basis of Union as agreed to by the Synod of the United Presbyterian of Union. Church, and laid before this Synod.

The first article was read and agreed to. It is in the following terms :--

I. OF HOLY SCRIPTURE .- That the Scriptures of the Old and New Testaments being the inspired Word of God, are the supreme and infallible rule of faith and life.

The second article was read. It is as follows :--

II. OF THE SUBORDINATE STANDARDS .- That the Westminster Confession of Faith, with the larger and shorter Catechisms, are received by this Church as her subordinate standards.

But whereas certain sections of the said Confession of Faith, which treat of the power or duty of the Civil Magistrate, have been objected to, as teaching principles adverse both to the right of private judgment in religious matters, and to the prerogatives which Christ has vested in his Church, it is to be understood :

1. That no interpretation, or reception of these sections is held by this Church, which would interfere with the fullest forbearance as to any difference of opinion which may prevail on the question of the endowment of the Church by the State.

2. That no interpretation, or reception of these sections is required by this Church which would accord to the state any authority to violate that liberty of conscience and right of private judgment which are asserted in Chap. XX., Sec. 2, of the Confession; and in accordance with the statements of which, this Church holds, that every person ought to be at full liberty to search the Scriptures for himself, and to follow out what he conscientiously believes to be the teaching of Scripture, without let or hindrance.

3. That no interpretation, or reception of these sections is required by this Church which would admit of any interference on the part of the State with the spiritual independence of the Church, as set forth in Chap. XXX. of the Confession.

On motion made and seconded, it was agreed to add the following words to the second section, after the words "without let or hindrance," " provided that no one is to be allowed, under the pretext of following the dictates of conscience, to interfere with the peace and good order of Society."

The third article was read and agreed to. It is in the following terms :---

III. OF THE HEADSHIP OF CHRIST OVER THE CHURCH .- That the Lord Jesus Christ is the only King and Head of His Church ; that He has made her free from all external or secular authority in the administration of her affairs, and that she is bound to assert and defend this liberty to the utmost, and ought not to enter into such engagements with any party as would be prejudicial thereto.

The hour of adjournment having come, the diet was closed with prayer.

# THIRTEENTH SESSION.

WEDNESDAY, 22nd June, 10 o'clock, A.M.

The Synod again met and was constituted with prayer, praise. and the reading of the Word.

The minutes of last diet were read and sustained.

The Committee appointed to consider the documents on the subcentenary of Re- ject of the celebration of the Ter-centenary of the Reformation presented a Report. The same having been given in and read by Dr. Willis, Convener, it was agreed to receive and sustain it. In terms of the Report the Synod adopted the following resolution, viz :-

"That having regard to the work of God, in the Reformation from Popery, of which the Protestant Countries generally have reaped precious fruits for three centuries past ; and especially sympathizing with the proposal to celebrate in some appropriate manner the meeting of the first Reforming Assembly held in Edinburgh. in the year 1560, the Synod agree at its next meeting, in 1860, to include a special reference to this matter of interesting remembrance in its devotional exercises or arrangements of business-in the meantime recommending its ministers, either simultaneously or on the days found most suitable in their seve-ral localities, to call the attention of their flocks to the blessings of the Reformation, and the responsibilities connected with the possession of them; also to appoint a Committee, meanwhile to confer with Committees of other religious bodies, in case it should seem for edification to unite on some method of manifesting simultaneously their grateful

sense of the great deliverance wrought for our common parent land at the Reformation era; and further, inasmuch as a meeting is proposed to be held in Edinburgh, in May next, in connection with this object, at which the attendance of delegates or representatives of churches at a distance is invited, the Synod authorize the above Committee to request some father or brother, or fathers and brethren who may be in Britain about that time, on their own account, to represent this Synod at the said convention or assembly, such representative or representatives being expected to act as far as possible in co-operation with the Committee."

The following Committee was appointed, viz :- Messrs. Topp, Gregg, Inglis, Dr. Irvine, Dr. Bayne, Dr. Willis; Messrs. Kemp, Wardrope, Scott, Young, W. B. Clark, and Dr. Boyd, Ministers; and Messrs. McMurrich, McAuley, and Court, Elders.

Dr. Willis, Convener of the Committee appointed to consider and Report of Comreport as to correspondence with the Presbyterian Church in the mittee with re-United States, (N. S.) reported that after conference with Mr. pondence with McLeod, the Deputy of the Church referred to, with the view of General Assembly of the Church referred to a state of the church referred to be a state of th ascertaining the views of the Church he represents, in the course of bly of U.S. [N.S.] which conference Mr. McLeod had replied to all their questions with the greatest candour, the Committee came to the conclusion, that while much of the common truth was held by that Church, its profession of doctrine was in some important points different from that of this Church, not so much on sovereign electing grace, or faith, or the work of the Spirit, as in the extent of the atonement, and the imputation of guilt and righteousness in the Adamic and Christian covenants; that in respect of many zealous efforts to extend the common cause of Christianity, and especially in having sought to discourage the practice of slave-holding in members of the Church, the Assembly represented by Mr. McLeod deserves the interest and sympathy of churches such as ours ; at the same time, as this Synod is not yet in the habit of appointing delegates to Churches in America generally, the Committee is not prepared, until the question shall have been considered comprehensively in all its relations, to recommend a formal recognition in that way of one particular branch of American Presbyterianism.

It was agreed to sustain the Report, and declare in terms thereof.

Mr. Topp, Convener of the Committee appointed to consider the Report of Commatter of the instruction of the Students in Knox College in He-brew, and to confer with the Professors, reported that the Committee brew in Knox having met several times and having had full deliberation on the College. subject, were unanimously of opinion that no changes should be made in the teaching of the classes in College till satisfactory arrangements shall have been made for meeting that change, and that as the Committee are not prepared in the meantime with any definite proposal, the Synod be recommended to postpone any further action in the matter in present circumstances.

On motion made and seconded, it was agreed to receive and sustain the Report.

The Synod then resumed consideration of the matter of Union. The fourth article was read. It is in the following terms :

driving Givin MAGISTRATE.—That ithe Lord Jesus Christ, as Mediator, is invested with universal sovereignty, and is therefore King of Nations, and that all men, in every capacity and relation, are bound to obey His will as revealed in His word; and particularly that the Civil Magistrate (including under that term all who are in any way concerned in the legislative or administrative action of the State,) is bound to regulate his official procedure as well as his personal conduct by the revealed will of Christ.

Several motions were submitted with reference to this article.

(1) It was moved by Mr. J. K. Smith, and seconded by Mr. J. B. Duncan :--

"That the Synod adopt the article as it stands."

(2) It was moved by Mr. Wilson, and seconded by Mr. Mac-Mullen :--

"That the following words be added after "King of Nations," viz., "and that all nations in their corporate capacity, as well as all men," &c."

(3) It was moved by Mr. Middlemiss, and seconded by Mr. Geikie :--

"That the following words be added at the end of the article, viz., "seeing to it that the constitution, legislation and administration of the State are based on Christianity."

On a division being called for, the amendment by Mr. Wilson and that by Mr. Middlemiss were put against each other, when the amendment of Mr. Middlemiss carried. Thereafter this amendment was put against the original motion, when the motion was carried, and the Synod in terms of it accepted the article as it stands.

With reference to the note appended to the fourth article by the Synod of the Presbyterian Church, the following motions were submitted :--

1. It was moved by Mr. Topp, and seconded :--

"That inasmuch as this Synod does not deem it necessary to append any note as explanatory of the views expressed in the 4th article, the Synod do resolve to call the attention of the Synod of the United Pres byterian Church to this matter, and to consider whether they shall not see it consistent with their duty to remove the same."

2. It was moved by Mr. Stark, and seconded :--

"That this Synod does not deem any note necessary to the interpretation of the 4th article, and therefore does not receive or regard it as any part of the Basis of Union."

3. It was moved by Mr. Kemp, and seconded :-

"That the Synod does not consider the note appended to article 4th, as a necessary part of the Basis of Union, and, inasmuch as its terms are liable to misconception, and cannot be accepted by this Synod, respectfully represent to the United Presbyterian Synod the propriety of withdrawing said note."

On a division being called for, Mr. Kemp's amendment and Mr. Stark's were put against each other, when Mr. Kemp's was carrried. Thereafter Mr. Topp's motion and Mr. Kemp's amendment were put to the house, when Mr. Kemp's amendment was carried, and was adopted as the finding of Synod.

The hour of adjournment having come, the diet was closed with prayer.

### FOURTEENTH SESSION.

#### WEDNESDAY, 22nd June, 6 o'clock, P.M.

The Synod again met and was constituted with praise and prayer. The minutes of last diet were read and sustained.

The Synod took up a reference from the Presbytery of Ottawa, Reference from involving the question whether the Presbytery had power to erase a resb tawa. minute of session after said minute had been attested by the Presbytery. On motion made and seconded, it was agreed to sustain reference, and declare that the Presbytery may, on cause shown, act as they may judge best in such a case, subject to the review of the superior court.

The Synod proceeded to the further consideration of the subject of Union.

The following motions were submitted. (1) It was moved by Mr. Wilson, and seconded :-

"That while this Synod rejoices in the progress made in finding a satisfactory Basis of Union, and in the prospect thus afforded of its speedy consummation : yet, as this Synod has no reliable information from the Synod of the United Presbyterian Church, as to the province of the Civil Magistrate in the practical application of the general principle of Christ's Headship over the nations, contained in the fourth article of the proposed Basis of Union, and as such information is deemed necessary in order to a harmonious and honorable Union, appoint a Committee to confer with said Synod as to its views on this practical question."

(2) It was moved in amendment by Mr. R. F. Burns, and seconded :-

"That inasmuch as by the almost unanimous decision of last year, the Synod stands committed to embodying in the Basis of Union simply the grand principle of national responsibility to Christ, they are not prepared at this advanced stage of the negotiation, to burden the Basis with an enumeration of the varied practical applications of that principle which have been already fully and satisfactorily discussed by the united Committees, and respecting which there is, on good grounds, understood to be substantial harmony between both Churches. The Synod, therefore, proceed to the consideration of the 5th article."

(3) It was moved in amendment by Mr. Middlemiss, seconded by Mr. McRuar :-

"That before proceeding to the consideration of the next article of the Basis, the Synod appoint a Committee to draw up an article embodying the views of this Synod, in reference to the province of the Civil Magistrate, with instructions to report at the next sederunt."

The amendment by Mr. Burns, and that by Mr. Middlemiss, having been put against each other, that by Mr. Burns carried. Thereafter, the motion of Mr. Wilson, and the amendment by Mr. Burns, were put to the house, when a majority supported Mr. Burns' amendment.

The Synod accordingly proceeded to the consideration of the remaining articles in the Basis of Union. Article 5th was read and agreed to. It is in the following terms :--

OF CHURCH GOVERNMENT.—That the system of polity established in the Westminster Form of Presbyterial Church Government, in so far as it declares a plurality of Elders for each congregation, the official equality of Presbyters without any offices in the Church superior to said Presbyters, and the unity of the Church, in a due subordination of a smaller part to a larger, and of the larger to the whole, is the Government of this Church, and is in the features of it therein set forth, believed by this Church to be founded on and agreeable to the Word of God."

Article 6th was read and agreed to. It is as follows :---

OF WORSHIP.—That the ordinances of Worship shall be administered in this Church as they have heretofore been, by the respective bodies of which it is composed, in a general accordance with the directions contained in the Westminster Directory of Worship."

Thereafter it was moved by Mr. McLaren, and duly seconded :---

"That the Basis of Union as a whole be now approved, and transmitted to Presbyteries and Sessions, and that Presbyteries and Sessions be instructed to Report to Synod through the Committee on Union on or before the first day of November."

It was moved in amendment by Dr. Bayne, and seconded by Dr. Willis :---

"That inasmuch as the Basis now under consideration contains no statement on the leading applications of the principle contained in article fourth, or on the Province of the Civil Magistrate, within which he is to serve and confess Christ—subjects on which unsound and un scriptural views are often held by those who admit the aforesaid principle itself—a Union on such a Basis would virtually involve a compromise of principles for which it has been the distinction and glory of this Church that it has hitherto contended."

The motion and amendment having been put to the house, the motion was carried by a large majority; whereupon Dr. Bayne dissented in his own name, and in name of such as might adhere to him. for reasons to be in due time given.

The Synod re-appointed the Committee on Union as follows, viz: Mr. Ure, Convener, Dr. Burns, Dr. Willis, Messrs. Laing. Lowry, Inglis, T. Wardrope, Scott, Gregg, Ross, Ministers, and Messrs. Heron, Jeffrey, and A. McKenzie, Elders.

It was agreed that the next ordinary meeting of Synod should take place at Hamilton, and within Knox Church on the second Wednesday of June, at half past 7, P.M.

The diet was then closed with prayer.

The Synod again met, and was constituted with prayer, praise, and the reading of the Word.

### MINUTES OF THE SYNOD AT TORONTO.

"The Synod took up a communication addressed to the Moderator

by Dr. Ryerson, Chief Superintendent of Education for Canada Communication West. The communication was read, and referred to a Committee from Dr. Ryerson consisting of Messrs. McTavish, Gregg, Topp, McRuar, and Kemp, taken up and re-Ministers and Messrs. Intra and Medanica, Ministers, Mr. Kemp, ferred to Com-Ministers, and Messrs. Lutz, and McAuley, Elders,-Mr. Kemp, mittee. Convener.

The Synod called for Report of Committee appointed to examine Report of Com-and classify returns of Presbyteries to overtures. The Report was mittee appointed to Examine and given in and read. It appeared from the Report-

Classify Returns of Presbyterles

1. That the overture on the calling and induction of ministers had to Overtures been approved ; six presbyteries having approved simpliciter ; one having approved cum notis; and one having rejected it.

2. That the overture on the licensing of students had been approved ; four presbyteries having approved simpliciter ; three having approved cum notis ; and one having rejected it.

3. That the overture anent baptism of converts from the Church of Rome had been rejected ; five Presbyteries having rejected it, one having approved of it cum notis, one having approved simpliciter ; and one having given no return.

The Synod received and sustained the Report.

Thereafter it was moved by Mr. Kemp, and seconded,-

" That the overture anent the calling and induction of ministers be Calling and In-duction of Minpassed into a law of the Church."

It was moved in amendment.-

"That the overture be referred to a Committee, with a view to revise it and send it down again to Presbyteries."

The amendment carried, and in terms of it the Synod referred the overture to the following Committee, viz : M. W. Gregg, Convener, Messrs. A. F. Kemp, W. McLaren, A. Wilson.

It was on motion made and seconded, agreed---

"That the overture anent the licensing of students be referred to a Licensing of Stu-Committee to revise it and report to the Synod, with a view of its vised and again being again sent down for the consideration of Presbyteries ; the Com- sent down. mittee to consist of Mr. Kemp, Convener, Mr. Wilson and Mr. McMurrich."

On a motion made and seconded, it was agreed-

"That no further action be taken with reference to the overture anent the baptism of converts from the Church of Rome."

The Synod, in accordance with the terms of the Act passed last ish Converts session of the Legislature for the incorporation of Knox College, at this its first session after the passing of the Act, resolved and declared,--

"That the principles and doctrines to be taught in Knox College by the Professors and Tutors, or other persons who shall from time to Doctrines to be time, and at all times hereafter, be employed or appointed in giving taught in Knox instruction in the said College, shall be such and such only as are con- College. sitent with and agreeable to the ' Confession of Faith,' the ' Larger and Shorter Catechisms,' and the 'Form of Church Government,' all which are called 'The Westminster Standards,' and shall comprise all theol-ogical learning consistent with the said Standards : Provided always, that the said 'Confession of Faith,' be understood and taken with the

explanatory note thereto, agreed upon by the Synod of the Presbyterian Church of Canada, met at Toronto in the year of our Lord, 1854: Provided also that the said 'Westminster Standards' be taken and understood with such other, or further directions and rules as to Church government, discipline or worship, as may from time to time be prescribed or ordained by the Synod of the said Presbyterian Church of Canada, with the concurrence of a majority of the Presbyteries of the said Church, to be ascertained in such manner as the Synod shall prescribe, and that such regulations and rules be duly recorded in the minute book of the said Synod, and signed by the Moderator and Clerk for the time being of such Synod.

The Synod further instruct their Clerk to register this resolution and delaration in the records of the Synod, and in the public Records of the City of Toronto."

Mr. A. F. Kemp, in behalf of the Committee appointed at last meeting of Synod, presented Report with reference to regulations for the government and administration of Knox College.

The Synod received and sustained said Report, and sanctioned ad interim the regulations contained therein, instructing Preshyteries to consider said regulations and report to the Synod next year.

The following are the regulations :--

REGULATIONS FOR THE GOVERNMENT AND ADMINISTRATION OF KNOX COLLEGE.

#### I. BOARD OF MANAGEMENT.

1. There shall be a Board of Management, composed of thirty-five persons, ordained Ministers and Elders of the Church, of whom seven shall be a quorum for the transaction of all business. The said Board shall be annually appointed by the Synod, and its members shall hold office until their successors be appointed. They shall appoint their own Secretary and Treasurer, who shall keep records and accounts which shall be open to the inspection of the Synod. The Chairman of the Board shall be appointed annually by the Synod, and in the event of no such appointment being made, or, of the death, removal, or resignation of said Chairman, his place shall be supplied by the Board itself.

2. The Board shall be convened, by the Chairman, at least three times a year, and at such time, and in such manner as may be determined by the Synod or by the Board itself.

3. The Board shall have the whole management of the financial affairs of the said College, shall receive and disburse all its moneys, keep and manage all its property, and transact all its business relating to property and money committed to its care, by the Synod or otherwise, and shall exercise all the powers, in regard to property and money, vested in the Corporation of Knox College, by the Act 22 Vic., cap. 69. In cases where special instruction shall be given by the Synod, (in writing under the hand of their Clerk,) it shall be the duty of the said Board to act according to such instructions.

4. The Board shall receive annual Reports from the Senate in reference to the departments under the care of said Senate, and shall transmit the same to the Synod along with a Report on all matters entrusted to said Board, and an audited balance sheet of the property and financial affairs of the College.

5. The Board shall further take general cognizance of all matters pertaining to the interest of the College, and co-operate with the Senate in maintaining its discipline. They shall also take charge of the Boarding

department of the College, and make such regulations for its management as they may see fit, and shall appoint all subordinate servants and dismiss and remove the same as they shall see fit.

6. The Board shall have power to appoint an acting sub-committee with such powers as they may deem requisite.

#### II. THE COLLEGE SENATE.

1. The Principal and Professors of the College, together with seven members of Synod, shall be annually appointed by the Syuod as a "COLLEGE SENATE," to whom shall be entrusted the reception, academical superintendence, and discipline of the Students, and of all other persons within the said College. The SENATE shall take a general inspection of the whole internal arrangements, of the College and of the studies of the Students, and shall place said Students in that year of the Curriculum to which they may be certified by Presbyteries, or by such other body as the Synod may determine.

2. The Senate shall have charge of the Library and Museum. and shall at the close of each College Session present to the Board of management a Report on the studies of the classes, and on any other matters which may have been intrusted to them.

#### III. PRINCIPAL OF COLLEGE.

1. The Title of the Principal shall be-" The Reverend the Principal of Knox College."

2. He shall preside in all meetings of the College Senate, and shall summon such meetings at stated or convenient times. In case of a division, the Principal shall only have a casting vote on there being an equality of votes on any question submitted to their decision.

3. He shall preside at the public opening and closing of the College Session.

4. He shall be the medium of communication with, and conduct the official correspondence of the College Senate.

5 He shall have a general superintendence of the studies of the Students in accordance with the instructions of the Senate; it being understood that the other Professors shall be responsible only to the Synod for the discharge of the duties entrusted to them.

# IV. APPOINTMENT OF PROFESSORS AND TUTORS.

1. That no person shall at any time be employed or inducted into office as a Professor of Theology who is not at the time of his employment or induction an ordained Minister of the Presbyterian Church of Canada; and if a Licentiate shall at any time be appointed, he shall before induction, be ordained to the Holy Ministry in the usual manner by the Presbytery of Toronto, or by a Commission specially appointed for that purpose by the Synod; and all persons, it any, who shall be appointed or employed as Tutors, shall at the time of their entrance into office be members of the said Church in full communion therewith, and that said Professors and Tutors shall sign the Formula appointed to be signed by Ministers, &c., of the Church.

2. That all Professors and Tutors who shall hereafter be appointed or employed in the said College, shall be appointed by the said Synod at its ordinary annual Session. or at any special meeting of the said Synod, to be called for the purpose of making such appointments or appointment by notice from the Moderator of Synod for the time being, to be sent to each member of Synod at least fifteen days before the day appointed for such special meeting, such appointments to be made

by open vote of the majority of members present at the Sederunt of the said Synod at which the appointment shall be made, or in such other manner as the said Synod shall from time to time, by resolution determine and direct to be pursued in making such appointments : Provided always, that any such Professor or Tutor may resign, or may by the said Synod be removed, suspended, or deposed from office, according to the laws of the Church, and in case of any such Tutor resigning or ceasing to be such as aforesaid, or in case any such Professor being removed, or being deposed from the Ministry in due process of discipline, such Tutor or Professor, so resigning, ceasing to be a member, or being removed, or deposed as aforesaid, shall *ipso facto* cease to be a Professor or Tutor in the said College, and cease to have any claim to any emolument or privilege belonging to the said College, and his office shall be vacant.

V. OF SESSIONS ; AND ADMISSION AND ATTENDANCE OF STUDENTS.

1. The Session or Academical year shall commence on the first Wednesday of October, and end on the first Wednesday of April. There shall be such recess at the end of December as may be fixed by the Senate.

2. No person shall be entitled to rank as a student who has not been certified to the Senate by some Presbytery of the Church, and who has not signed the Album of the College and agreed to submit to its discipline in such form as may be determined by the Senate.

3. Every Student shall at the end of each Session apply to the Professors on whose instructions he has attended, for certificates attesting the regularity of his attendance, his proficiency, diligence and general conduct, which certificates shall be presented to the Presbytery of the Church, by whom said Student may be examined for license or for entrance upon the next year of the Curriculum; and before any Student shall be taken on trials for license, he shall present to his Presbytery a certificate from the Senate signed by the Principal, attesting that he has attended all the classes and performed all the duties required by the Church.

4. Cases of an urgent or peculiar nature of attendance or absence from the classes of any particular year shall be adjudged upon by the Senate according to the circumstances of each case.

#### VI. THE CURRICULUM.

The Curriculum of study shall be such as may at any time be determined by the Synod, and for the present is :--

1. PRELIMINARY CLASS. For those who, on examination, are not found qualified to enter upon the curriculum properly so called. Arithmetic and Mathematics; English Grammar; Elements of Civil History; Elements of Latin and Greek.

II. NON-THEOLOGICAL COURSE.

1. First year-Classics ; Mathematics ; English Composition.

"That £300 of the Foreign Mission Fund be given in equal proportions to the Foreign Missions of the Free Church and the Irish Presbyterian Church, and that the balance be appropriated to the British Columbia Fund."

The amendment by Mr. Gregg, and that by Mr. Ross, having been put against each other, Mr. Gregg's carried. The original motion and Mr. Gregg's amendment were then put to the house, when the original motion carried by a majority.

It was moved by Mr. McRuar, and seconded,-

"That the Foreign Mission Committee consist of the following members, viz: Messrs. Lowry. Gregg, Topp, Clark, Kemp, T. Wardrope, Wilson, Dr. Irvine, Messrs. Inglis. Stark, Scott, McRuar, Dr. Burns, and Dr. Bayne, Ministers ; and Messrs. Court, Clark, Redpath, Elder. Kennedy, Cattanach, Turnbull, Ross, Cook, McKenzie, and Lutz, Elders,-Mr. Lowry, Convener ; and that this Committee be empowered to look out for, and send into the mission field, suitable missionaries, it being understood, that these missionaries be ministers in connection with this Church ; but that before sending such, the Committee shall submit the name of any one whom they may select for this work to the different Presbyteries of the Church, who shall meet within twenty one days of the date on which such notice shall come into the hands of the Moderator or Clerk, and report their decision to the Convener of the Committee, who shall be authorized to assume that Presbyteries who neglect to answer shall be held as concurring in the proposal made by them; the Committee to be guided by the decision of a majority of the Presbyteries. Further, that the Committee be empowered to provide outfit and passage, and fix the salaries of missionaries.

The Report of the Home Mission Committee was called for. The Report of Home Mission Comsame was given in by Mr. Reid, and read.

On motion made and seconded, it was agreed----

"That the Report be received, and that the funds at the disposal of the Home Mission Committee be distributed among the several Presbyteries according to the number of ordained ministers in each."

Wilson, Thomson, Dougan, McKenzie, Ross, Cordon, Leith, Turnhull, Starwart, Graham, Vigol McKenzie, Ross, Gordon, Leith, Turnbull, Stewart, Graham, Nicoll, Cattanach, Court, Redpath, Ross, and Dr. Holden, Elders,-Mr. Ure, Convener.

The Synod called for the Report of the Committee on Colportage. Report of Com-The same was given in by Mr. McKenzie, Convener, pro tem. The mittee on Colportage given in Report stated :---

"That there was nearly sufficient money in hand to pay all the creditors, with the exception of Nelson & Sons, whose account, without interest amounted to over \$3,700. The position of the scheme at present, was as follows : Accounts past due, \$4,101 74 ; assets, \$4,006 79 ; deficiency, \$94 05. Of these assets, the selling price of books still on hand amounted to \$975 98; cash, \$227 72; sundry accounts due,

\$1,185 29; balance due on sixty-three packages sent ont, \$1,617 80. Should these assets be realized, little would be required to liquidate the entire indebt-dness of the scheme; but it was very clear that this could not be hoped for, and that a considerable loss must be estimated upon the books still on hand, as also upon what must be regarded as debts. The actual deficiency the Committee estimated as not likely to be less than \$1,200. The Committee trusted that the Synod would devise means whereby this deficiency could be made up, and the Church released from the pressing claims of the creditors of the scheme. In order to do this, the Committee recommend that the books on hand should be sold, and that the Synod should instruct ministers to bring this matter before their respective congregations, and to take up a collection for this object on the first Sabbath in October. In this manner the Committee confidently hoped that the scheme could be closed within the current year."

Report received and Collection recommended in On motion made and seconded, it was agreed :----

"To receive and adopt the Report, and to recommend that a collecaid of this object. tion be taken up throughout the Church on or before the first of February next, for the purpose of meeting the liabilities of the scheme. and also that private subscriptions be taken up for the same object."

### SEVENTEENTH SESSION.

#### FRIDAY, 24th June, 10 o'clock, A.M.

The Synod again met and was constituted.

On motion of Dr. Willis, the following minute was unanimously adopted, viz :-

"The Synod having respect to the aspect of Providence, and the with reference to interests of the country, as concerned in the prospective returns of the approaching harvest, recommend to ministers and congregations, a becoming attention to this interest in public and private prayer."

Reid, Lowry, McTavish, Ure, Gregg, Topp, Inglis, and Laing,-Dr. Burns, Convener.

The Synod resumed consideration of the Buxton Mission.

On motion made and seconded,-

"It was referred to the Home Mission Committee to consider the whole matter of the Buxton Mission, and report to the next meeting of Synod."

The Committee was appointed as follows, viz : Mr. Scott, Convener ; Messrs. Ross, Forrest, Dr. Burns, Dr. Willis, and Dr. Irvine, with Messrs. W. Clark, and A. McKellar.

The Committee appointed to revise the overture with reference to overture with licensing of students, reported the overture in the following terms, reference to licensing of Stu-

dents sent down

"Whereas it is of importance to regulate by special enactment of to Presbyteries Synod the form of proceeding in the licensing of Students; it is hereby humbly overtured by the undersigned that the Reverend the Synod of the Presbyterian Church of Canada, shall remit the following regulations thereanent in terms of the Barrier Act, in order that the same may be passed into a Standing Law of this Church.

I. "That no Student shall apply for license until the last session of his theological course is concluded.

II. "When a Student applies to any Presbytery to be taken on trial for license, he must produce certificates from the Professors and Senate of the College, or from the Professors of any Theological College in connexion with churches in communion with this Church: (1,) That he has completed the theological curriculum. (2,) That he has delivered the five discourses prescribed to him in the course of his studies. (3,) That his character and conduct during his attendance at College were suitable to his views of life.

III. "That the Presbytery shall then examine said Student in Latin, Greek, Philosophy, Theology, and Practical Religion. If the examination be sustained, the Clerk shall be directed to make application to the next Synod for leave to take said Student on trial for License, certifying at the same time that the requisite certificates had been produced, and the examination had been sustained.

IV. "Leave having been obtained from the Synod, the Student shall then undergo his public probationary trials. These are examinations : 1. On Biblical Hebrew and Greek. 2. On Theology, Church History, and Government, and on Personal Religion. 3. He shall also read before the Presbytery : (1,) A Latin exercise. (2,) A Greek critical exercise. (3,) A Homily. (4,) A popular lecture. (5,) A popular sermon.

"The Presbytery may reject any or all of these trials, and may examine the Student on his various discourses if they see cause.

V. "That the trials being finished, the Presbytery shall take a conjunct view of the whole, and record their opinion. If not satisfied therewith, the licensing shall be deferred, and the Presbytery shall act in the matter as they shall see for edification ; if the trials be sus-tained, the Court shall proceed to license said Student to preach the Gospel. This shall be done in the following manner :-

VI. (1,) "He shall give his assent to the questions required by the Synod to be put in such cases, and shall either sign the formula or agree to sign it when required. (2,) The Moderator shall then give him a suitable address, and after prayer for the Divine blessing, shall in the name of the Lord Jesus Christ, and by the authority of the

Presbytery, l'cense him to preach the Gospel wherever he may be order y called. The clerk shall be in-tructed to g ant an Extract of License when asked, and on a probationer removing from one Presbytery to another, he shall produce a Presbyterial certificate in common form to the Presby tery with n whose bounds he shall be appointed to labour.

"This latter rule shall apply to ordained ministers without fixed charges "

On motion made and seconded,-

"It was agreed again to send down the overture to Presbyteries."

The Committee appointed to revise the overture anent the calling **Overture** anent calling and in-duction of a d inducting of Ministers, reported the overture in the following terms, viz :-

> "Whereas a diversity of practice exists in the Presbyteries of this Church in reference to the calling and ordination of Probationers, regarding which it is desirable that there should be uniformity, it is therefore overtured that the Synod shall send down the following regulations to Presbyteries in terms of the Barrier Act in order that they may be passed into a Standing Law of the Church.

> 1. "That when a Probationer or ordained missionary is called to a charge, and does not reside within the bounds of the Presbytery calling, the call shall be sent to the Presbytery within whose bounds he resides, to be presented to him with all convenient speed.

> 2. "That no Presbytery shall induct or ordain a missionary or Probationer coming from another Presbytery, without first having obtained a Presbyterial certificate of his standing from the Presbytery within whose bounds he has last resided."

Two motions were submitted.

1. It was moved and seconded.-

"That the overture be sent down to Presbyteries in terms of the Barrier Act."

2. It was moved and seconded,-

"That it be not transmitted."

On a division, the first motion carried, and it was accordingly down to Presby- agreed to send it down for the consideration of Presbyteries.

The Report on the Widows' Fund, was given in and read. From the Report it appeared,-

"That the receipts for the year has been-from Congregational Coltections, \$995 85; from Minister's Rate, \$760; from interest, \$1,434 08; and from amount of principal falling due, \$378 30. The amount paid for annuities was \$910; Minister's Rates repaid with interest, \$342 78; and amount invested, \$2,658 90. The total amount invested in Debentures and Mortgages is £5,824 14s., making with balance for investment, a total of £6,383 16s. 4d."

On motion made and seconded,-

"The Report was received and sustained, and the Committee were instructed to revise the rules and regulations, and report to next Synod any alterations they may consider necessary, giving the required notice in the Record."

The Synod appointed the Committee on statistics, viz :-- Messrs. J. Grav, J. Laing, W. Reid, W. Gregg, and T. Dallas,-Mr. Gray, Convener.

The Committee appointed to consider the communication from Deliverance on Dr. Ryerson, Chief Superintendent of Education in Canada West, Dr Ryerson's presented a Report. The Synod sustained the same and adopted the communication; following minute, viz :-

"The Synod having had under consideration a letter from the Rev. Dr. Ryerson, Superintendent of Public Education, Canada West, on the subject of Christian instruction in Common Schools, regard such communication as partaking of the nature of a private document, and therefore not calling for special consideration at their hands. The Synod would, however, refer to their previous action on the subject of Separate Schools, in June, 1856, in which they express strong views adverse to the continuance of such schools instituted for sectarian ends. In regard to other aspects of this question, the Synod appoint a Committee to watch over any legislation that may be proposed during the next session of the Legislature in regard to education, seeing that it be based on Scriptural principles :- the Committee to consist of Dr. Willis, Messrs. Gregg, Topp, Clark, Ure, McMurrich, McAuley, Lutz, and Hossack."

The Synod called for Report from Presbytery of Toronto with Report of Presreference to Missionary operations among the American Indians.

The Presbytery Reported that they were unable to collect any can Indians. further or more definite information on the state of the American Indians, but that they were about to institute enquiries, and hoped that ere long they would be in a position to obtain such information as might enable the Church to see her way to do something to advance the cause of the Gospel among an interesting and perishing race.

# THE COLLEGE COMMITTEE.-KNOX COLLEGE.

The Committee have great pleasure in recording the continued prosperity of our Theological College. They would ascribe the praise to God who, since the commencement of this Institution in 1845, has made it a most important means of advancing the interests of our Church in this Province.

The number of the Students matriculated in Knox College during the past year is 35. Besides these, there are other students who are studying with a view to the Ministry in our Church, partly in Knox College, and partly in University College. The whole number is about 50.

It may be stated that no less than seventeen students have completed their Theological course during the past year, and are thus in a position to ask license at the hands of the various Presbyteries. This is the largest number that has on any occasion completed the curriculum at the close of one session in Knox College.

The course of instruction in the different classes will be seen by the Reports of the Professors which have been handed to the Committee, and which will be submitted to the Synod. It will be seen from these Reports that besides the usual classes, a class of Sacred Rhetoric and Elocution was superintended by the Principal and the Professor of Church History. The Committee deem it desirable that this class be continued, and recommend the Synod to instruct the Professors' Court to make the necessary arrangements.

As during previous years, a Mathematical class was conducted in the Gollege by Mr. Thompson, and Hebrew and Latin were taught in University College by Messrs. Hirschfelder and Wickson. With respect to the Hebrew class, the Committee recommend the Synod to instruct the Professors' Court to confer with Mr. Hirschfelder with a view to bring his instructions into greater harmony with the requirements of the classes in Knox College.

The Committee find that the returns received from Presbyteries relative to the examination of students have not been all sent in, and agreed to direct the attention of the Synod to that subject, recording at the same time their opinion that a Committee be appointed to consider the subject of the examination of the students generally, and to report next year.

With respect to entrants upon the College course, the Committee learned from the Reports of the Professors, that several had come up from Presbyteries unfit to enter the Classes on account of deficiency in elementary training. They therefore recommend the Synod to instruct Presbyteries to give more particular attention to the literary attainments of students making application to them, and when necessary, to send them to Institutions where they may be trained under the care of the Presbyteries till they are prepared to enter the College Classes, and further to see that in such cases pecuniary assistance be provided by the Presbyteries if necessary.

A question which gave rise to much discussion in the Committee was, whether the Professors' Court have power to determine the position of students in the curriculum It was the opinion of a majority, (five to four,) that they have this power. The minority were of opinion that the power belongs exclusively to Presbyteries. It will be necessary for the Synod to come to a decision on this question, so as to prevent future misunderstandings.

It will be seen from Professor Young's Report that some doubt is entertained whether attendance on his exceptical class is imperative on students of the second as well as of the first year in Theology. In point of fact, the class is attended by students of both years. The Committee recommend the Synod to order the attendance of Students of both years as the standing rule.

Although the subject of the employment of Students during the summer months has occupied the attention of the Synod at previous meetings, the Committee deem it necessary to urge it upon their notice again. They feel that is impossible for students to prosecute their studies satisfactorily while burdened with the labour of preparing for preaching two or three sermons each Sabbath. The Committee, therefore, recommend that measures be taken by the Synod to remedy this evil; and particularly that they instruct Presbyteries to be more stringent in securing to Students a reasonable time for the exclusive prosecution of their studies.

The Committee now proceed to report on the Finances of the College. They have satisfaction in being able to state that there is an improvement in the fund for the current expenses of the College. It will be remembered that for three preceding years there was an annual and increasing deficiency of £40 in 1856, of £187 in 1857, and of £210 in 1858. The whole balance against the fund was £438. During the year now closed there has been no deficiency. On the contrary, the balance has been reduced to £392. It should be added, however, that the interest on the mortgage has been as formerly, charged to the account of the Building Fund.

The improvement in the Current Expenses Fund has been the result of increased contributions from the different congregegations, the whole amount received from which was \$5476 this year against \$4749 last year, making an increase of \$728.

Besides the contributions just referred to, the Committee have to report the receipt of a Legacy of £500 from the late James Gibb, Esq., of Quebec, whose memory will be long and gratefully cherished in this Synod. As an Elder of this Church, he took a deep interest in all its concerns; and his liberality in support of the various schemes is well known to the brethren.

The legacy has been received by the Agent of the Church. The terms of the bequest leave it in the power of the Synod to dispose of it at pleasure. It will therefore rest with the Synod to determine how it shall be appropriated. The Committee recommend that it be placed to the credit of the Current Expenses Fund, against which, as already reported, there is a balance of nearly £400.

No contributions were specially asked for, during the past year, on behalf of the College Building Fund. Contributions, however, have been received, amounting to  $\pm 115$  10s., which have enabled the Treasurer to pay a large proportion of the interest due on the mortgage. The whole amount due on the mortgage is  $\pm 2678$ , which is payable in 1862.

There is a balance in favour of the Bursary Fund of \$722. A particular statement of the receipts and disbursements of this and the other funds, will be submitted in separate documents.

The Boarding department of the College is still conducted under the superintendence of Mr. Thomas Willing, who continues to give satisfaction. A slight reduction has been made during the last session, on the price of board. The Committee are of opinion that it is exceedingly desirable that the students be not required to pay more than two dollars weekly. This would require the church to supplement the payment from their own funds. Such a provision the Committee recommend so soon as practicable.

It may here be added that the comfort of the students has been materially increased by the introduction of Gas-light into the large Dining Hall. This has been effected by the private liberality of the Principal and Professor of Church History. Other private efforts are just now being made towards still adding further to the comfort of the students in the separate rooms.

In concluding this Report, the Committee would not forget to state that they were glad to learn that special prayer on behalf of the College was generally offered in the various Congregations on the Sabbath appointed by the Synod. They have reason to believe that the prayers offered have not been ineffectual; and they recommend the Synod to renew a similar appointment for the ensuing year. The Divine blessing is that which is above all things necessary, and ought therefore to be specially and earnestly sought.

### **REPORT OF THE FOREIGN MISSION.**

Your Committee regret that they cannot report much progress in the matter of a Foreign Mission during the past year. At an early meeting after the last meeting of Synod, the suggestions contained in last year's Report were taken into consideration; and eventually the Committee resolved to take steps towards sending two Missionaries to Vancouver's Island and British Columbia, for the purpose of gathering

together the Presbyterians and such others as may be found willing to receive the Word, with the ulterior view of conjoining with this undertaking an effort to Christianize the Pagan Aborigines in those regions. It was also resolved, to invite to this Mission two Ministers of this Church, when the Committee thought qualified to commence such an important work. However, on corresponding with these brethren, the Committee found their services were not available, as one of them declined accepting the invitation, and the other declined entertaining the matter under present circumstances. In this position the Committee agreed to delay further procedure till the present meeting of Synod. They were induced more readily to come to this decision because they understood that doubts were entertained by some as to the power of this Committee to undertake the work of sending Ministers or Missionaries to New Columbia or Vancouver's Island. Your Committee therefore ask the Synod to make such a deliverance on the subject as will authorize the Committee to proceed in sending Missionaries to those regions.

Respecting the Financial affairs of this Mission,—according to the Report presented to the Synod at its last meeting, there was at that time a balance in hands of £596 3s. 1d. During the past year, a sum of £300 has been contributed chiefly by congregational collections. There is, therefore at present in your Treasury about £900.

From this brief statement of the details of business, the Synod will readily perceive, that there is little connected with our Foreign Mission of which we have reason to congratulate ourselves. Has not the way of the Church in this matter been much hedged in ? No satisfactory response has been made to the Church's call, "Who will go for'us ?" To a greater extent than the circumstances of the people connected with our Church would warrant, there has been a withholding of the gold and silver which the Lord claims as His own.

May we not very properly enquire, why are these things so? Have we, as a Church been resting on our own strength? Are we, through a false economy, robbing God of the offerings which a recollection or experience of mercies or judgments should have prompted us to bring into the house of God? Are we in any measure beginning to fall short of those solemn and noble-hearted purposes to which we pledged our. selves in former years? Has the unexpected failure of our first effort in the Indian field thrown us into despondency, rather than led us to heart-searchings respecting the motives by which we were influenced, and to hnmble but sincere purposes of greater devotedness? To such conclusions, your Committee would not desire to come. They would judge charitably respecting the Church. They are fully satisfied that the people of our Church were, in many instances, influenced in contributing less than in former years, or in not contributing at all, by the fact that a Foreign Mission Field had not been definitely selected, and that consequently there was no urgent demand for their pecuniary offerings. Again, the great pressure arising out of the distressed state of commerce and agriculture, will sufficiently account for smaller returns being made from several districts than formerly. And, besides, have we not reason to believe that the Great Head of the Church may be pleased to act towards Churches as He does towards individuals? We frequently find that when God is about to employ His servants in the execution of some important work, He requires them previously to pass through much trial and affliction as a discipline calculated to glorify himself? And, on the same principle, may He not require a Church to pass through her trials of faith, when at the very same time He may be calling her to "shake her-self from the dust and loose herself from the bands of her neck" that He may nake h r "an eternal excellency. a joy of many generations?" As long as we have authority to believe that great difficulties and obstacles, instead of affording reasons for inactivity, furnish sufficient warrant for putting forth even feeble efforts, provided those efforts correspond in some measure with the abilities of the parties concerned, and such a principle seems to be involved in such an expression as, ' curse ye Meroz, said the angel of the Lord, curse ye bitterly the inhabitants thereof; because they came not to the help of the Lord. to the help of the Lord against the mighty,"—so long ought the people of God to aim at 'te ching all nations." And chiefly. ought the Church in her several Courts and Congregations to plead earnestly in prayer to her God and King, that He would " have respect to Hi covenant,"-that He would make the pillar of His guidance so apparent to His Church, that she would discern

the places in which she should make her encampments; and that, inasmuch as fi the fields are already white unto the harvest," He would "send forth faithful, devoted, and successful labourers into His tarvest."

Y. ur Committee have also to inform the Synod, that during the past year they have been deprived of the services of the Rev. Donald Fraser, the original Convener of the Committee, by his removal to Invernes, Scotland. It is justly due to that brother, that this Committee should embody in their Report a statement of their grateful recollection of the very zealous and faithful manner in which he attended to all matters connected with the Foreign Mission, and also an expression of their hope, that in another portion of his Master's Vineyard, he may be made eminently useful in extending and edifying the Kingdom of Christ.

Finally, your Committee would earnestly solicit the special attention of the Synod to the present state of your Foreign Mission, to the claims that a Westerly portion of our own continent has on our prayers and ministrations, and to those agencies, which as a Church, we should employ, to aid in the introduction of the period when "The people which sat in darkness shall have seen a great light; and to them which sat in the region and shadow of death, light shall hav esprung up."

Of this sum the amount of \$910 00 has been paid in annuities to Widows and Children, and the unusually large sum of \$342 78, paid to ministers who have resigned their pastoral charges, and are no longer in the service of the Church. (The names of these ministers are Revs. Messrs. John McMurray, James Rogers, Samuel Young, William S. Ball, Donald Fraser, and Donald McLeod). There is a falling off in the amount of congregational collections, as might have been expected. There is also a falling off in the amount received from Ministers' Rates. But both these sources of income will again increase. Last year the interest on one investment was paid up in advance to the end of this year, thereby making the amount for interest last year larger, and for this year smaller than it would otherwise have been.

There is no increase in the number of annuitants.

# REPORT OF COMMITTEE ON A FUND FOR AGED AND INFIRM MINISTERS

The Committee beg to Report that they have held two meetings to deliberate on the subject entrusted to them, but have not thought it expedient in the present depressed state of the country to recommend the addition of another scheme to those already claiming the attention of the Church. Deeply impressed, however, with the great need of action being taken as speedily as practicable, they have agreed to submit to the Synod the following statements :--

That the provision may be made for aged and infirm Ministers in two ways, either by the establishment of a fund, such as the Widows' and Orphans' Fund, the interest of which would annually be expended; or to take up a collection annually, or biannually, as may be required, and that the money thus accruing, shall be paid to those who may be considered as entitled to aid.

The former plan would undoubtedly be the more satisfactory, on account of its permanency and superiority to the evil effects of caprice or accidental circumstances beyond the control of the Church; but on the other hand, the latter plan seems to be the more simple and more readily available.

The principles on which a scheme may be formed were to some extent considered, when it was proposed, that no Minister should be put upon the Fund who has not been a Minister in this Church for at least five years, and that a graduated scale of distribution, according to the length of service be adopted; and further, that Congregations whose Ministers are put upon the Fund will be expected or required to contribute towards their support, according as may be determined by a Committee to whom that duty shall be entrusted.

The regulations which may be necessary for establishing and administering such a fund, the Committee is not prepared to submit. They would, however, suggest the propriety of re-appointing the Committee with instructions to mature a scheme to be submitted to next Synod.

They would also suggest, that the Synod appoint one of the quarterly collections to be devoted to this object, leaving it for a future Synod to determine whether the money thus accruing shall be reserved as the nucleus of a permanent fund, or should it be required, shall be partially distributed.

All which is respectfully submitted.

#### REPORT OF COMMITTEE ON UNION.

The Committee on Union beg leave to report that, they met with the Committee of United Presbyterian Church at Toronto, on the eighteenth day of August last, and continued their deliberations during that and the following day.

There were present on behalf of the United Presbyterian Church, Dr. William Taylor, (Convener,) Dr. Jennings, Messrs. Thornton, Kennedy, Aitkins, Skinner, and Gibson, Ministers.

On behalf of the Presbyterian Church of Canada, there appeared Messrs. Ure, (Convener,) Scott, Fraser, Gregg, Ross, and Laing, Ministers; Messrs. Jeffrey, and Heron, Elders.

The Rev. W. Aitkins was called to the chair.

The Conveners laid on the table their instructions from their respective Synods.

The Committee proceeded to frame a "Basis of Union," and came to a unanimous agreement on the following articles : --

I. OF HOLY SCRIPTURE.—" That the Scriptures of the Old and New Testaments, being the inspired Word of God, are the Supreme and infallible rule of faith and life.

II. OF THE SUBORDINATE STANDARDS.—" That the Westminster Confession of Faith, with the Larger and Shorter Catechisms are received by the Church as her Subordinate Standards, and as exhibiting the sense in which the Holy Scripture is to be understood.

"But whereas, certain sections of the said Confession of Faith, which treat of the power or duty of the Civil Magistrate, have been objected to, as teaching principles adverse both to the rights of private judgment in religious matters, and to the prerogatives which Christ has vested in His Church, it is to be understood :

(1.) "That no interpretation of these Sections is held by this Church, which would interfere with the fullest forbearance as to any differences of opinion which may prevail, on the question of the endowment of the Church by the State.

(2.)<sup>4.</sup> That no interpretation of these Sections can be received by this Church which would accord to the State any authority to violate that liberty of conscience and right of private judgment, which are asserted in chap. XX. sec. 2., of the Confession, and in accordance with the statements of which, this Church holds that every person ought to be at full liberty to search the Scriptures for himself, and to follow out what he conscientiously believes to be the teaching of Scripture, without le<sup>+</sup> or hindrance.

III. OF THE HEADSHIP OF CHRIST OVER THE CHURCH. "That the Lord Jesus Christ is the only King and Head of His Church; that He has made her free from all external or secular authority in the administration of her affairs, and that she is bound to assert and defend this liberty to the utmost, and ought not to enter into any such engagements with any party as would be prejudicial thereto.

IV. OF THE HEADSHIP OF CHRIST OVER THE NATIONS, AND THE DUTY OF THE CIVIL. MAGISTRATE.—" That the Lord Jesus Christ, as Mediator, is invested with universal Sovereignty, and is therefore King of Nations; and that all men, in every capacity and relation are bound to obey His will as revealed in His word; and particularly, that the Civil Magistrate, (including under this term all who are in any way concerned in the Legislative or Administrative action of the State,) is bound to regulate his official procedure as well as his personal conduct, by the revealed will of Christ, to bow to the authority of Christ as King of Nations, and conduct his whole administration according to the dictates of the word of God, while he does not interfere with the religious liberty of individuals, and has respect to their conscientious convictions

V. OF CHURCH GOVERNMENT.—" That the system of polity exhibited in the 'Westminster Form of Government,' in so far as it lays down the principles of a plurality of Elders for each congregation; the official equality of Presbyters who minister in word and doctrine without any officers in the Church superior in said Presbyters; and the unity of the Church in a due subordination of a smaller part to a larger and of a larger to the whole, in the government of this Church, and is in the general features of it, herein set forth, believed by this Church to be founded on and agreeable to the word of God.

VI. OF WORSHIP.—" That the ordinances of worship shall be administered in this Church, as they have heretofore been by the respective bodies of which it is composed, in a general accordance with the directions contained in the Westminster Directory of Worship."

Such is the statement of principles and articles which the Committees drew up, and which they agreed to submit to their respective Synods as a basis of Union.

There are two notes in relation to Article IV., which were presented by the Committee of the United Presbyterian Church, and which at their request were inserted in the minutes of the procedure of the joint Committee. It is to be understood, however, that these notes form no part of the proposed basis. They were submitted not as additions to the foregoing articles, but with the two-fold view of endeavouring to remove misapprehensions as to the position which had heretofore been assumed by the United Presbyterian Church on the subject of Christ's Headship over the nations; and next, to protect the Committee of that Church from any charge of having exceeded their instructions. The following are the notes on the article referred to:

1. "That the first part of it (Article IV.) having relation to Christ's Headship over the Nations, has always been one of the things most surely believed and most firmly maintained by the United Presbyterian Church, while at the same time, she has constantly and carefully guarded against the practical inference drawn from it by some, that Christ as King of Nations delegates His power to earthly kings that they are in any sense his vicegerents, or that magisterial interference in matters purely of a religious nature is a medium through which Christ exercises the authority with which as King of Nations He is invested.

2. "That the second part of this article having reference to the duty of the Civil Magistrate, is to be understood as simply expressing what the Committee of the United Presbyterian Church believe to be the general sentiments held by that Church on the subject, for no declaration of sentiment regarding it has been required by her as a term of communion, and their instructions forbid their acknowledging it now in that character." All of which is respectfully submitted,

There were embodied in last year's Report the substance of answers, from corresponding members, to certain queries on points connected with the state of religion - such as the prominence given to religious exercises at the ordinary meeting of Presbyteries-the holding of special conferences, or meeting for prayer by Presbyteries in regard to the state of religion-the extent to which the holding of presbyterial visitations and Missionary meetings is practiced-the amount of attention given to the instruction of the young-the manner in which the duties of the eldership are generally performed, &c.; on which points, the information then presented, showed that all the ordinary meetings of Presbyteries were opened with a season of devotional exercises, and in the case of two Presbyteries, sermon was preached at their ordinary meetings-that special conference on the state of religion had been held by your Presbyterics, and a special prayer meeting relative to the subject by one Presbytery-that periodical visitation to the congregations within the bounds was made by one Presbytery, and annual Missionary meetings held by all the Presbyteries of the Clurch except one-that a considerable amount of attention was given to the instruction of the young--by Sabbath schools. Bible classes, and annual season of catechising, but, that the visiting of families by the Elders, and the practice of parental catechising were much neglected.

The Committee did not this year think it necessary to repeat the queries, but have simply endeavoured to ascertain how far the recommendation of the Synod of last year have been acted on --- and here they have to Report, that, two additional Presbyyear have been acted on-and here they have to Report, that, two additional Presby-teries, viz., those of Ottawa and London, have adopted the practice of making period-ical visitations to the congregations within their care. The correspondent from the Presbytery of Ottawa says, that, about the half of the congregation within the bounds have been so visited during the past year, and that the remainder, it is intended, will be visited during the current year. Respecting the nature of the visi-tation he remarks that the Presbytery not only uscertain the state of the congregatation, he remarks that, the Presbytery not only ascertain the state of the congregation in respect to temporalities, but makes diligent enquiry into the state of religion. In the Presbytery of London eighteen congregations have been visited during the year, and the corresponding member states in relation to this work, that the result on the whole has been satisfactory, and that in some instances decided good has accrued. The practice also of having sermons preached in connection with the ordinary meetings of Presbytery has been adopted by two additional Presbyteries, viz., those of Toronto and Montreal, making now four Presbyteries in all, in which

The important practice of catechising the young seems to be receiving increased attention. From one Presbytery it is stated that---"Ministers invariably attended to catechising, not only in Sabbath school and in Bible class, but also while visiting families." And from another Presbytery the writer says : "It is believed that at any rate, attention is being more than previously directed to the subject of general catechising."

In regard to the evidence of saving fruit arising from the means of grace, there dees not appear to be anything special. There have been indications during the past year that the Lord is accompanying His Word and ordinances with His blessing. Several congregations have received larger additions than usual to the number of communicants, and a great proportion of these additions in some instances, have been from among the young, attended with circumstances which evince the work of the Spirit of God in their hearts. But there is reason to fear that the spiritual life of the Church in general is low, and such as call for humility, and earnest prayer to God for a time of refreshing from His presence. And this matter ought the more to attract attention, from the circumstance, that both in the neighbouring Republic, and in Britain, the Lord has been, and is, giving special efficacy to the word of His grace. A serious concern for the future welfare of our Canadian Church ought to be awakened, should we be altogether past by at such a time.

The Committee would also take the liberty of recalling to the mind of the Synod,

The many instances of recklessness and dishonesty in business transactions---the serious accidents that are ever occurring from the prevalence of drunkenness---the boldness with which profanity is practised----and the many cases of murder that have lately taken place---seem to prove a want of vitality in the Christian Church, and a failure on her part to approve herself as the light of the world and the salt of the earth.

And as the government and training observed in the family, have a special influence in forming the character of society, as well as in maintaining true religion in the Church, your Committee would conclude by recommending, that a pastoral letter, bearing specially on the subject of family religion, be prepared by the Synod, and besides being published in the *Record*, be read from the pulpits of the Church.

#### **REPORT OF HOME MISSION COMMITTEE, 1858-9.**

In presenting their Annual Report the Home Mission Committee would express their gratitude to God that, notwithsanding the difficulties which have pressed during the past year, with peculiar weight, on young and unconsolidated Mission Stations, the work has nevertheless been extending. Fewer demands for Missionaries have been made than in some former years; but the Committee believe that the gradual development of the Home Mission work has not been seriously retarded, and they are of opinion that the past and present difficulties have had, and will have the effect of leading the Presbyteries and the Stations themselves to the employment of more systematic means in carrying on their operations.

The following is a statement of the laborers employed in Home Mission operations throughout the bounds of the different Presbyteries. At the meeting of the Committee in the beginning of October, the following distribution was made, viz: To the Presbytery of London, 4; Hamilton, 4; Toronto, 4; Cobourg, 1; Kingston, 2; Brockville, 1; Ottawa, 2; Montreal, 4.

And at the meeting in the beginning of April, the following distribution was made, viz: To London, 7; Hamilton, 5; Toronto, 10; Cobourg, 1; Kingston, 2; Brock-ville, 2; Ottawa, 3; Montreal, 7. Of these, 14 were probationers and 23 students.

During the year, the following settlements have taken place. viz :

Presbytery of London-

Hamilton-Four, viz: Rev. J. Murray, at Grimsby; Rev. A. Grant, at Owen's Sound; Rev. J. Cameron, at Derby and Sullivan; and Rev. W. Park, at Durham.

Toronto—One, viz: Rev. James Stewart, at Oro—not including the settlement of Rev. A. Topp, of Knox's Church, Toronto.

Cobourg-0.

Kingston-One, viz : the Rev. Robert C. Swinton, at Picton.

Brockville-0.

Ottawa—Four, viz: Rev. J. Whyte, at Osgoode : Rev. W. McKenzie, at Ramsay ; Rev. J. McKinnon, at Beckwith, and Goulburn ; and Rev. S. C. Fraser, at White Lake.

Montreal--Three, viz: Rev. John Milloy, at Lingwick; Rev. Adam F. McQueen, at Kenyon; and Rev. John McKay, at Richmond.

We proceed next to give a general statement of the vacancies and Mission stations in the several Presbyteries :---

LONDON.—Within the bounds of this Presbytery there are at present four vacant congregations. These are Amherstburg, Knox Church Woodstock, Port Stanley, and Saugeen. The first named has been vacant since the translation of Mr. McLaren to Boston, the second since Mr. Ball's resignation and acceptance of the Agency of the

June.

Upper Canada Bible Society, the third and fourth have been lately rendered vacant by the respective resignations of Messrs. Doak, and McNaughton.

In this Presbytery there are in all 20 Mission stations, of which eight come under the designation of organized stations--understanding by an organized station not only one where a congregation has been formed by the reception of members and the administration of the Lord's Supper, but where Elders have also been ordained for the oversight of the members. These Stations are---5. Ashfield and Huron.

1. Chalmer's Church, Dunwich.

- 2. Yarmouth and Belmont.
- 3. Blythe and Manchester.
- 4. Wawanosh and Kinloss.

Of the 12 that are regarded as unorganized, six of them have been formed into congregations to the length of members being received, managers being appointed, and the Sacrament of the Lord's Supper being regularly dispensed once a year. These are-

- At the remaining six stations the ordinance of the Lord's Supper has not yet been dispensed, although at the most of them managers have been appointed, and a place of worship, either erected or in process of being erected. These Stations are-

Of these 20 stations nine require service in the Gaelic language,---some of the other eleven have Gaelic-speaking people connected with them; but preaching in the Gaelic is not essential.

Seven stations are self-sustaining. The rest are assisted from the Home Mission Fund, and some of them are almost entirely sustained from it.

HAMILTON .--- Four vacant Congregations, viz., Guelph,--- Wellesley,--- Niagara,---Owen Sound. Beside these there are six organized stations, viz., Durham,---Mount Forrest,--Arthur,--Minto,---Walsingham, and Garafraxa. There are also seven Mission stations requiring supply, but not yet organized, viz., East Durham, --Rocky Sangeen, --Swanstown, --Gaelic Congregation at Mount Forrest, --North Arthur, ---Maryboro', --Crosshill, Wellesley. Of these stations two, viz., Minto and Walsing-ham, have been opened during the past year. The stations generally are described as being one half self-sustaining. The money crisis has affected both the funds of the stations and the contributions of the settled Congregations. Four Missionaries are labouring at present within the bounds of this Presbytery are labouring at present within the bounds of this Presbytery.

TORONTO .--- Within the bounds of this Presbytery there are the following vacant Congregations: 1. West Gwillimbury and Bradford. 2. Erin and Caledon West. 3. Markbam, Melville, and Brown's Corners. 4. York Mills and Fisherville. Organized Stations: 1. York Town Line. 2. Cedar Grove, &c. 3. Flos and Medonte. 4. Collingwood Harbour. 5. Caledon East and Mono Mills. 6. Mono East, West and Centre. 7. St. Vincent, &c. 8. Osprey. 9. Nottawasaga, &c.

Besides the four vacant Congregations, four of the organized Mission stations may be considered as prepared to call Ministers.

The above S. venteen Congregations and Stations comprise Forty preaching places. Besides those reported, there are seven or eight places where services are held under

the direction of settled Ministers. The Sabbath attendance at all the Stations is as nearly as can be ascertained 3,250. The number of members in full communion do. 745.

Nine Sabbath Schools are reported,---33 Teachers and 312 pupils. Human raggu Six stations report meetings on Sabbath when there is no preaching. Nine stations report weekly prayer meetings held.

At thirteen stations Churches have been built. There are several townships yet unexplored in which it is known that many

Presbyterians have settled, and are unprovided with ordinances.

The debt owing by the Home Mission has been reduced from about \$800 to less than \$300.

COBOURG .- The Mission field of this Presbytery is very limited. The only stations are Bethesda Church and Alnwick, which are now prepared to call and sustain a Minister. There are two Missionaries at present employed.

KINGSTON .-- In this Presbytery there is at present one vacant Congregation, viz., Trenton and Consecon, and one group of Mission Stations in the neighbourhood of Kingston, where it is hoped a Pastor may soon be settled. Two Missionaries are employed at present by this Presbytery.

BROCKVILLE .--- In this Presbytery there are at present two Mission fields, viz. : 1. Lyn and Yonge. 2. Mirrickville. Both of these places are likely soon to have settled Pastors. There are two Missionaries at present employed.

OTTAWA .--- In this Presbytery there are two vacant Congregations, viz.: Cumberland and Renfrew. There are two or three stations requiring supply, but they are not yet organized. It is hoped, now that a number of settlements have taken place in vacant Congregations, that the Presbytery may be able to give more especial attention to the outlying field. There are two Missionaries at present employed.

MONTREAL .--- In this Presbytery there are five vacant Congregations : Martintown and Williamstown; Winchester and Bates' Corner; Laguerre; Osnabruck; and Williamsburgh; besides Cote-street Church, Montreal. There are three Mission stations organized, viz., Valleyfield, Farnham Centre, and Alexandria. There is also another station not yet organized, but requiring and now enjoying Missionary labour, viz., Kennebec. There are at present seven Missionaries employed in this field.

The supply of Missionaries has mainly, indeed we may almost say exclusively, been from our own seminary. During the year we have received one only from Scotland, and none from Ireland.

But although we have not received any Missionaries from Ireland, we have to state to the Synod that the Church there has lately placed at our disposal the sum of one hundred pounds per annum, for three years, for the special benefit of Stations which have never enjoyed a stated Ministry. The first year's allowance has been received. This grant was made on the special recommendation of the Rev. W. McClure, and the This grant was made on the special recommendation of the new. W. Mcolure, and the Rev. Prof. Gibson, the respected Deputies who visited our Church during the past summer. The Committee cannot advert to this deputation without expressing strongly their high sense of gratitude to the Church in Ireland for their kindness in sending a Deputation to visit us, and also the great pleasure which they had in all their intercourse with the highly esteemed brethren who were selected for this espe-cial service. Their only regret is that the time of the Deputies did not admit of their making a longer stay, and visiting more of the Congregations throughout the bounds. making a longer stay, and visiting more of the Congregations throughout the bounds. It will be for the Synod to determine the special manner in which this grant referred to is to be employed. The Committee would also suggest to the Synod the desirablehess of making some application of the balance in hand for Home Mission work of the amount given by Alex. Gillespie, Esquire, and the sum bequeathed by the late Mrs. Fergusson, of Woodhill, as reported to the Synod at a former meeting.

A Special Report will be presented by Mr. King, with reference to the Buxton Mission. Conjoined as this Mission is with the Synod Fund, in the matter of an annual collection, it is found that there is some difficulty in obtaining the necessary funds. For this object the Church in Ireland have specially appropriated fifty pounds, which sum will be available for meeting part of the charges of the present year.

RED REVER-11 will be borne in mind that at the late meeting of the Synod, Mr. McTavish was appointed to proceed to Red River to visit and encourage Mr. Black and bis flock, who have been for many years earnestly pleading for a visit from a Minister of experience and weight. Circumstances prevented Mr. McTavish from proceeding to Red River last year, in accordance with his appointment. But at the recent meeting of the Home Mission Committee, in April, it was again agreed to request Mr. McTavish to proceed to Red River, to strengthen the hands of Mr. Black, and to make inquiries as to the practicability of a Mission to the aborigines. The Committee again ask the sanction of Synod to this appointment, believing that in the present circumstances of the North West, and in view of the increasing intercourse between Canada and the Red River settlement, such a Mission would be productive of great good. As Mr. Black is most desirous, both on account of the health of Mrs. Black and other considerations, to visit Canada and the United States, where his friends reside, it would be most desirable that a young man could accompany Mr. McTavish and remain until the opening of navigation next Spring.

Your Committee would, in conclusion, again place before the minds of the Synod the great truth, that the special work which the Church in this land appears called upon to prosecute is the work of Home Missions. May the Great Head of the Church, by the special out-pouring of His Spirit greatly increase our zeal. May He raise up many faithful and devoted labourers, and grant that through the means and agencies employed by us many may be added to the Church of such as shall be saved.

# REPORT OF BUXTON MISSION.

In presenting the ninth Annual Report of the Buxton Mission, the Committee feel deeply grateful to the great head of the Church for the measure of success vouchsafed to it during the past year. Although there have been some difficulties of a peculiar nature to contend with, still the progress has been onward. The failure of the crops for two years in succession has pressed hard on the settlers. The first year was not so much felt, but last year the struggle for food has been such that very little of their scanty earnings could go for clothing. The Committee, on visiting the different parts of the settlement, met with a number of families, where neither parents nor children were able to attend either the Church or school, for want of proper clothing. Still the people were neither disheartened nor discouraged, but were looking forward to the future with the hope that the coming harvest, which there had the prospect of being good, would release them from their difficulties.

The number of families in the settlement and living near it, amount to between two and three hundred. Of these, thirty-two belong to the Presbyterian Church; of the rest about sixty families belong to the Methodists and Baptists, who have established separate churches: the remainder belong to no communion, but occasionally go to the Mission Church. The attendance on Sabbath varies from 120 to 200, according to the weather and state of the roads,—some having to come from six to seven miles on bad roads. The number of communicants is sixty. These have nearly all been gathered in since the Mission was established. Three years ago the first convert from among the youths trained in the Mission school was received into the Church; at every communican season since a few more have been added. The number of such at present is twelve. Since the last Report the Lord's Supper has been dispensed twice, and on each occasion six members were added to the Church, four of these were received on certificate and eight by examination. The Church is regularly organized, with a full staff of office-bearers, four Elders and four Deacons. The settlement has been divided into Districts, and an Elder and a Deacon appointed to each District. They have visited regularly all the families in their respective

Districts during the past year, and have been well received. The Sabbath school in connection with these churches is in successful operation. Mr. Thompson, the teacher in the day school being Superintendent. The number of pupils on the Roll, is 80, and the average attendance 60. A number of children who might be at the Sabbath school were unable to attend, especially during the winter, for want of proper clothing; some of them live at such a distance from the school that they scarcely ever attend, unless in good weather. To accommodate those who live at a distance, another Sabbath school was opened two years ago, in the north part of the settlement; it is attended by 25 pupils, and is open six months in the year.

To encourage a Missionary spirit, the children in the Sabbath school have formed a Missionary Society, take up a collection in the school every Sabbath, and send their annual contributions, which amounted, last year, to ten dollars, to the Calabar Mission on the coast of Africa.

The Committee spent a portion of the time in examining the day school, and were highly pleased with the mode of teaching and the proficiency of the scholars. The number enrolled is 90, the average attendance 60. The branches taught are Reading, Writing, Arithmetic, English Grammar, and Geography, besides Classics and Mathematics. All the pupils read every morning and evening, a portion of the Scriptures, on which the teacher examines them as a religious exercise. The Shorter Catechism is taught in connection with the Bible, and most of the pupils who have been a length of time at the school can repeat the Catechism; all have received religious instruction. The Committee on examining the pupils on the Scriptures, found that they had acquired considerable Scriptural knowledge, and gave answers readily and correctly to the questions put. The Committee also examined the pupils in English Grammar, Geography, and Latin, in all these branches they appeared to have been thoroughly taught. Some of the pupils studying Classics and Mathematics intend to enter College as soon as they can be prepared, but unless a Bursary Fund can be obtained to support them while there, they will not be able to enter, as nearly all of them are without means. One friend in Scotland, contributed last year, ten pounds, towards the formation of fund for the purpose of supporting students at the College, who intend to prosecute their studies with a view to the Ministry ; another, in Canada, has given five pounds for the same purpose. It is to be hoped that by another year a fund will be obtained by the liberality of friends, sufficiently large to support, at least, one student at College.

It should be mentioned that a grant of fifty pounds, sterling, has been made by the Mission Board of the Presbyterian Church in Ireland, for the general purposes of the Mission.

All the people in the settlement have to struggle hard for their support, and the payment of their lands, and can afford to pay but little for the support of the Gospel, and the education of their children; still they endeavour to do something; when their lands are all paid for, which will be in the course of three or four years, they will, in a great measure be self-supporting, till then the Mission must depend almost entirely on the Synod for support. But as many warm friends of the Mission in Ireland, Scotland, and the United States, have expressed their willingness to aid the Mission, and already have given substantial tokens of the interest which they take in it, the Committee would recommend the Synod to send an Agent to Great Britain and Ireland during the present summer, to raise funds to aid in carrying on the Mission. A collection is taken up every Sabbath in the congregation, they also contribute to all the schemes of the Church; although the contributions are small, still the habit of giving systematically is being formed, and it is hoped that as the means increases their liberality will increase. The total contributions during the last year were eighty-four dollars.

The scholars attending the day school can pay but little towards the support of the Teacher, they can scarcely procure proper clothing and books. The Committee appointed by the Synod two years ago, to visit Buxton, recommended that the Teacher should be allowed \$300 annually from the Synod, and to depend on the fees and Government grant for the balance of his salary, but no specific understanding

had been come to with the Teacher, and as the fees and Government grant-only amounted to eighty-seven dollars during the last year, one hundred and thirteen less than the salary promised in his first engagement, Mr. Thomson proposes to take for last year, and this respectively, from the Synod, \$400, and after the present year to take \$300 annually, as he expects in another year the fees will increase, so that the grant from the Synod can be reduced, this proposal the Committee would recommend the Synod to accept.

The buildings are all of a very temporary kind, and in winter are very far from being comfortable. The Manse is a log cabin, erected by Mr. King at his own expense; the church and school house are quite open in the sides and roof, the heavy rains in summer, and the drifting snow in winter easily pass through them; they are not built on land belonging to the Synod. A park will be given to the Synod at any time in the source at Buxton, for the erection of the necessary buildings.

time in the square at Buxton, for the erection of the necessary buildings. It is absolutely necessary that permanent and substantial buildings be erected as soon as possible for the use of the Mission. Dr. Burns, and the Rev. William King, were appointed last year by the Synod as a Committee to consider the best means of obtaining funds for the erection of new buildings in connection with the Mission at Buxton. They have corresponded with parties in Great Britain and the United States, and have received from several quarters in Great Britain assurances that if an Agent can be sent over during the present summer, assistance can be obtained for the erection of buildings and carrying on the Mission efficiently.

William King to Ireland, Scotland, and England, for the purpose of raising funds to be applied in the erection of permanent buildings and other purposes connected with the efficient carrying on of the Mission.

# REPORT OF COMMITTEE ON STATISTICS.

Your Committee, in submitting this Report have to express regret that so far from being prepared to carry out the resolution passed at last meeting of Synod, to put the Report in a printed form, into the hands of the members of Synod, at the commencement of its sittings, they have even been unable to make it more complete than it was last year. Almost the sole cause of this unfavourable result is the delay of individual ministers and Presbyteries in forwarding their Reports. They have, however, pleasure in expressing for the second time their high satisfaction with the complete, carefully prepared, and business-like return from the Presbytery of Kingston, while at the same time the delay that occurred in transmitting the returns from all the other Presbyteries has proved both harassing and vexatious to your Committee.

Last year, out of 131 settled charges, 107 Reports were received, and about 24 gave in no Report. From this statement, it is evident: that we are increasing in irregularity. And while there has been an improvement in the more easterly Presbyteries, in the three westerly, great laxness has been introduced. Beginning with the Presbytery of Toronto, there has been an increase of delinquents from 7 to 12; in that of Hamilton, from 6 to 10; and in that of London, from 2 to 14; an increase of irregularity that could scarcely have been expected from a young and energetic Presbytery.

While making every allowance for vacant and newly settled charges, your Committee feel bound to state that much irregularity must prevail in this matter, and unless greater attention be given by Ministers and Presbyteries to this subject, our Statistics must become unworthy of confidence.

The real increase in the number of Ministers is 6, but if we take into account the number of resignations, the gross increase would be about 12. There were present at Synod last year 99 ministers, and 61 elders; this year there are 109 ministers and 58 elders, making a total of 167,—a fact which shows an increase of 10 ministers, but a falling off in the attendance of elders. All the ministers in each of the Presbyteries of Hamilton and Toronto, were present, except one. The actual increase in membership, as based on the columns of admission is 2149, by deducting from which 793 cases of diminution, the real gain is 1356, though there is a difference of 800 between this and the number of members report ed last year. This is to be accounted for by the defaulting congregations being different this year from those of last year. The largest increase has been in the Presbyteries of Hamilton and Toronto.

It is distressing to notice an apparent decrease in the numbers attending prayermeetings and Sabbath-Schools, being respectively, 2924, against 3832 last year, (a diminished attendance of fully 900,) and 8806 against 9128 of last year. We however find 2572 reported as attending Bible classes, against 1413 of last year. Your Committee hope that the smaller attendance at the prayer-meetings does not indicate a decay of vital piety; but the fact at least calls for faithful and frequent heart-searching on the part of office-bearers and members. The column recording Baptisms is interesting as showing the number receiving that sacred ordinance, and important by pointing out to Sessions the duty of keeping correct records of such events. The column giving the number of elders is also of consequence, by pointing out the numerous band of able and self-denying co-laborers, who are gathered round our ministers. Your Committee in connection with this would suggest an additional column for visitation by elders. The amount of average attendance may seem large— it was obtained by adding together the numbers attending forenoon, afternoon, and evening ; and as some congregations have only one diet of worship, and others three, by dividing by 2, a correct approximation may be obtained.

Your Committee regret very much that they are unable to present this table in a perfect form; but by adding one-sixth to each of the items to make up for the nonreporting congregations, a pretty correct idea of our actual numbers may be obtained and is now submitted. Ministers, 143; communicants, 20,000; gross increase, 2507. Real deducting diminution by death, &c. 975, 1532; prayer-meetings, fully 3000; Baptisms, upwards of 2000; Elders, nearly 700. Average attendance from 23 to 25,000. An examination of this table shows that the largest number of communicants admitted during the year was in the Presbyteries of Hamilton, Toronto and London. The column for prayer-meetings seems to denote, that the Presbytery of Montreal enjoys the great privilege of embodying the largest proportion of vital piety, within its bounds. Hamilton comes next, though at a considerable distance. The lowest in number in this respect is Kinsgton. It is well however to bear in mind that the weekly lecture is in many congregations partly a prayer-meeting. But do not statistics read to us in this respect a humbling lesson, and are they not calculated to stir us up to pray without ceasing? Would to God that this were the largest column in the return.

The greatest number of Baptisms was administered in the Presbyteries of Hamilton and London. Montreal possesses the largest staff of elders, and along with Hamilton and London, has the largest number of the young under instruction.

Your Committee in next submitting their financial table, are unable from the reason previously given to lay a full statement before the Synol; and notwithstanding the injunctions of last year, it will somewhat differ from the return of the agent.

The Hamilton Presbytery has again taken the lead as the largest contributor, but this year it shows a considerable falling off, being only \$27,545 49, against \$34,237 last year, though considerably above Toronto, the next in order of liberality; and it is nearly equalled by Montreal. The congregations that have made the largest contributions are Macnab Street Church, Hamilton, \$6,171 93; Knox Church, Toronto, \$5872, and Knox Church, Hamilton, \$4,803. There appears to be a considerable falling off in the contributions of Coté Street Montreal, the highest contributor last year for ordinary purposes The congregation actually contributing the largest amount is Peter borough, viz., \$9415 59, but though the congregation has been liberal, considering its circumstances, a proportion of the above sum has been contributed by parties unconnected with the congregation.

The following table will show the respective contributions of this and last year, for the five Synodical Schemes, Stipend, and Presbytery's Home Mission Fund :--

It will be seen, that while there is a decrease in most of the schemes, two of the most important show an encouraging increase,—the College, and Presbytery's Home Mission.

These, judging from their financial position, are justly regarded by our people as the most important of all. It is gratifying to find an increase of more than \$1400 in the College Fund; but it is well to bear in mind that this increase is chiefly due to special efforts made by several congregations. The most liberal contributor to this all-important Institution is the Presbytery of Hamilton, though it is nearly approached by that of Toronto, being \$1331 and \$1294 respectively. In the Presbytery of London, however, there appears a considerable falling off. The congregation that has shown most liberality to this scheme, is Knox Church, Toronto, which gives \$800.

In the Presbytery of Kingston, there are no defaulting Congregations, and in the Presbyteries of Brockville and Cobourg, all the Congregations so ling in returns have contributed to this scheme. This shows only a deficiency of 15, as compared with 18 last year, but if you add those that make no return, you have a total of 58 non-contributing Congregations, or fully one-third of our Church, and 14 more than last year. Your Committee, however, hope that Presbyteries will act as they deem most desirable with the defaulting Congregations within their bounds, and they would also urge upon the Synod the necessity of the claims of the College being brought more prominently before the Home Mission Stations, with the view of their aiding an institution, in whose welfare they are so much interested. It would now seem that the special effort made for the Building Fund having been concluded, the ordinary Fund is gradually assuming larger proportions. It is pleasing to find the Home

<sup>2</sup> Mission Fund growing so rapidly, as it evinces an increasing interest in the Home <sup>3</sup> Mission work. In 1857, this fund only amounted to \$662, and this year it has reached \$2528, having nearly quadrupled within three years.

There is a slight increase in the Widows' and Orphans' Fund, as well as in French Canadian Mission; but a decrease in the other two schemes.

Your Committee regret to notice a slight decrease of \$1072 in the Stipend Fund, but as the distinction between stipend paid and promised, was not made last year, the probability is that there is an actual increase.

It is distressing to find upwards of \$9000 due to Ministers out of the stipend promised to them - a sum that amounts to about one-sixth of their average income. This is a state of matters which should be inquired into by Presbyteries. The Presbytery of Kingston seems most deficient in this respect. The average stipend of each Minister is \$520 per annum. The average income in the Presbytery of Montreal is \$636 against \$842 last year. In Ottawa \$718. In Brockville \$570. (The last two formed one Presbytery last year, with an average of \$429.) In Kingston \$665 against \$376 last year. In Cobourg \$424 against \$402. In Toronto \$701 against \$402. In Hamilton \$654 against \$596. In London \$521 against \$436 last year. The Ministers of the Presbytery of Toronto have the highest average salary, and those of Cobourg, the lowest. The largest stipends, (\$2000,) are given by Knox Church, Toronto, and Coté Street Church, Montreal. It would thus appear, that notwithstanding the commercial depression, the average salaries are somewhat higher than last year, except in the Presbytery of Montreal. On examining the returns sent, it would seem that 25 Ministers have received less than \$400 of stipend during the past year. In Presbytery of Ottawa 1. In Presbytery of Toronto 1. In Presbytery of Brockville 2. In Presbytery of London 6. In Presbytery of Montreal 5. In Presbytery of Cobourg 4. In Presbytery of Hamilton 6. Only 16 were reported last year, but this arises from the amount paid, as well as promised, being now entered. Considerng the crisis through which the country is passing, the wonder is that more such cases have not been reported. 15 ministers in Presbytery of Hamilton.,-13 in Presbytery of Montreal,-6 in Presbytery of Cobourg,-6 in Presbytery of Brockville,-5 in Presbytery of Ottawa,--12 in Presbytery of London,--10 in Presbytery of Toronto, and 2 in Presbytery of Kingston-in all 69, or about one half of the Ministers of our Church have received less than \$600. The average contribution of each individual member is, for stipend, nearly \$3.50, the same as last year, and for all other purposes about \$3.55, as against \$8 last year. Or adopting the basis of families, \$5 for Stipend Fund, and about the same for general purposes have been contributed by each family. The average contribution of each member to the College has been about 30 cents, against 20 last year; and estimating the actual membership at 20,000, this amount, if universally contributed, would provide for all the ordinary College expenses. There is an apparent decrease of contributions to the amount of about \$10,000, as compared with last year, which is to be accounted for by the extraordinary sums raised for building purposes by several Congregations, and which in the case of two, amounted to nearly \$24,000.

Apart from the Congregations neglecting to send returns, not a few have failed to take up collections for the several schemes.

In the Presbyter have con with 18 li non-contr last year. most desi also urge more proinstitutio special e Fund is This is considerably less than last year--yet if we take into account the defaulting Congregations, probably one-fourth neglect the collections appointed by Synod.

The entire sum reported as contributed for religious purposes is \$118,921. This is considerably less than last year, which was \$128,868. But adding one-sixth to the gross amount for defaulting Congregations, the total would be about \$138,000; and if the amounts contributed to the British and Foreign, and Upper Canada Bible Societies, and to the funds of other denominations be taken into account, the actual sum will not fall short of \$150,000.

On our Churches and Manses lies a debt of upwards of \$80,000, and taking their value at \$450,000, one-sixth remains as a load of debt. Taking the average interest at six per cent., the sum necessary to be raised to meet the interest, amounts to nearly \$5000 a year, or as much as would erect a handsome rural church.

Your Committee, in conclusion, are of opinion that under the present mode of transmitting the returns, the irregularity has become chronic. For several years the same complaint has been made respecting the irregularity in forwarding the necessary returns, and stringent resolutions have been again and again passed by the Synod, but apparently with little beneficial effect. Your Committee have, therefore, concluded that some change of plan is needed, and recommend to the Synod the following scheme :

1. That the year of the five Synodical schemes run from the 1st of June to the 31st of May, when the Agents' books will be closed.

2. That the Agent's books be so constructed, as to show at a glance the contributions to the aforesaid schemes from each Presbytery and Congregation, and that the financial statement be made up from these books.

3. That during the meeting of Synod the Agent enter the various sums which are then usually handed in by members of Synod, and make up, at the earliest period possible, a supplementary statement, so as to furnish a complete view of the financial condition of our Church.

4. That the year of the statistical return proper, run from the 1st January, to the 31st December, and only contain the bona fide facts and figures comprised within the period specified—that returns be handed in to the Presbytery Clerks, on or before the 15th January each year, and be by them transmitted to the Convener of this Committee, not later than the 31st January.

5. That this return, fully completed, and accompanied by the usual Report of your Committee, and the financial statement of the five Synodical schemes, be put in a printed form into the hands of the members of Synod, at the opening of its sederunt. All which is respectfully submitted.


