

NOTE — All the Acts passed by the Parliament of Canada, are entered herein, including Private and Repealed Acts. The repeal or partial repeal of any Act will appear in the Table of Statutes ordered to be printed with this Index, and the detailed provisions will be found in the Indexes annexed to the Volumes referred to. Each Act is entered here only under a title referring to the whole Act. It is intended that all the Private or Local Acts shall be included under some one of the titles referred to under the heading "Private or Local Acts," so as to form, in fact, a classified table of the whole, and enable the reader to find all such Acts on any class of subjects. Such Acts are seldom repealed, and we have no means of ascertaining those that may have become effete by non-use or other cause. The letter *p* before the year in any case means that the Act is Private or Local, and entered in the second volume of the Statutes of that year at the page mentioned. This division into two volumes applies to all years after 1874, and if the Act be Private or Local the reference is always, after 1874, to Vol. 2.
