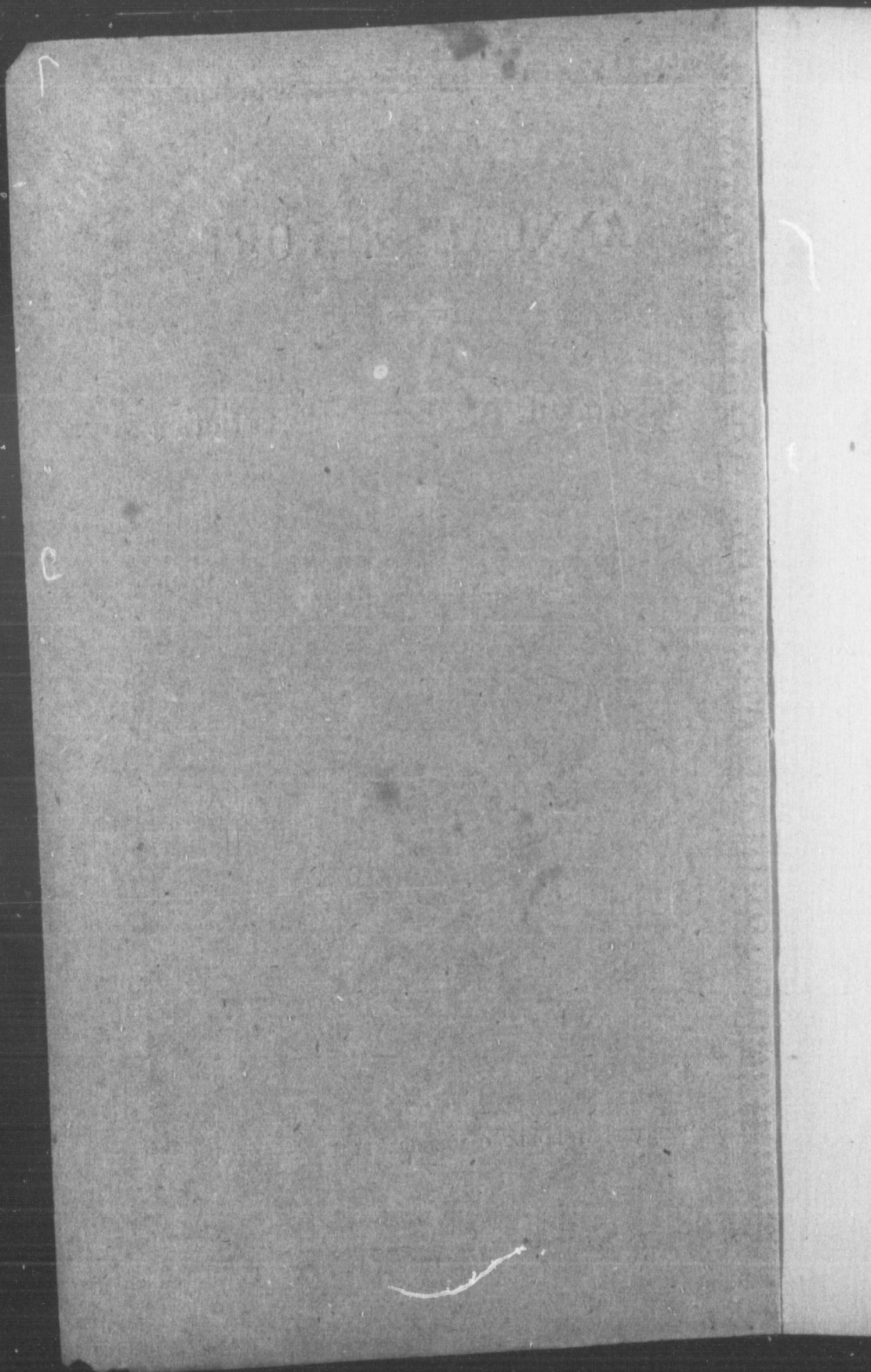

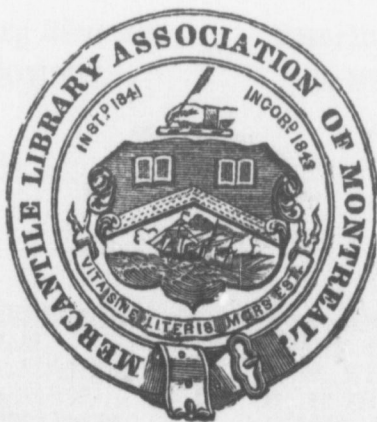

TERMS OF MEMBERSHIP.

Extract from the Constitution of the Mercantile Library Association.

ART. 1, SEC. 2.—Any person engaged in mercantile pursuits as a Clerk, may become a Member of this Association, on adding his name to the Register of Members, and paying his Subscription as in the next Article.

ART. 2.—Senior Clerk Members (*i. e.*, those receiving salaries of £25 or over) shall pay an annual Subscription of Twenty Shillings; and Junior Clerk Members (*i. e.*, those receiving no salary, or salaries under £25,) shall pay an annual Subscription of Ten Shillings.

ART. 3.—Merchants, and others not engaged in mercantile pursuits, may become members of the Association by signing the Register, and paying an annual Subscription of One Pound Five Shillings.

FOURTEENTH ANNUAL REPORT
OF THE
MERCANTILE LIBRARY ASSOCIATION.

Gentlemen,

In conformity with the rules of the Association, the Board of Direction beg to submit the following Report of their operations during the past year:—

Although your Board are desirous that the Report should be brief, yet they cannot enter upon the several departments connected with the Association without presenting a general view of its history during the year now expiring.

At the last Annual meeting a resolution was passed to the effect, "That this Association was of opinion that the time had arrived when an effort should be made to secure a suitable site for the erection of a convenient building." At the same meeting a Committee was appointed to co-operate with the Board in carrying out the above resolution. This Committee reported:—"That in their opinion there were two sites on which suitable buildings for the Association could be erected. The one preferred by the Committee was a corner lot on McGill and Foundling streets, belonging to the Reverend Sisters of the Grey Nunnery, but this lot could not be obtained. The next best lot was one belonging to the Hon. John Young, in McGill Street, adjoining the buildings lately erected by him. This lot is bounded on one side by McGill and on the other by Grey Nun Street. The locality is not so central as the Committee could desire; but it can be bought at a lower price

than other lots at present better situated ; and they believed that a lot on McGill Street, so near the port and entrance of the canal, with the probability that the business will, by-and-bye, (on the completion of the Bridge across the St. Lawrence,) centre more towards the canal, is more desirable than at any other point, and will, in a few years, advance more in value proportionately than a lot secured in any other part of the city. The Committee pointed out the necessity of unanimity in the choice of a suitable building site, stating if there be not unanimity among the members, it will, to some extent, mar the probable success of the Association in securing subscriptions for the building."

Your Board would express a hope that an object so much desired as that alluded to, be not lost sight of by their successors in office.

Your Board would notice, as the most important step taken by them, the leasing for three years of our present commodious rooms. They cannot, however, conceal the fact, that in taking this step they incurred a heavy responsibility, such as they would not have felt themselves warranted in assuming, had it not been their desire to carry out your wishes expressed at the semi-annual meeting.

Notwithstanding the great advantages and convenience which the present rooms afford, being much superior to any hitherto occupied by the Association, your Board regret to say, that there has not been an accession of members such as they anticipated. Especially would they notice the apparent want of interest in the Association on the part of clerks in retail stores, there being only thirty-three who subscribe to the Rooms.

Your Board feel certain, however, that there is not one member of this Association who would not cheerfully aid the retail clerks in obtaining greater freedom

than they now enjoy, did they exhibit a desire to support an Institution so well calculated to afford them both pleasure and instruction.

Your Board witness with great pleasure the prosperity of their Sister Institutions in this city, although a comparison with our own affords little gratification. The Institut Canadien numbers 640 members, and the Mechanics' Institute 820, while we number only 489.

The acknowledged members of the Association appear thus:—149 merchants, 199 senior clerks, and 61 junior clerks, making 409 paying members; also 53 life and 27 honorary members, making a total of 489. Your Board would observe, that hitherto the practice has been to insert in the report all the members appearing on the books, whether paying or not; they have considered it advisable to discontinue this practice, deeming it their duty to guard their successors against forming their plans for future operations and engagements upon false data.

At the commencement of the past year Mr. A. B. Stewart gratuitously disposed by auction of the newspapers and periodicals not fyled, a kindness which your Board hereby beg to acknowledge.

The Board have much pleasure in testifying to the efficiency of Mr. Donaldson, the Superintendent, and are happy to add, that they believe his duties have been discharged to the satisfaction of all the members.

Your Board would proceed to notice more especially, the different branches of the Association.

READING ROOM.

The Room has been supplied with 59 newspapers and 9 reviews and magazines. 562 strangers, including 50 clergymen, were introduced into the Rooms during the year, a privilege which must be highly prized by members having friends visiting the city. For the last two years telegraphic reports have been regularly

furnished to the Rooms. Your Board would, however, recommend to their successors the discontinuance of these reports, as being, in their opinion, unnecessary, and too expensive.

Also, a Second Course was delivered by the Rev. HENRY GILES, as follows:—Saturday evening, April 15th, on "Love of the Beautiful;" Monday evening, April 17th, on "The Worldling;" Wednesday evening, April 19th, on "The Enthusiast;" Thursday evening, April 20th, on "The Immortality of Shakspeare's Genius."

Soon after your Board assumed office, their special attention was directed to engage the services of popular Lecturers from the United States. But, the remuneration which they felt themselves justified in offering, not

being such as Lecturers of reputation would accept, during their "Lecture Season," your Board, like their predecessors, failed in effecting an engagement, until late in the Season. Not succeeding in carrying out their object at an earlier date, and being still desirous of affording the members an opportunity of hearing two of the most eloquent and popular Lecturers in the States, they secured the services of the gentlemen above named. Your Board fully expected that the reputation of these gentlemen would be a sufficient guarantee that their lectures would be more than well attended, and with that expectation they engaged the Theatre for the occasion. You need not be informed that your Board's anticipations were far from being realized. Suffice it to say that, that the receipts from these lectures did not cover the expenses incurred, and that the Board, and a few other members of the Association, contributed to meet the loss sustained, rather than draw upon the ordinary revenue of the Institution.

FINANCES.

Your Board regret to say, that the financial state of the Association is not, by any means, in so flourishing a condition as last year's Report would lead you to expect. It is true, that an allusion is there made to old obligations, still unpaid; but, it is further added, "that the cash in hand, (£27 9s.) with some £20 of good debts, making £47 9s., would almost evenly balance the claims against the Institution. With apparently so favorable a state of things, your Board entered on their duties with high hopes as to the future of the Association.

Your Board soon discovered that the above cheering prospects were but ill founded. The predecessor of the late Treasurer, having lost by fire all vouchers, &c., in his possession, it was supposed that there remained but few claims against the Association; but, after a careful investigation, it was ascertained that the liabilities at the time of your Board assuming office were much greater than they anticipated. In addition to the above, the great increase in rent of our present over our former rooms, together with £30 indemnity, consequent upon the non-fulfilment of an engagement entered into with the Mechanics' Institute, have increased your liabilities to £260 10s. A detailed account of which will be found in your Treasurer's Report.

Upon several occasions during the short history of the Association, special appeals have been made to the merchants and others, to aid in extricating it from pecuniary embarrassments. That an Institution of this character should be under the necessity of soliciting such assistance, reflects little credit upon the clerks in this.

city, and should not be countenanced unless for the specific object of erecting a "Hall" for the use of the members; such extraneous support only tending to encourage that want of self-reliance which has hitherto characterized the proceedings of this Association.

But overshadowed as our prospects are, one effort would relieve us from our difficulties, and place us in a position as enviable as that of the Institutions alluded to. Let each member procure an additional subscriber, and the object is accomplished.

The Board, in resigning into your hands the trust committed to them, do so, feeling that, although they may not have, in every particular, discharged their duties to the entire satisfaction of all the members, they can flatter themselves that they have rendered the Association one essential service, in exhibiting its affairs in their true light, so that their successors will be able at one view to see the difficulty they have to encounter.
