The High Courts.

HIGH COURT OF CALIFORNIA.

Los Angeles, Cal., October 27th, 1899.

The tenth annual session of the High Court of California, Independent Order of Foresters, was called to order in Spinney Hall, at the City of Fresno, Cal., on Tuesday, Wednesday and Thursday, October 17, 18 and 19, and was one of the best attended, and most interesting sessions in the history of that most excellent of High Courts, more especially so as to its social feat res, which are always of a most interesting nature.

The following official programme of events will show how well the brethren of Court Fresno, No. 763, provided for the entertainment of their guests, their labors being fully appreciated by the officers and delegates assembled.

On the evening of the 17th, a grand ball was given, at Armory Hall, in honor of the officers and representatives, the hall being beautifully decorated for the occasion. The music was excellent, and the High Chief Ranger, Bro. G. A. McElfresh, did himself proud, as the leader of the grand march, which was participated in by over 100 couples.

At the close of the ball, which occurred at 12 o'clock (Honolulu time) the guests were attended to at the Grand Central Hotel, by the committee on entertainment, where a sumptuous banquet was served under the auspices of Court Fresno, No. 763.

On the morning of the 18th, a grand parade was held, which was participated in by all the officers and members of the High Court, and which was led by the officers and members of Court Fresno, No. 763, in full regalia. The parade halted in front of the beautiful Court house of Fresno County where a photograph of the entire body was taken, after which the line of march was again taken up and ended at Spinney Hall, the place of meeting of the High Court.

Bro. John A. McGillivray, Supreme Secretary,

arrived at Fresno on the evening train of the 18th, and was met at the station by the members of the High Court, in a body, and was given a right royal welcome, such as only Californians can give to one whom they were delighted to see, as they were to see our "Genial John."

At 8 o'clock on the same evening a grand reception was given in the Barton Opera House, to the members of the High Court, by the citizens of Fresno. The Hon. the Mayor of Fresno welcomed the members of the High Court, and extended to them the freedom of the City. High Chief Ranger McElfresh, in a most eloquent address, acknowledged the honor extended by His Honor the Mayor, and then proceeded to explain the objects and principles of the Order.

Following the address of the High Chief Ranger there was provided a most interesting programme consisting of music, both vocal and instrumental, recitations, declamations etc., by some of the most noted talent of the City of Fresno, after which the assemblage was honored by a most interesting and eloquent address by Supreme Secretary Bro. John A. McGillivray, which gained the highest appreciation of all present.

On the afternoon of the 19th, the entire membership were treated to a free excursion, tendered by the good citizens of Fresno, over the local lines of the Southern Pacific Co., which said lines run through the largest raisin and wine vineyards in the world. Several stops were made at the large packing houses, and a pound package of table raisins was presented to each member of the Order. A stop of 15 minutes was made at the famous Kearny Wineries, where each member of the party was presented with a bottle of sparkling California Wine. It was noticed that Bro. McGillivray carried away three quart bottles of "Kearney's extra dry Sherry," but what he intended to do with them is, as yet, an unsolved mystery, inasmuch as he had addressed the High Court, during the morning, on the value of a temperance life.

A resolution, emanating from one of the Courts of the jurisdiction, praying that this High Court adopt resolutions recommeding the Supreme Court to reconsider its recent legislation with reference to the rates of assessment, was tabled without debate.

A petition to admit Companions to representation in the High Court met with a similar fate.

On the recommendation of the High Chief Ranger, the High Court Dues, for the current year, were reduced from \$1.00 to 80 cents.

The election and installation of the officers for the current year took place at the night session of Thursday the 19th. The following is the list of High Court officers:

The installation of the officers elect was performed by the Supreme Secretary, Bro. John A. McGillivray, and after the High Court had decided upon the place of meeting for the year 1900, (Santa Cruz.) the brethren, led by the Supreme Sec'y, joined hands and sang "Auld Lang Syne," followed by "America."

The High Chaplain was called upon for the closing benediction, and the session of the High Court, for the year 1899, was declared closed.

HIGH COURT OF MAINE.

Official Circular No. 15.

To be Read in Open Court.

OLD TOWN, MAINE, Oct. 2, 1899.

BRETHREN,—The High Standing Committee are desirous of interesting every member of our Order throughout the state in the work of securing new members, new Courts and upbuilding the Order generally.

In our last circular letter, as an inducement to our deputies and members to engage in organizing work, we offered for a limited time the full charter fee of \$100 for a commission. As a further incentive to the securing of new members in Subordinate Courts, we are pleased to refer you to Official Circular No. 7 of the Executive Council, giving Dispensation to remit the Certificate and Registration Fees on all new members secured during the months of October and November, and a further Dispensation to all Courts to initiate at Charter Rates during said months.

You were informed in our last circular letter that it was the intention of your committee to give the services of a Deputy to every weak Court in the state for such time as might be deemed necessary. Yow is the time for all Courts, and especially weak ones, to make special effort to increase their membership, as under the Dispensation new nembers may be admitted by payment of Medical Examination Fee only.

Your committee have been very fortunate in securing the services of Forester A. A. Campbell, D.S.C.R., an experienced Deputy of the Supreme Court, to assist in the work of extending the Order throughout the state. Forester Campbell is now engaged in vork in Bangor and vicinity. After completing his work in this field, he will devote a few weeks to other sections in the eastern part of the state, and will then work westward. You should arrange to secure the benefit of services while he is in your vicinity.

We also wish to call attention to a special Dispensation for the organization of Companion Courts which has been granted to Sister A. A. Campbell, the wife of Deputy Campbell, and which may now be taken advantage of. Under this Dispensation, Courts may be instituted by Sister Campbell upon payment, by the Charter Applicants, of the Medical Examination Fee only.

If Foresters or ladies who are interested in seeing a Companion Court instituted in their section, will secure a sufficient number of applicants for a Charter, Sister Campbell will meet with them, complete the work and institute the Court We hope to see many new Courts instituted during the next two months.

You may be interested to know that during the year 1898 we secured, without the aid of a paid officer, more new members in the State of Maine than any other society, and only two Insurance Companies, with their army of paid agents, succeeded in securing as many members in this State as did the I.O.F.

You are reminded that you are a member of the wealthiest and best managed Fraternal Beneficiary Society in existence. We have passed the \$3,500,000 mark with our surplus funds. You are an equal sharer with every other brother in this accumulation of golden treasure, and as a commonsense business proposition for yourself, should you

and have a voice in its deliberations?

Court Penobscot No. 1186 yields the Banner to Court Rumford Falls No. 1861, which numbered 192 members July 1st, last, and is the largest Court in the State. Penobscot brace up! We wonder which Court will lead next?

Some of the Courts are still in arrears for supplies and High Court Dues. These should be for-

warded at once.

From the Local Press.

The Washington High Court, Independent Order of Foresters, finished its work Oct. 11, in the afternoon and decided to meet in New Whatcom

two years hence.

The biennial session recommendation of High Chief Ranger Forsyth went through, but it was only after a hard fight. Many of the delegates thought yearly sessions should be continued, but on the other hand it was argued that the annual gathering is a useless expense. In support of Bro. Forsyth's position the fact was pointed out that at the session just closed there was not an appeal or a petition to be acted upon. Apart from the re-commendations of the High Chief Ranger, and the visit of Supreme Secretary McGillivray with his incidental defence of the Supreme Council's action raising rates, there has been practically nothing to do.

The date of the next meeting will be fixed later

by the High Standing Committee, which is com-posed of the highest seven officers. It will have to be set in time for the next meeting of the Supreme Court, which is to be at Los Angeles two years hence. The Supreme Court meets triennially, the last session having been held in Toronto a year ago. It will be necessary for the Standing Committee at New Whatcom to set the date for the meeting in time for the High Court to select its Supreme Representative. Until then Bro. Forsyth will continue to fill this position.

REDUCTION OF REPRESENTATION.

fifty members or fraction thereof, Courts of ten members or less to be not entitled to representation, was also favorably acted upon. The proposed reduction of the High Court Tax, from \$1 to 50 cents, was rejected for the reason that the membership in Washington is not yet large enough to justify it.

Another important matter decided by the Court was the determination to refuse women as delegates. In some Forestry circles the advisability of admitting the Companions has been agitated and more or less discussed. The High Court takes the position that the Companions are merely auxiliary to the Order and are not entitled to representation.

GETS GRAND CROSS OF MERIT.

The Grand Cross of Merit was conferred upon the retiring High Chief Ranger, Bro. Forsyth. This is the first time this distinction has been conferred in the state of Washington. Bro. Forsyth has been High Chief Ranger for three years.

Upper, of Spokane; H.J.W., William Cruse, of Seattle; H.M., Charles Frashch, of Seattle; H.C., James Brownie, of Seattle; H.S.B., N. S. Snyder, of Port Townsend; H.J.B , A. R. Pratt, of New Whatcom, and H. Mess., S. N. Poyner, of Tacoma.

Major John A. McGillivray, of Toronto, the Supreme Secretary, left on an evening steamer for Seattle, intending to stop over there on his way to Victoria. From Victoria he will go to California to attend the session of the High Court of that State at Fresno. Thence he will go direct to the City of Mexico. On his return home he will stop at Jamaica and Island of Porto Rico to work up the Order there.

According to the reports of the Secretary, Treasurer and Auditors, the Washington High Court is now absolutely free from debt.

HIGH COURT OF MID-ENGLAND.

This High Court, which has been a kind of nursing mother to the High Courts of Central England and Southern England, showed up well in Birmingham on the 11th October. Bro. Wilkinson, H.C.R., called to order about 10.30 a.m., and was supported by the bulk of his officers.

After opening seremonies the Credential Committee was appointed, and reported forthwith. Agreeably thereto the delegates present for the first time were obligated and instructed, the former being administered by the H.C.R., and the latter on request by Bro. Marshall, H.C.R., London, and General Manager in Europe.

The H C.R. reported in that capacity, and, in a second report, as representative of this jurisdiction at last Supreme Court meeting. The H.S. report was restricted to those matters coming within his province. The H.T. was absent through severe illness, so that matters of finance were dealt with on mention of High Secretary and Auditors

An upward tendency was noticeable in all matters reported on. The H.C.R. was supported in his recommendations on certain points, and the whole sayings and doings of the H.S. were commended, and a substantial honorarium ordered to be paid to him. The members were unanimous in asking for an increase of the organizing staff in the jurisdiction. When election time came, a fine healthy spirit of rivalry was evinced, and great good feeling followed the contested elections. Bro. Powell steps up from the Vice-chair to that of H.C.R., a worthily earned honor; Bros. Ashcroft (Derby), Horne (Newcastle-under-Lyne), and Row-'ey Moody (Hanley), each being put on H.S.C. as H.V.C.R., H.T., and H. Physician respectively. It has been characteristic of these brethren to act well their part in other positions in the past, and there was evident pleasure in securing them as members of H.S.C.. 
Syracuse Notes.

NORWAY.

How the Norsemen Take Our Valuation Report.

(From "Grenmar," of Sept. 30th.)

"The Independent Order of Foresters is in England classed with the ordinary life assurance societies and stands under the same strict control as these. It has therefore recently, as prescribed in the English Life Assurance Company's Act, had to submit to the Board of Trade a valuation report or statement for the five years 1893-97, showing its income and expenses, assets and liabilities, rate of interest, investments, etc.

The result is that the 1.0.F., on the 31st day of December, 1897, had funds which were £27,465 more than was necessary to provide for the risks and the provisions for premiums ceasing at age 70.

This report has been approved by the Board of Trade as satisfying the requirements of the act and is a document the reliability of which is beyond question. We should therefore be free from the many attempts which are made to weaken our confidence in the insurance system of the Order, and the public should, before refusing the offer made by the I.O.F. of safe insurance at lower premiums than in any other society, in its own interest study the exhaustive report which has been accepted by the Board of Trade. We are fully convinced that many who now under the influence of ignorant, but often not quite disinterested persons, are standing aloof would, if better informed, join the Order and try to become entitled to the many advantages it is giving.

As to ourselves we feel quite sure that the Independent Order of Foresters is worth joining and we welcome any respectable man who wants to join us and thereby procure to himself and those dependent upon him a security which he otherwise cannot procure without considerably higher outlay.

The I.O.F. is subject to supervision quite as strict as that which it is intended to introduce into this country, and intelligent people should at once reject all attempts to cast suspicion on the I.O.F. which in spite of all attacks exists as an Order 'of the people, by the people and for the people."



Editorial.

The Surplus on the 31st of October, 1899, stood at \$3,659,156.74.

During the month of October there were 3,655 applications, of which 3,265 were accepted. The promise for November (based on those already in) is over 4000 accepted. This is the answer to those few malcontents who have hoped that the changes of last Suprem Court session would kill the growth of the membership.

The Supreme Secretary has returned after a very arduous campaign in California and Washington. He also visited Mexico with a view to reporting on the desirability of introducing Independent Forestry into the healthy regions of that flourishing Republic.

Financial Secretaries having members whom they wish reinstated, will please read Clause 204 of the Constitution and Laws, and thereby save the S.S. annoyance, the suspended member dangerous delay and themselves humiliation. It is necessary not only that a remittance of dues be made but also that a for and application for reinstatement be made.

Some otherwise irreproachable persons who correspond with the Head Office are blessed with highly civilized but illegible signatures. Recently Dr. Millman received a Medical Examination with a signature so elaborate that it took several days to ascertain to whom it belonged. He wrote recommending the local physician to buy a rubber name stamp and stamp his papers in the margin, "so that we shall have not only your signature but also your name."

The Mission of the Chief.

The entertainment for the I.O.F. staff, held some days ago in the blue lodge room of the Temple, and consisting mainly of camera views collected and taken by Bro. Lawless, A.S.C.R., was marked by an affecting incident. For, on this occasion, Dr. Oronhyatekha took leave of his comrades, many of them the friends of a life time, on the eve of his departure for new fields of conquest and colonization.

His mission is to introduce Independent Forestry into the antipodes, and those other portions of the civilized world where there have not yet been erected the alters of L., B. and C. We may anticipate a somewhat lengthy absence; but while he is bringing in new High Courts let us bring in new members.

Besides the many personal advantages which the S.C.R. brings to his arduous task, he will be further strengthened by his recent election to the chief office of the National Fraternal Congress. For the presidency of that body is an office which represents the advanced fraternal thought of this hemisphere; and the incumbent of so high a chair is the most fitting missionary to carry to other continents the doctrines of New World fraternity.

Fraternity, under ambitious but wise guidance, is spreading throughout the world like the Imperialism of the Anglo-Saxon races. But giving all honor to the valor of armed Imperialism and to the justice of its cause, fraternal Imperialism is better. We bring more comfort to the widows, and our death rate is lower.

Columbus on his arrival at this comment brought the natives only death and disease. Our voyager, himself the greatest living representative of the native races, will do better for his hosts. No man who walks to the alter of L., B. and C. will be dangerously near either disease or death,—not if our Supreme Physician knows it.

Clean Cut.

It is an unfortunate turn of mind which leads some people to think that the spirit of fraternity is something wholly alien to the spirit of business and that the affairs of a brotherhood are to be conducted without precision and without calculation. Such people regard a fraternity as a body organized for charitable and social purposes and nothing else.

The truth is, that charity is one of the objects of every fraternity, and no body is a true fraternity unless the spirit of charity pervades and guides its every act. The truth is, that the social labors of the Orders are of the highest importance, both because of their effect on the community outside, and because of their immense influence in cementing the membership. But it is also true that nearly all the fraternities, in addition to their social and charitable objects, offer benefits that have a distinctly commercial character.

It has been brought home to the fraternities that the payments of money on the death or sickness of members must be made on a calculated basis, and that no amount of fraternal sentiment will make good financing out of random and capricious guess-work. Whatever the phraseology employed, every reputable fraternity is now fully alive to this, that when it p-omises a certain sum on the death of a member, the fraternity is selling and the member is buying a benefit; that the arrangement must be definite and mutual—the benefit sold must be genuine, solid and sure, and the member must punctually pay the fair price.

We have said this much not for the benefit of the ruling minds of the fraternities, for they are fully alive to the necessities of the situation. But it is sometimes, nay, always, necessary to remind, and forever din it into the ears of the rank and file, that they must pay their assessments to get their benefits.

It is necessary to keep reminding the brethren that fraternal charity does not cheerfully exercise itself with members who are negligent in their duties and unpunctual in fulfilling their obligations. The fraternal spirit will not expend itself in finding excuses for men who die suspended, or who fall sick and give no notice thereof. Societies are formed for the benefit of the tens of thousands of steady payers, and not for the exercise of a fatal leniency towards lapsers and stragglers. The cleancut men are the back-bone of the fraternities as they are the back-bone of the business world and of every human enterprise.

Lapsers.

Lapsers in a fraternity are of two kinds. First, there is the deliberate lapser who cuts adrift because he thinks his money will be better employed elsewhere. This lapser is entitled to some pity because he has exercised his judgment and his judgment is bad.

The other class of lapsers, and this class contains ninety per cent. of those who fall by the wayside, is the patron class. The gentlemen who patronize a lodge by allowing themselves to be made members just to help it along, and who patronize the Financial Secretary by allowing him to carry them, generally quit about the time the Financial Secretary gets tired of his knapsack.

For the benefit of Financial Secretaries who have often paid their own good money in and thought they were helping the Order by continuing a membership, we beg to express our deliberate opinion, founded on experience, that no Order is benefited by a continued connection with a dead-beat. Such a connection has but two endings; if the dead-beat dies, the Order pays for it; if he lives, the Financial Secretary pays for it.

No deserving member need be suspended because misfortune has prevented him paying his dues. Where the happiness of a man's dependent relatives is at stake, only a false delicacy would prevent him from acquainting his brethren with his inability to meet the necessary payments. And this is where the spirit of fraternity comes in. For we have never known a deserving member to appeal to his brethren to prevent his suspension without their responding cordially and promptly.

The Uncommercial Benefits of Fraternity.

The division of labor is one of the advantages which a great fraternity, above all other human institutions, enjoys. Thus, while the executive officers of the Order have their time fully occupied with the organizing, the finances and the administration of affairs relating to the death, sick and other stipulated benefits, the members generally have the responsibility of doing those acts which distinguish a fraternity from a purely business corporation. The unstipulated or uncommercial benefits of an order cannot be defined with precision, cannot be promised in a written contract, have no legal significance, are intangible and nonnegotiable; but are as real as the four seasons and as good as the light of the sun.

Every month we note with delight, in our own Order, the workings of the obligations upon those who solemnly and sincerely have charged their consciences with the duties of fraternity. We note that the brethren over in Milwaukee have purchased an invalid chair for a brother upon whom has been laid the heavy hand of disability. We note that the brethren in Newark have reached the outstretched arm of fraternity to a brother in far-away Denver, comforting him in the hospital during his last illness, and securing for his remains honorable interment when death had ended his sufferings.

Benefits such as these are very real. They cannot be weighed by actuaries or added up by bookkeepers. They are non-valuable benefits and invaluable.


Re members of the Order and the British-Boer war in South Africa.

OFFICIAL CIRCULAR, No. 8.

To all Members of the Order who are British Subjects, Greeting:

That the policy of the I.O.F. with respect to members of the Order entering the military or naval service of their own country may be clearly defined and fully understood, we desire to announce:

1.—All members of this Order who are British subjects have the right to enter the Army, Navy, or Militia of Great Brita'.1, or of any of her Colonies, and serve in South Africa or wherever else they may be called; and from the date of such service they shall be rated in the Ordinary or Preferred Class and shall pay the rates provided for such class as set out in Section 237 of the Constitution and Laws of the Order.

2.—All restriction as to residence or employment on vessels are hereby suspended in so far as they affect or may affect such brethren; such suspension to continue during the time that the said brethren are so engaged in the service of their country.

3.—The Financial Secretary of each Court is hereby instructed to transfer any brother who may be in the Hazardous or Extra Hazardous Class to the Ordinary or Preferred Class from the date of his entrance into the military or naval service of his country.

4.—All Courts are instructed to immediately furnish the Supreme Secretary with the name of each brother who may enter the military or naval service of his country, giving if possible such further information as to regiment or ship as to enable the Supreme Officers to keep track of our brethren and to communicate with them from time to time if necessary.

The Executive Council have every confidence that the Courts will give every attention and care, and, if need be, fraternal aid to the families of those of its members who may have responded to the call of duty.

To all Subordinate and Companion Courts:

That ample opportunity may be afforded for supplementing and completing the special effort so well commenced during the month of October, to increase the membership of the Order, the dispensation announced by Official Circular, No. 7, dated 20th September, 1899, exempting applicants for membership from the payment of any of the fees usually payable for admission to the insurance or mortuary benefits except the medical examiner's fee, is hereby extended and continued in force until the 31st day of December, 1899, up to which date all Subordinate and Companion Courts are authorized to initiate and receive into membership without the payment of such fees (except the medical examiner's fee) all applicants who have been duly accepted by the Medical Board after examination by their respective Court Physicians. The result of the work done under the dispensation up to date has been most gratifying, and the thanks of the Executive Council are hereby tendered to the Courts which have actively taken advantage of the opportunity to increase their membership.

pressly declared that the fees authorized to be remitted were and are those required by the Constitution and Laws of the Order to be paid to secure admission to the Order and the mortuary benefits thereof, and that

(a) Applicants for Social Membership in Companion Courts,

(b) Applicants for Enrolment for the Sick and

(c) Applicants for increase of Mortuary Benefits were and are required to pay all the certificate, curolment, registration and other fees demanded by the Constitution and Laws of the Order for admission to such membership or benefits.

Knaresborough.

The illustration given below represents the quiet old Yorkshire town of Knaresborough, in which, in the year 1715, was founded the Royal Order of Foresters. are among objects of interest to visitors. It was in the latter, so the tale goes, that Eugene Aram hid the corpse of the man he murdered, by the way in 1745.

"The Royal Order of Foresters" was founded at Knaresborough, England, in 1745, and in 1834 changed its name to "The Ancient Order of Forest ters," which name it still bears. In 1849 a Court of the A.O.F. was instituted in New York City, but soon died out. In 1864, Samuel Lambert organized Court Brooklyn, No. 4421, of the A.O.F. From that beginning the society spread over several States establishing Courts to the number of sixty-four. In 1872, Col. A. B. Caldwell, then Managing Editor of the New York News, united with Court Empire City, A.O.F., at 26 Delancey Street, New York. Soon after he was invited to deliver an address before Court Erooklyn, then meeting at corner of Court and Schemerhorn streets. At that meeting the Colonel advocated "Independent" Forestry, and his was therefore the first voice raised for the I.O.F. The sentiment was so well received that he continued to advocate independence when-ever opportunity offered. This was kept up for some two years, and he succeeded in securing a large following. In 1873, his Court, "Empire City," seceded from the A.O.F., his motion of secession being seconded by Samuel Gompers, now President of the Federation of Labor. On the 16th of June, 1874, a convention called by the Colonel met at Liberty Hall, 149 Market Street, Newark, N.J., to discuss the proposal for an "independent" organization, about five hundred members being present, and on the following day the assembly resolved itself into "The Independent Order of Foresters," with Col. Caldwell as first presiding officer, the governing body assuming the title of "Most Worthy High Court." What followed is known to every Independent Forester who has taken the trouble to read the history of the Order; he who has not read it should purchase a copy from the Supreme Secretary and store his mind with a knowledge of the history and principles, the trials and triumphs of "the best fraternal benefit society in existence."

A discussion has been going on for month; in a number of insurance journals on the much-discussed and mysterious question of "What becomes of the

Reserves belonging to policies which are terminated otherwise than by Death or Maturity?"

Whatever becomes of these reserves, one thing

Whatever becomes of these reserves, one thing is certain, that it materially adds to the cost of insurance, especially to those who decide to dis-

continue their policies.

In the Official Reports for the years 1896, 1897 and 1898, of Wisconsin and Connecticut, the total reserve released by surrendered and lapsed policies, and the total surrender and lapse values allowed, are given, consequently it is an easy matter to see just how much the companies made by retaining a portion of the reserve.

Those who are interested in this subject are referred to the following table, from which it will be seen that of the \$29,734,091 of reserves for feited by policyholders, and for which they got no value, whatever, the enormous sum of \$23,518,366 was taken from policyholders by six companies

alone.

Is it any wonder that legal reserve life insurance companies are increasing their assets and surplus by millions every year?

RESERVE RETAINED ON LAPSED AND SURRENDERED POLICIES.

The following table, compiled from Official Reports, shows the reserve released on lapsed and surrendered policies and the amount returned to policyholders in surrender values, and the balance as given in the last column being the amount retained by the companies out of the reserve to the credit of the insured when the policies lapsed or were surrendered. and attention to the work.




