Amendment adopted.

The Grand Scribe read the following document.

Almonte, Ontario, 14th October, 1871.

To the Grand Division of S. of T., of the Province of Nova Scotia.

Dear Brothers,
At the last meeting of the National Division at Boston, advantage was taken
of the presence of so many representatives from the British Provinces to hold
a conference as to the best means of promoting the interests of our Order in
British North America; the representatives present were nineteen in all, and
each Province was represented; three meetings were held, and the Rev. G.
Huestis was appointed Chairman, and the Rev. J. W. Manning, Ontario, Secretary.

During the meetings a full and free interchange of opinions took place, from which it appeared that the establishment of a National Division for the British Provinces would tend materially to promote the interests of the order.

After discussing the question of Finance it was considered by the representatives that a National Division would entail no greater expense upon the order than the proportion now paid by them to the present National Division; and that even should the cost be greater it would still prove a benefit to our Order by an increase of membership—the delegates from two or three of the Provinces being decidedly of opinion that such a step would double the number of their members.

Each of the representatives desired it to be distinctly understood that they were actuated by no unfriendly feeling towards our brethren in the States, but solely by a desire to serve the common cause.

In order to give practical shape to the conference, it was moved,

That it is the opinion of the representatives now present that the time has come for the formation of a National Division for the British Provinces, and that we recommend the subject for action to the different Grand Divisions.

On being put to the vote every representative voted for its adoption.

It was then moved and carried,

That one Representative from each Grand Division, and the Secretary be a Committee for the purpose of framing a document to be laid before the different Grand Divisions.

The conference then broke up and the above committee met, when the outline of the document was agreed to, and the Secretary requested to prepare it, and address a copy to each Grand Scribe.

The following were, amongst others, the reasons for which the formation of a National Division for the British Provinces was considered desirable:

1st. Because it was a generally expressed opinion that a National Division for the British Provinces would largely increase our numerical strength by removing prejudices that now exist, in various localities, against our order in consecuence of the connection with the United States.

2nd. Because the extent of the present jurisdiction prevents a full supervi-

sion over all parts by the head of the order.

3rd. Because the large majority of representatives from the different States in the National Division, gives (no doubt unintentionally) a tone to the legislation of that body in which as British subjects we have no interest.

4th. Because the frequent meetings in our own localities of a National Division would tend materially to add to the influence of our order in those places.

5th. Because the establishment of a National Division will give us the control of our own funds for the advancement of our order in our own jurisdiction.

6th. Because we believe that a National Division for the British Provinces could be efficiently sustained without imposing any greater hurdens pon the order than those now existing, whilst, should our numbers largely increase, as it is believed they will, a corresponding deduction may follow.

7th. Because whilst our Order would be benefitted in the British Provinces, there would be no loss suffered by it in the United States; the large number of representatives rendering it only possible for very few to take part in the discussions, and also that such separation, if brought about, would not entirely sever the two bodies, as we should still hold the same friendly relations as other existing National Divisions.

Hoping this subject will receive your best consideration, and that you will instruct your Grand Scribe to join in an application for a National Division Charter,

Minute of last evening's sitting were read and proved.

A communication from Brother John McLearn, Deputy of Rechab and Still-in-Time Divisions, in relation to per capita tax—was read and referred to Committee on Communications.

The G W. P. read his report as follows:

TO THE GRAND DIVISION OF THE SONS OF TEMPERANCE, OF NOVA SCOTIA.

Officers and Brothers,-

Once more in the good providence of God, in the possession of health and many other blessings, we assemble in annual meeting to review the past year, consult in reference to future operations, and stimulate one another by the greetings of an exalted friendship, and the mutual resolves of an enlightened philanthropy.

I cordially greet you as co-labourers in the field of toil in the jurisdiction of this Grand Illusion, convinced that the cause we seek to advance is not only important, demanding respect and attention, but that it is in this our day pre-eminently important and necessary, in order to the salvation from drunkenness of that class of society around which gathers the future hope of our country—

our young men.

Our past efforts have doubtless been instrumental in checking the tide of intemperance from destroying many of our best men and women; but with the combination of means at our disposal, the Press, the Pulpit and Platform, and the working of our noble Order, but little, comparatively speaking, has been accomplished. The deadly influence of the rum traffic, impelled by human passion and folly, seems still to have a firm grasp of large numbers of our population; and sometimes one almost imagines that this abominable habit is on the increase.

We are still obliged to repeat as the agents of moral and religious enterprise, which has often been done before, the unanswerable question, "What shall be

done to stay and destroy this iniquitous and alarming evil?"

As Sons of Temperance we still have a name to live; but, alas! too many are as good as dead to the interests of our Order, striking their colours and abandoning their once vaunted professions of temperance, vitality in such is fast

dying out.

Shall we conclude, as some would have us do, that this organization, like some which have preceded it, has fulfilled its mission, and should now gracefully retire from public life in order that some new arrangement may be instrumental in pressing forward the temperance reform? I think we are hardly prepared for such a retrograde movement; and yet unless an impetus is supplied from some source, speedily, the painful anticipation may yet be realized. Neither past success, pleasantly reviewed, nor firm resolve, sincerely utter-

Neither past success, pleasantly reviewed, nor firm resolve, sincerely uttered, nor speeches at our annual and other gatherings, nor our beautiful ceremonies, will save us from a retrograde course, unless we use carnest and intelligent effort. Sustain, then, the Subordinate, the Grand and National branches of our Order, the Press and the Agency, by your individual and united efforts. If we wish to do good a greater effort must be put forth, or I greatly fear that disaster and ruin must be our lot. Let the subject be fully and freely discussed at this annual meeting, under the guidance of Him who doeth all things well, and by our co-operation good will result.

I fully intended to have prepared an epitome of the state of the Order in the several counties in this Province, under my jurisdiction, for presentation at this Annual Session; but for want of time, as well as the necessary information, I am totally unable to say a word on the subject. This course is generally expected from the Grand Worthy Patriarch, at the Annual Session, as an exposition of the state of the Order, but when I inform this Grand Division that I have only received two or three reports from all my deputies, I know they will excuse me from attempting it. As usual I shall have to depend upon our efficient Grand Scribe for all the statistical information at command.

The National Division held this year in the city of Boston was well attended, not only from distant States, but from all the Provinces of the Dominion, where the Order has been established. Eight representatives were present from Nova

Scotia, as well as some visitors.

Several questions were under discussion, among which was the admission of coloured persons to membership in the National Division. This was decided in the affirmative, and two persons, one from Maryland and one from Massachusetts, took their seats as members. While this gave a colouring to the proceedings, I can assure you that one of those persons manifested a capability of throwing much light upon all the discussions in which he took part.

The reception and festivities given by the Grand Division of Massachusetts to the members of the National Division, has, I believe, in point of magnifi-

cence, never been exceeded on any similar occasion.

The entertainment at Music Hall, in the city of Boston, was almost beyond

description, in the display and abundance of its festivities, &c.

The subject of a separate National Division for the Dominion was fully discussed by the Representatives from the several Provinces, a report of which will be submitted for your consideration. I trust the discussion of so grave a question will be approached and investigated with intelligence, wisdom and caution.

The subject of a suitable Agent will also engage your attention, which measure will be brought to your notice by the report from the Agency Committee.

If no one man can be found to enter into the work, perhaps much might be done by employing local Agents, in the several counties where our cause seems to be waning.

The vexed question of the increase of the per capita tax will also claim your attention, as a notice for a repeal of the clause adopting it, was given at the Quarterly Session held at Liverpool in August last. No one question at this Session will require more careful consideration than this. Without money, the Grand Division, as the head of the Order in this Province, cannot be sustained. Without means public opinion cannot be enlightened, and our principles diffused over the land; in fact, cripple or withhold our resources, and a public Temperance sentiment, now so necessary, will languish, wither, and perhaps die out altogether. If professed Temperance men have the great cause at heart, I think they will cheerfully contribute of their substance for the grand object of making our cause triumplant and universal.

I cannot conclude this brief, imperfect, and hastily written report, without referring, in terms of commendation, to the efficient manner in which our worthy Grand Scribe conducts The Abstainer, the recognized organ of this branch of the Temperance Reform, as well as the adopted Organ of other organizations. Its weekly messages are full of truthful matter, well put, and inseparably connected with the present and future interests of the Temperance cause; and I hope, and trust that it will henceforth be more fully patronized and encouraged by all professed Temperance men.

It would therefore seem that in the present state of the Temperance movement, something more must be done to stay the demon of destruction now sweeping over our land. What shall it be? It is for you, brothers, to determine; and guided by wisdom from above, I hope your decisions and reselves will be wise and prudent.

I trust this Session will be profitable and beneficial to our common cause, and thanking you for the courtesy extended to me during my official term,

The Grand Scribe presented the following Report.

TO THE GRAND DIVISION, SONS OF TEMPERANCE OF THE PROVINCE OF NOVA SCOTIA.

Worthy Brothers,-

The termination of another official term brings us together in twenty-fourth annual session of Grand Division, to "deliberate on the means best adapted" to advance the interests of the Order and to make provision for the carrying on of our work during the coming year.

Our organization has not been so active during the year new drawing to a close, as it might have been. A spirit of apathy has prevailed in the jurisdiction, and but little temperance work has been done, compared with former seasons. Several Divisions have ceased working; a few others are struggling for an existence, some of which may deem it necessary to surrender their charters. An impression prevails that the increase of the per capita tax has caused this result, and that a large majority of Divisions will cease to work in consequence of the additional burden. It is true that to the increased demand upon their funds may be attributed the suspension (but temporarily, I hope) of less than half a dozen Divisions; and it is also true that the present rate presses heavily upon a number of others, particularly those having but small funds, and who need all their resources to complete their Temperance Halls now in course of With these exceptions, the present apparent inactivity of the construction. order is due to the indifference of the members rather than to the increased And I would here remark that if some of the struggling Divisions had not been meddled with, and inducements pressed upon their members to surrender their charters, and take position in the ranks of other organizations, these Divisions would now have been in a healthy condition. Tampering with the members has made them doubtful as to whether they should hold on by the "old Order," or try others for awhile. Such action creates a division of the forces, lukewarmness, disappointment, and ends in injury to the cause of Temperance. My fears, expressed a few years since, that the introduction of too many organizations into some parts of the Province would result in the disappearance of all associations engaged in preventing the spread of intemperance, have been, to some extent, realized. To these things, in a great measure, and not entirely to the increase in the per capita tax, is due the present apparent declining condition of the order of the Sons of Temperance in this jurisdiction, and consequent dereliction of duty on the part of temperance men. In some cases the free distribution of rum by candidates, or their agents, at the recent provincial elections had an injurious tendency, from the effects of which some few Divisions have not yet recovered.

Several Divisions that were considering the propriety of surrendering their charters, have concluded to continue their work as branches of the order.

To remedy this state of things, the services of a good Agent and Lecturer are absolutely required. But the Agency Committee have not yet succeeded

in finding a suitable person to put in the field. It is of the greatest importance to our association that innucliate effort be made for the encouragement of subordinate Divisions, by the periodical visits of a duly authorized official. In addition to public lectures, the visitation of Divisions in business session by competent agents is a present necessity, in order that more life may be infused into their members. How can, or shall this be accomplished? A lecturer to address public meetings on the subject of temperance, and an agent visiting the Divisions would arouse the Order from its lethargy in a few months. If we cannot get a lecturer, can a well-informed visiting agent be had? one whose duty it would be to re-organize Divisions, and work the Order into a new life.

The sum of \$426 21 is now in the Treasury to credit of the Agency fund.

Non-receipt of many Returns for past quarterly term, and absence of information in the shape of reports from Deputies and Divisions, prevent me from giving a detailed statement of the condition of the Order in the jurisdiction.

Following is a summary of the Returns received for the quarter ending Sep-

The receipts of this office to 21st inst., amounted to \$293.29, of which

amount \$101.23 is credited to the Agency fund-

In reference to the per capita tox, some Divisions still withhold payment of the additional four cents on members and two cents on lady visitors; others have not paid the increased rate because of inability to do so. Were it not for the agitation of one or two persons, for agitation sake, several Divisions that have refused payment, would have cheerfully paid the full amount. A final settlement of this, now somewhat delicate question, will be necessary at the present session.

A large number of Divisions now admit females to full membership, some of whom, I am led to believe, have been benefitted thereby. Three of the city

Divisions admit female members.

The following named Divisions are not working: Island Home, 170; Tangier, 194; Randall, 231; Fenwick, 239; Melrose, 290; Hillside, 291; Fisherman's Home, 293; Brule, 296; Karsdale, 315:—9.

The following named may be considered as dead: Inverness, 172; Oakland,

243; International, 302; Dominion, 311; Livingstone, \$14;-5.

Although it may not be well to class them among those not working, the following named Divisions are not holding their meetings with anything like regularity, and have failed to report to this office for some time: Parrsborough, 110; Wolfville, 112; North American, 128; General Inglis, 152; Bethesda, 209; Banyan, 225; Welcome, 260; Homeville, 271.

On the roll of the Grand Division there are the names of one hundred and fiftythree Subordinate Divisions. Of these, not more than one hundred and twenty can be considered as being in good working order.

One Charter, only, was granted during the year, but no new Divisions were

organized.

During the past seven months, the demand for stock used by Divisions has not been as frequent as previously. Per Capita tax for quarter ending September 30th, has been received from not more than half of the Divisions sending in Returns for that term, which will make the receipts of this office for past three months appear much less than usual.

To this date the accounts of the Grand Division have been kept in Nova Scotia Currency. It was be necessary at this Session to provide for their being

kept in Dominion Currency.

The National Division of the Order met in Twenty-seventh Annual Session at Boston, Massachusetts, on the 6th, 7th, 8th and 9th days of September last. This Grand Division was represented by eight members, viz: P. G. W. P.'s McMurray, Creelman and Huestis; P. G. W. A.'s Johnston and Heenan; G. W. P. Hamilton, G. W. Associate Williams, and G. Scribe Monaghan. The Session was the largest ever held. There was not much business transacted. The most important change was the increasing of the tax from Grand Divisions to the National Division from three cents to free cents on each member in the jurisdiction. The proposal to increase the tax was opposed by your representatives, they believing it would be burdensome on the funds of this body. The Journals of Proceedings have not yet come to hand, but the following is a synopsis of the business done, for a copy of which I am indebted to Most Worthy Scribe Hodges.

Resolved, That the Most Worthy Treasurer be, and is hereby requested to furnish his report to the Most Worthy Scribe, to be printed with Reports of Most Worthy Patriarch and Most Worthy Scribe, before the opening of the

Sessions of the National Division.

Whereas, In the Order of the Sons of Temperance, under the jurisdiction of this National Division, we know no distinction, on account of race, color, or former condition, but all are alike equal before the law; therefore

Resolved, That in our future action, we do not deem it expedient to organize separate hodies in the same territory, on account of any of the above named

distinctions.

Resolved, That this National Division earnestly recommends that all Divisions supply themselves with such documents as discuss the question of narcotics, and stimulants, and their effect on man, so that the members of our Order may become intelligently educated on these subjects so necessary to the final triumph of temperance.

The following decisions of the Most Worthy Patriarch were confirmed:

Applications for charters may be acted upon at Special Sessions, as such matters do not vitally affect the general interests of the Order, so as to require

action only at Annual sessions.

No person can be a member of two Divisions at the same time; no person can legally join a second Division until connection with the first has been severed in some of the modes prescribed by the Constitution; and initiation into a second Division, while retaining connection with the first, is null and void, and gives no right there to membership. Any member so offending, should be charged in the first Division, with a violation of the rules of the Order.

A member who becomes intoxicated by drinking liquors, even if drank under the advice of a physician, violates the pledge.

A member, acting as cashier in a department of a Fair where cider is sold, and knowing the fact, although such member does not handle or deal out the same, or any other article, violates the pledge.

The N. D. also decided that

A By-Law making any who should violate Art. 2nd of the Constitution ineligible to the office of W.P. or W.A., for six months, is unconstitutional, as the law recognizes either the conviction or exoneration; and consequently the subjecting a brother to probation is a violation of the law-

All bodies have an inherent right to protect their own members, and preserve their own purity, whether so defined by law or not; that in all such cases they are a law unto themselves, and consequently a Grand Division has the right to

entertain, charge, try, and expel a member on such charges.

A dispensation to install a W.A., under twenty-one years of age, is legal, even if the name of the person to be installed is not inserted.

A Grand Scribe shall keep his records in a manner satisfactory to the Grand

Division.

The Constitution of the National Division was so amended that the propagation tax is included in the per capita tax, that tax being placed at 5 cents each member, annually, two-fifths of which is to be appropriated for propagation purposes.

A slight amendment was also made in the form of return required from Grand Divisions, so as to make the return conform to the other constitutional

The Constitution for Grand Divisions was amended, Rule III, so as to read as

Rule III-Time of Meeting .- An annual, Semi-Annual or Quarterly Session, shall be held at such times and places as may have been fixed at a previous Annual Session, and officers shall be elected at the Annual Session.

There was no change whatever in the Constitution and Code for Subordinate

Divisions.

The Revised Ritual was referred to a Committee, with full powers to prepare and publish the same.

Resolutions in favor of a Temperance Press were adopted, and the support of the same by temperance men was urged.

It was voted to hold the twenty-eighth Annual Session of the National Division in the City of Chicago, Illinois, on Wednesday, the 19th day of June, 1872.

One hundred and sixty five delegates were present, representing twenty six Grand Divisions. These Grand Divisions report a membership of 89,465, and 19,526 Lady Visitors,-a total of 108,991 out of 117,504, or 93 per cent of our total strength.

In the month of September the Representatives from the Provincial jurisdictions, attending the meeting of the National Division in Boston, held a conference on the subject of establishing a National Division for the British North American Provinces. All the Provincial Grand Divisions were represented. A document prepared by a Committee appointed by the Conference will be sub-

mitted for your consideration.

I have to announce the death of P. G. W. Associate, the REV. NATHANIEL GUNNISON, at Norway, Maine, U. S., on August the 18th, after a brief illness. Our deceased Brother was an active and useful member of the Order during the time he resided in this City. He became a member of this body Jan. 26th, 1859, was installed G.W Associate, Oct. 30th, 1861; initiated a member of the National Division June 18th, 1862. Although residing in the United States for the last six or seven years, Brother Gunnison continued his membership in Mayflower Division in Halifax.

I have also to announce the death of P. W. P. John Sears, D. G. W. P. of Lady of the Lake Division, No. 267, of Lochaber, Antigonish County. Brother Sears died in August last. He was initiated a member of this body October

26th, 1869.

The Committee on the State of the Order, having had submitted to them the

Reports of the G. W. P. and G. S., beg leave to report:

Whatever may have contributed to the present low state of the cause of Temperance and of our Order in Nova Scotia, your Committee see no great occasion for despondency. We have in the past on more than one occasion passed through seasons of discouragement and trial; but hopeful in the goodness and blessing of Almighty God, and in the righteousness of our cause, we pursued the even tenor of our way and had the season of darkness succeeded by a brighter

day, and rejoiced again in the triumph of our principles.

To become disheartened because the Order we so much love is now in a comparatively languishing condition, would be to afford encouragement to those who would rejoice greatly in our overthrow. Rather let our hope and trust be strong in that benign Providence whose watchful oversight is especially extended to every effort and service tending to the welfare of the human race .--Let us nerve ourselves afresh for labour and conflict, prepared for greater sacrifice and toil than the past history of our Order has witnessed, and in the confident assurance that our labour shall not be in vain. In due season we shall reap if we faint not. Strong and united exertion is called for from all our Divisions. A faithful regard to our obligations as Sons of Temperance, a punctual attendance at our Division Rooms on each regular night of meeting, individual effort to save the fallen and to gather into our ranks any who would be likely to prove an acquisition to our ranks,—and with all the rest, combined and aggressive effort to extend our organization by public Temperance meetings frequently, and by agitating for the formation of Divisions in localities where they are likely to prove a blessing, and for the resuscitation of Divisions that are drooping, or that have fallen into decay. By these and other means which will readily be suggested to zealous and devoted brethren of our Order, we shall not long have to mourn over such a state of indifference as unhappily now exists; but instead thereof, shall have to rejoice over a new era of life and prosperity in our great reform. The very means we employ to benefit and bless others, will react favorably upon our own zeal and prosperity, until the wilderness shall be glad and the desert become arrayed in bloom.

The Committee carnestly hope that the efforts to employ General Agents and Lecturers will shortly be successful, convinced that upon the employment of suitable persons in these capacities our progress largely depends, and persuaded that if the right men can be had, their mission would prove to a large extent

self-sustaining.

The importance of fidelity on the part of the local and County Deputies is too self-evident to need remark. It is hoped that these Officers will be found working with all the zeal and success that distinguished brethren in these offices in days gone by.

To the question of per vapita tax, now being made in some localities a matter of disquietude, we confidently recommend the attention of this Grand Division, believing that the prosperity of many of our Subordinate Divisions de-

pends greatly upon the judicious settlement of this question.

The Committee need not commend to the Grand Division the great advantage to the cause of Tomperance in this Province that our Organ " The Abstainer" should be everywhere introduced and liberally patronized; and we earnestly hope that the power of the press thus at our command will be vigorously employed in our aims and efforts to advance our great cause.

The project of a National Division of the British Provinces of North America, which, last year, received the serious consideration of this Grand Division. will again be brought to the notice of this body, and we hope with results that will meet the approval of all the Grand Divisions of these Provinces.

We recommend that the suggestion of the Grand Scribe in regard to the

adoption of the Dominion currency by this Grand Division, be favourably entertained.

G. W. P., Officers and Representatives,-

The Committee on Communications would respectfully present the following report, viz:

Your Committee would report that they have received Communications from the following Divisions in reference to the extra Tax imposed upon members of the Order, viz:

Lady of the Lake, Rechab, Still in Time, and Ray of Hope Divisions. In all of these Communications this Grand Division is asked to settle this question of extra per Capita Tax so as to meet the views of the members; and your committee are of the opinion that these communications express the views of the members of the Order generally.

Your Committee have also considered the correspondence received during the past year bearing upon this same subject, to which is added some statistics that

will aid the Grand Division in arriving at a correct conclusion.

Your Committee find that on the 30th of June last 145 Divisions were on the Roll of this Grand Division. That out of that number of Divisions only 79 Divisions sent Returns to the Grand Scribe.

That 16 Divisions have stated decidedly they will not pay the additional Tax.

That 17 Divisions report themselves unable to pay the additional Tax. While your Committee feel the great importance of the object sought to be gained at the time this extra tax was imposed; yet it is of the highest importance that every obstacle to the harmony and prosperity of the Order should be removed. The question of raising money has always been and always will be a vexed question. It is therefore to be hoped that whatever this Grand Division may decide upon, may be done with a desire to benefit the Order throughout the jurisdiction.

Your Committee would like to meet the views of the members in recommending that the Tax be reduced to the original sum of 6 cents. But to meet any deficiency that may arise in view of the fact that many Divisions do not send in any Returns or pay their Tax with anything like regularity, your Committee would recommend that the Tax be fixed at 7 cents per member, to take effect with Term beginning 1st January, 1872. We suggest that the tax of 2 cents be continued upon Lady visitors as during the past year.

Communications have also been placed in the hands of your Committee from

Star Division of Lockeport, and Crystal Division of Middle Stewiacke inviting this Grand Division to hold the July Session at these places.

Your Committee would recommend that the July Session be held at Locke-port, and if convenient to the members of Crystal Division that the January Session be held at Middle Stewiacke.

All of which is respectfully submitted in Love, Purity and Fidelity.
