We hope also in next number, to supply a Report of the Synodical Meeting in commemoration of the Tri-centenary of the Reformation in Scotland.

# CONGREGATIONAL STATISTICS.

An exceedingly interesting and useful Report was submitted by the Committee with their missionaries in Salonica in on Statistics to the Synod which was, however, unfortunately imperfect, in consequence of the omission of a number of congregations to supply the needed information. The Synod regarding "the work as one fraught with interest and importance station will be occupied by our Church to the Church at large" instructed all Kirk Sessions who have not sent in Reports 45,000 Jews, and an effective Mission to the Convener (the Revd. Robert Dobie of Osnahruck) to do so on or before the Scotland. It is bound in a stiff cover, and contains with printed columns pages for entering a register of the class as well as of the daily attendance of the scholars and other memoranda, The book contains 12 pages of strong paper, and will be found of service to Sabbath School Teachers. The price is 50 cents per dozen copies, or, inclusively of postage to any part of the Province, 63 cents. The Scheme of Lessons for the Quarter commencing on the 1st of July, and including the last half of the year, is offered, as will be seen by the advertisement, at 15 cents per dozen copies, postage paid. We can heartily recommend the use of this Scheme to schools not provided with such means of instruction.

> The Annual Missionary Meeting of the Presbyterian Church, in connection with the Church of Scotland, was held in Stirling on Tuesday evening, the 13th February. After the meeting had been opened with singing and prayer, W. R. Parker, Esq. was called to the chair; and very interesting and appropriate addresses were delivered by the following Ministers :- Revds. Messrs. McLean & English, of Stirling (Wesleyan Methodists); Rev. Mr. Neill, of Seymour; Rev. Mr. Walker, of Belleville, and the Rev. Mr. Buchanan, the resident Manister of Stirling.

> The Stirling choir, led by Mr. Mills, enli-vened the audience with several pieces of music.

The House was crowded, and all present appeared to have the Missionary cause at heart by the close attention given to the eloquent speeches of all the Rev. gentlemen present. The collection amounted to nearly \$80.

The Presbyterian Congregation of Seymour held their Annual Missionary Meetings in St. Andrew's Church on the evening of Tuesday, the 6th March, and in the Sons' Hall, Campbellford, on the following evening. After singing and prayer the Minister of the congregation, the Rev. Robert Neill, gave some account of the Missionary Schemes of the Presbyterian Church of Canada, in concetion with the Church of Scotland, and then introduced the different speakers-the Rev. Messrs. English and Downs, of the Wesleyan Methodist Church, and the Rev. Messrs. Buchan and Walker, of the Presbyterian Church, who in a very happy and impressive manner addressed the audience on the duty and importance of Missionary enterprise, and the special claims of the Home and Foreign Missions of the Church to their liberal support. Notwithstanding the unfavorable state of the roads both places of meeting were well filled; all present seemed interested and delighted with the proccedings, and about \$50 were contributed for Missionary purposes.

A Missionary Meeting was held in St. Andrew's Church on Monday evening, 30th April. The building was well filled on the occasion, there being present, in addition to the congregation, many persons from the other Protestant denominations in the town. After prayer by the Rev. Mr. Niel, the chairman, Mr. Burdon in a short speech drew attention to the Missionary Schemes of the Presbyterian Synod of Canada, in connection with the Church of Scotland. # REPORT OF THE COLONIAL COMMITTEE.

QUEEN'S COLLEGE, CANADA.

We have before us the Report of the Colonial Committee of the Church of Scotland, and consider it a most valuable and instructive document. We may hereafter. when we have less pressure upon our space, make room for it. The Scheme is evidently now in vigorous hands, and we only regret that the Funds placed at the disposal of the Committee are inadequate to the demands upon them. Meanwhile we select one or two extracts.

The Report opens its view of the Colonial field with a narrative of operations in our own Province. We extract a few paragraphs.

The Committee feel it to be a duty as it is a'so a privilege, to congratulate the Church at home on the state of her offshoot and representative in this great colony. Incidents, which will be noticed under another head, have brought the Committee into an unusual intimacy of correspondence with distinguished members of the Canadian Synod, and the result has been most gratifying. It is eminently desirable that such intercourse as is here alluded to could be more frequent; for it tends to strengthen on the one side a hearty interest which is apt to languish, and to sustain on the other an affectionate loyalty which is exposed to many adverse influences. The Committee take leave to invite the special attention of the General Assembly to the Annual Report of the Trustees of Queen's College, hereinafter inserted; and they would venture further to

recommend that steps be taken to facilitate the access of ministers at home to the yearly issue of " Acts and Proceedings of the Presbyterian Church of Canada," which is, in many respects a most interesting and instructive document.

The ensuing extracts show how lively an interest is felt by the Committee in the welfare and prosperity of Queen's College, and how cordial the endorsement of the new principal, Dr. Leitch, is as well on the part of the Committee as of the General Assembly.

The Annual Report by the Trustees of this Institution may be justly regarded by the Church at home as a satisfactory and encouraging document. Before inserting it in these pages, the Colonial Committee desire to lay before the General Assembly an expression of the gratification which they derived from their intercourse with the deputation of the Trustees, the Rev. Dr. Barclay of Toronto, and Alexander Morris, Esq., barrister-at-law, of Montreal, who visited this country in autumn last with reference to the selection of a Principal and Primarius Professor of Divinity for Queen's College. The Committee, considering that the appointment to this important office is by the Charter vested absolutely in the Trustees, restricted themselves to what they deemed to be their proper province-that of facilitating and aiding the end in view by correspondence, and by obtaining personal interviews with such ministers as had otherwise been brought under the notice of the deputation. The result has already been hailed, both at home and in Canada, with a general satisfaction; and the Committee are assured that the Rev. W. Leitch, A.M., recently promoted to the well-carned degree of D.D. by the University of Glasgow, will go to his new field of duty, possessing the cutire confidence and enjoying the best wishes of the Church of Scotland.

The Colonial Committee, moreover, aceply impressed by the representations of the deputa

tion on the subject of Bursaries for Students of Theology at Queen's College, increased their annual grant for that purpose, as is noticed in the Report of the Trustees, from L 30 to L 50. Should their opinion as to the importance of encouraging the education of a native clergy meet, as they think it deserves to meet, the approbation of the General Assembly, they will be anxious, 30 500n as the state of their funds permits them, to increase this grant in compliance with the urgent request of the Trustees.

The following is the deliverance of the Assembly after hearing the Report :---

Which day the General Assembly of the Church of Scotland being met and constituted, wter alia, the General Assembly called for the Report of Colonial Committee, which was given in and read by the Rev. Dr. Stevenson, Convener. Several members being heard, it was moved and unanimously agreed to that the General Assembly approve of the Report now presented, reserving consideration of the part thereof relative to Army Chaplains till the Report of the late Moderator therein referred to shall have been received; renew their expression of unbated anxiety to promote, by every means in their power, the religious interests of their countrymen in the Colonies, and earnestly recommend this object to the increased liberality of the Church.

The General Assembly congratulate the Church in Canada and the Committee on the appointment of the Rev Dr Leitch to the office of Principal in Queen's College at Kingston, an appointment which has already been haded with approbation and confidence both at home and in Canada, and which, they trust, will, by the Divine blessing, greatly encourage the training of a native Preshyterian ministry for all the provinces of British North America.

The General Assembly, with reference to the four Students from Nova Scotia, - Messrs Grant, M'Millan, M'Gregor and Cameron,-approved of the recommendation contained in the Report, and authorised the Presbytery of Glasgow to

#### STANDING ORDERS.

The report of the Committee on Standing Orders having been called for was read by the Clerk.

Agreeably to a recommendation contained therein, the Synod convert the minutes hitherto repeated from year to year in the first day's proceedings, in regard to the Synod's hours of meeting, and meetings of Presby teries during the Session, into Standing Orders.

The following Bill reported by the Committee was read .-

Bill anent the Representation of the Eldership in the Superior Church Courts

WHEREAS it is desirable to embody in one Act sundry resolutions and enactments of this Synod, made and passed at different times. on the representation of the Eldership in the Superior Church Courts, and otherwise declare and facilitate the practice of the Church in this matter, with the view of providing for the said representation in a full and effective manner, be it enacted as follows :-

1. Each Kirk Session shall, at a meeting regularly summoned by the Moderator giving intimation of the time, place, and object thereof, duly constituted and held, within two months after the closing of the annual Session of Synod, exercise their right of electing annually one of their number, who must be a bona fide acting Elder of their Congregation, and who must have signed the Formula appended to this Act, to represent them in all meetings of the Saperior Courts during the Synodical year, to wit, until the close of the annual meeting of Synod then ensuing and the responsibility and daty of summoning the said meeting shall lie with the Session and the several members thereof, as including both the Moderator and Elders, and, as a means of reminding them of this duty, the Synod Clerk shall, within ten days after the closing of the annual Session of Synod, in each year, mail or cause to be mailed, a printed copy of the blank Form of Commission annexed to this Act, to the address of each Minister on the Synod Roll, being Moderator of a Kirk Session, but the not being furnished thus with a copy of the said Form shall be no excuse for any Moderator neglecting to summon his Session in the manner and for the purpose aforesaid; and, although the period of two months is allowed for the election of Representative Elders, nevertheless, Sessions are enjoined to make their elections with all convenient speed, and if it come to the knowledge of Sessions or Moderators of Sessions that a meeting of the Presbytery of the bounds is called or appointed to take place, before the first ordinary or stated meeting thereof after the closing of the annual session of Synod, they are required to regard this circumstance as an urgent reason for expedition in this matter, so that if possible there may be no meeting of Presbytery without Representative Elders, should it be their desire or interest to attend.

Il At the meeting of Session summoned and constituted, as hereinbefore provided, no procedure shall be taken in the election of a Representative Elder until the Moderator shall have read the following in so doing to conform in every respect to the requirements of the Act. statement in the hearing of the members present :-

Wheneas it is the principal and distinctive duty of the office of a there to deliberate and vote, agreeably to the word of God and i the constitution of this Church, on all questions affecting the interests both of the Church at large, and of the particular Congregation to which he belongs; and whereas it is of the utmost consequence that the Church, in her legislative, judicial, and executive capacities, should be assisted and strengthened in her several Courts by the presence of her Representative Office-bearers therefore the member of this Session, who may be elected to fill the office of Representative Elder, shall be required, before his election be sustained, to acknowledge it to be his duty, (1) to attend the meetings of the Presbytery of the bounds and the ansend a written apology to the Moderator or Clerk or Synod if necessarily prevented from attending the annual meeting of Synod, and he shall be required to promise that, God willing, he will, to the atmost of his ability and deligence, fulfil his duty in these several particulars:

And this statement having been read the Session shall make an elechereby appointed for this year, namely, the Moderstor, Convener, Dr. | tion, and require of the party elected his assent thereto, and it he refuse to give his assent his election shall be held to be null and void, and the Session shall proceed immediately to a new election, but it he give his assent his election shall be austained, in which case the Session Clerk shall record a minute of this procedure according to the Form annexed to this Act, and shall forthwith furnish the Representative Elder with an extract thereof, which shall be his Commission, and which shall be good and valid until the close of the ensuing annual Session of Synod but no longer, and if no member of Session be found willing to be elected, a minute to that effect shall be recorded and an extract thereof forwarded to

the first stated meeting of Presbytery.

III. In circumstances rendering it impossible to elect a Representative Elder within the aforesaid period of two months, the Session so situated shall make an election as soon as possible thereafter, and in the event of the death, or permanent removal or separation from the Session or Congregation, of the Elder elect, or in the event of his resignation, which it shall be competent for the Session at any time, if they think fit, to accept, the Session shall, within one mouth after the occurrence of the va-cancy thus occasioned, hold a meeting duly summoned for the purposo of supplying the same by a new election, and all Sessions availing themselves of this provision shall cause the reasons of such elections to be fully and explicitly minuted in their records, and shall instruct their Clerk to furnish Elders elected in such circumstances with extracts of the whole proceeding therement, which extracts shall be the Commissions of the Elders so elected instead of the usual Form of Commission annexed to this Act; provided always that an Elder so elected shall be called upon to express, and shall express, his assent to the statement embodied in the second section of this Act.

IV. Representative Elders elect are required to lay their Commissions before the Presbytery of the bounds, not later than the first stated meeting thereof after their election, by personal compearance or by transmission of them to the Moderator or Clerk of Presbytery in time to be submitted to said meeting, provided always that, in the case of an election made according to the terms of the third section of this Act, if no meeting of Presbytery be held between the said election and the ensuing anmual meeting of Synod, the Elder so elected shall it possible forward his Commission to the Synod Clerk so as to be in his hands at least four clear days before the said annual meeting of Synod, to be by the said Clerk submitted to the Synod, but if this be not possible it shall be competent for him in person to lay his Commission before the said meeting of Synod, and it shall be competent for any meeting of Presbytery whatever to its character, provided only it be duly met and constituted, to receive and dispose of Elders' Commissions; and it shall be the duty of every Presbytery, at its first ordinary or stated meeting after the expiration of the aforesaid period of two mouths, to call for Elders Commissions and to enquire diligently into every case in which a Kirk Session may appear to have neglected to make an election or a representative Elder to forward his Commission, and such neglect in either case shall, on sufficient evidence, be consurable; and it shall not be lawful for a Presbytery to sustain any Commission which does not bear that the election it intimates has been made agreeably to the provisions of this Act.

V. A charge fully organized by once having had a Minister regularly inducted, being vacant and still on the Presbytery Roll, shall be entitled to representation in the Superior Courts by one of its Elders, the same as if it were supplied with a settled pastor, and Presbyteries shall, at their first stated or ordinary meeting after the annual Session of Synod, give practical effect to this right, by appointing one of their number, being a Minister, for each Session not having a Moderator, to be a term Monerator thereof, and in making such appointments shall enjoin all interim Moderators to give the Sessions for which they are respectively appointed an early opportunity of electing Representative Elders, and

VI. The Elders of a charge consisting of two or more Congregations, or sections of a Congregation, under one Minister, shall, for the purposes Representative Elder to attend the Superior Church Courts and of this Act, be considered as forming one Session, and they shall convene for the election of a Representative Elder, after due intimation as hereinbefore provided, at such time and place as may be agreed upon by a majority of their number.

VII. Inasmuch as Representative El ers are elected to attend the Superior Courts in behalf of the Sessions and Congregations to which they belong, and for the general interests of the Church at large, it shall be the duty of each Session to make provision from any fund at their disposal for such a purpose, by public collection, or otherwise, for the travelling expenses of their Representative Elder to Presbytery and

VIII. # Formula for Ruling Elders.

I do sincerely own and declare the Confession of Faith approven by former General Assemblies of the Church of Scotland, and ratified by law in the year 1690, to be the confession of my faith; and that I own the doctrine therein contained to be the true doctrine which I will constantly adhere to. As likewise that I own and acknowledge Presbyterian Church Government of this Church now settled by law, by Kirk Sessions, Presbyteries, Provincial Synods, and General Assemblies, to be the only government of this Church, and that I will submit thereto, concur therewith, and never endeavour directly or indirectly the prejudice or subversion thereof: And that I shall observe uniformity of worship, and of the administration of all public ordinances within this Church, as the same are at present performed and allowed.

It was moved by A. Mann, seconded by G. Thomson, That the Bill ne transmatted to Presby teries, that they may consider and report thereon to next meeting of Synod, but that it be not made an interim act. It was moved in amendment by A. Barker, seconded by Dr. Cook, That the Bill be referred to a Committee composed of Dr. Barclay, Convener, Dr. Cook, Dr George, J. Bain, Judge Logie, and R. Dennistoun, that they may consider and report thereon at an early day. It was also moved in amendment by Dr. Mair, seconded by Dr. George, That the Synod enter upon the consideration of the Bill now. The first amendment was carried against the second by a vote of 55 to 15, and the motion against the first amendment by a vote of 45 to 31. The Moder-

ator declared accordingly.

The following Bill also reported by the Committe on Standing Orders is transmitted for the consideration of Presbyteries, and they are instructed to report thereon to next meeting of the Synod :-

Bill unent the attendance of Ministers at meetings of the Superior Church Courts.

WHEREAS by the constitution and practice of this Church all monsters holding pastoral charges are members of the superior indicatories; and whereas at the time of induction to such charges such ministers did, both by oral assent and written subscription, publicly own the Presbyterian government and discipline established in this Church, and did solemnly promise that, through the grace of God, they would firmly and constantly adhere to the same, and to the utmost of their power in their station assert, maintain, and defend the said government and discipline, and in their practice conform themselves thereto, and never endeavour directly or indirectly the prejudice of the same, and that they would be subject to all superior judicatories of this Church where God in his providence would cast their lot; and whereas a diligent and faithful attendance of such ministers upon all stated meetings of the Superior Courch Courts, together with the exercise of their gifts and privileges in the dispatch of business, is one of the most obvious and important ways of faifilling the aforesaid solemn promise, yet, whereas it is true that some ministers of this Church do frequently absent themselves from said meetings, and thereby seriously impair the mittee is continued with the addition of Dr. Barclay.

manner at once secure and convenient for reference; and the Synod efficiency thereof, and render the transaction of business by those who do attend very unsatisfactory, be it enacted and declared by this Court as follows:

I. That this Synod, moved by zeal for the proper and effective maintenance of Presbyterian government and discipline, in the exercise of its lawful jurisdiction over all ministers belonging to this Church, strictly enjoins and requires all such ministers aforesaid to be diligent and faithful in the fulfilment of their duty of giving regular attendance at all meetings of this and other judicatories of which they are now, or may hereafter become, members; and hereby resolves and determin s to enforce this injunction, by calling all ministers infringing it to accoun, and holding them censurable, and consuring them, for so doing, as shall see fit; and further enjoins Preshyteries to do the same in regard to the non-attendance of ministers at their stated meetings.

II. That all ministers knowing beforehand that they cannot attend the annual meeting of Synod are required to show their respect and obedience to this Court, by sending letters of apology containing a statement of the reason of their absence to the Moderator, at the place of the said annual meeting, in time to be received by him on the first day thereof, or earlier at the place of L's residence; and, on the first day of the said annual meeting, the Synod, when appointing other Committees, shall appoint a Committee whose duty it shall be to report the names of all absent ministers, distinguishing between those absent from said meeting and those who have absented themselves from more than one meeting in succession, and to examine and report on the letters of apology received by the Moderator, distinguishing between the reasons of absence contained therein as considered by the said Committee to be sufficient or insufficient; and ministers absenting themselves without sending letters of a ology shall be ranked among those who are absent without a sufficient cause; and the Synod shall take action upon the report of their Committee in such manner and form as may seem best.

III. That inasmuch as ministers are members of Church Courts and they are bound to attend the meetings thereof, with a view to promote the interests of the Church at large and of the several congregations thereof, and inasmuch as the expense incurred by their attendance is considerable and is sometimes felt to be a difficulty in the way of attend ing, and it is desirable to diminish and remove it, the Synod requires Kirk Sessions to provide for the travelling expenses of their ministers to meetings of Church Courts, in the same manner and to the same extent as they are required, by the seventh section of an Act passed this session anent the representation of the eldership in the Superior Church Courts, to provide for the travelling expenses of their Representative Elders.

# CORRESPONDENCE WITH THE COLONIAL COMMITTEE.

The report of the Committee on correspondence with the Colonial Committee was called for and read. The report is approved of and the Committee continued.

# FORMATION OF A GENERAL ASSEMBLY.

The Synod called for the report of the Committe on the formation of a General Assembly, which was read. The Committee reported the existence of a general opinion against the expediency of this movement at present, and agreeably to a recommendation, custained in their report, the Committee is discharged in the meantime.

# DIVISION OF BATHURST PRESBYTERY.

There was read an extract minute of the Presbytery of Bathurst, showing that by a vote of nine to four members of that Court it was resolved to recommend the Synod to divide the Presbytery into two. It was moved by J. Bain, seconded by A. Morris, That as there is a considerable diversity of opinion among the members of Presbytery on this subject, the Synod resolve that the time has not yet arrived when a division is desirable. It was moved in amendment by J. Evans, seconded by J. Gordon, That the recommendation of the Presbytery of Bathurst be agreed to. The motion was carried by a large majority.

# DIVISION OF HAMILTON PRESBYTERY.

There was read an extract minute of the Presbytery of Hamilton proposing a division of the said Presbytery. It was moved by K. McLennan, seconded by G. Macdonnell, That the report of the Presbytery of Hamilton with reference to a subdivision of its bounds be sustained and that effect be given to the recommendation of said report, by authorizing the members residing in the bounds of the proposed new Preshytery, to take the usual steps towards organization as a separate Presbytery was moved in amendment by A. Mitchell, seconded by C. Campbell, That there should be no division of the Presbytery of Hamilton at the present time. The motion was carried by a vote of 64 to 8. The Moderator declared accordingly, and G. Macdonnell and J. Hogg were appointed to prepare a minute in regard to the proposed new Presbytery.

# METRICAL VERSIONS OF PSALMS.

The report of the Committee on metrical versions of Psalms was called for and submitted verbally by Dr. Cook, Convener. The ComAn extract minute of the Presbytery of Hamilton of date 31st May, 1860, sustaining a Commission from the Kirk Session of Clifton, in favour of Gilbert McMicken elected to be Representative Elder, and adding his name to the Roll was read. The Synod ordered Mr. McMicken's name to be added to their Roll.

There was read an intimation, from the Secretary to the Board of Trustees of Queen's College, of the election of Judge Malloch, Alexander Morris, Esq., and John Thomson, Esq., and of George Davidson, Esq. in room of the late John Mowat, Esq., to be lay Trustees of the College.

The report of the Committee appointed to wait on the Rev. Robert Burnet and other parties in Hamilton was received and read.

# ACT FOR REGULATING PUBLIC COLLECTIONS.

The Synod renew their act of last year for the regulation of public collections as follows:--

HEREAS it is desirable for various reasons to make alterations in the Act of Synod, 1854, anent the regulation of public collections for Missionary and other operations of the Church, and otherwise provide for the due observance of Synodical injunctions in regard to the matter, the Synod repeal the said Act, and appoint the following public collections to be made in all the Churches during the ensuing year, namely: First, for the Jewish Mission Scheme—On the first Sabbath of July; Second, for the Temporalities Fund—On the first Sabbath of October; Third, for the Ministers' Widows' and Orphans' Fund—On the first Sabbath of January; And Fourth, for the French Mission Scheme—On the first Sabbath of April; Provided always, that when the celebration of the Sacrament of the Lord's Supper shall happen to fall on any of the said Sabbaths, or when any of the said Sabbaths shall be deemed unsuitable and inconvenient for making the collection, then another day may be selected by the Session within four weeks thereafter; Provided also, that in case of any congregation preferring to raise their contributions in any other way, as by subscriptions and donations, or to furnish them out of any fund under their control, they shall be at liberty to do so.

The Synod, while rejoicing at the increased fruits of Christian effort in this Church, would earnestly urge on all their people the duty of still further augmenting the means supplied by them for promoting the cause of the Redeemer, hitherto so inadequate to the extent of the field daily opening up to the operations of the Church, and so far within what might be expected from the gratitude and love due to a crucified Saviour. They strictly enjoin all Ministers of the Church to fulfil the duty incumbent on them, of at least exhorting their Congregations to embrace the opportunities afforded them of contributing towards the maintenance and spread of the Gospel of Christ on all the days above specified: And the Synod erjoin every Minister on a Sabbath preceding that on which each collection is to be made, to give due intimation thereof from the pulpit, together with such information on the object of the collection as he may have been able to acquire; And they enjoin the Conveners of the several Committees and Boards for the management of the Schemes herein specified, to forward in good time to all the Ministers notices of the appointments herein made as they shall become due respectively, together with such statements as it may be of use and interest to read from the pulpit along with their intimations; And in particular the Synod enjoin the several Presbyteries, at their meetings next after the times specified, to inquire into the diligence of all their Ministers and Congregations in this matter and to record reports thereof in their Presbytery Books, and likewise instruct the Committee of Synod for revising Presbytery Books to notice how far Presbyteries attend to this injunction; And the Synod earnestly urge on all the people seriously to consider the duty of contributing liberally for the advancement of Christ's cause, according to the ability wherewith God has blessed them; And the Synod ordain a sufficient number of copies of this Act to be printed forthwith and distributed among all Ministers and Missionaries, who are hereby enjoined to read it from their pulpits on the first Sabbath after receipt thereof. This Act shall be annually on the first Sabbath after receipt thereof. This Act shall be annually renewed, with such amendments as the Synod may deem called for, and the expense of printing it shall be borne equally by the several Schemes, and the funds of each Scheme shall be charged with all

# expenses connected with its own management. MAINTENANCE OF MINISTERS.

Returns of opinions of Presbyteries, respecting the Overture and Interim Act, anent the maintenance of Ministers, having been read, it was moved by W. Snodgrass, seconded by Dr. Muir, That the returns with the interim Act be referred to the following Committee, namely, R. Dobie, Convener, G. Neilson, Dr. Muir, A. Barker, and J. Greenshields, that they may consider and report thereon upon Monday next. It was moved in amendment by Dr. Cook, seconded by A. Spence, That a Committee be appointed to prepare a new enactment on the maintenance of Ministers, and that the Committee be instructed in such enactment to prohibit Presbyteries from settling any minister in a congregation, without a promise of £100 a year independent of the Temporalities Fund. The motion was carried by a vote of 46 to 23.

The Synod re-elect Dr. Mathieson, Dr. Cook, Hugh Allan, and John Cameron, to be members of the Temporalities Board, agreeably to the provisions of the Act incorporating the said Board.

An understanding was come to as to the time and place of next annual meeting of Synod.

#### CONGREGATION OF NEW RICHMOND.

There was read a minute of the Synod of New Brunswick, of date 18th July, 1859, agreeing to receive the congregation of New Richmond within its bounds, in accordance with the terms of a minute of this Court last year.

#### CATECHISTS.

The Synod having called for the report of the Committee on Catechists and Missionary operations, it was read by D. Morrison, Convener. There was also read an Overture from the Presbytery of Glengarry asking the Synod to define the duties of Catechists. It was moved by W. Snodgrass, seconded by J. Greenshields, That the Synod thank the Committee for their diligence in this matter, adopt the report, and instruct Presbyteries to abide by its recommendations when employing Students for the Ministry as Catechists,—which motion passed unanimously, and the Moderator conveyed the thanks of the Synod accordingly. The following are the provisions recommended by the Comittee in

THAT the Synod enjoin Presbyteries to use diligence and exercise great caution in their selection of Catechists, and take order that none be engaged without their sanction; that the Synod require Catechists, before entering upon their work, to appear before the Presbytery or Committee of Presbytery, charged with the supervision thereof, that they may be examined as to their gifts and ability to expound the Holy Scriptures; that Catechists be required to write out beforehand whatever expositions or exhortations they may offer to the people, (whether to be read or repeated memoriter), and to hold themselves in readiness to submit all such written expositions or exhortations to the Presbytery or Committee of Presbytery, and to read any one of them that may be named or called for; and further that along with their own expositions they read a printed sermon, from some volume sanctioned by the Presbytery, in the services of public worship which they conduct among the people.

Call was made for a final statement from the Clergy Reserve Commissioners. No report was received, the Chairman giving reasons. The Synod earnestly request the Chairman of the Board to see that a final statement be ready for the next meeting of Synod.

# SYNOD FUND.\*

The Synod heard the statement of the Synod Fund read by the Treasurer, J. Cameron, Esq. On motion of Dr. Machar, seconded by D. Morrison, and unanimously agreed to, the thanks of the Synod were convend to the Treasurer

veyed to the Treasurer.

J. H. Mackerras read the report of the Committee on Finance, and the Synod gave the following deliverance thereon: Receive the report; approve of the suggestion contained in it with reference to the arrears of Paisley and Arthur, for 1858; adopt the scale of assessment recommended, and enjoin Kirk Sessions to remit their contributions to the Treasurer with all convenient speed; further, with reference to the defaulting Session of Woodstock and Norwich referred to in the report, the Synod appoint the Presbytery of London to visit the said congregation, and both investigate their state generally and deal therewith in respect of the special matter complained of by the Finance Committee, and their conduct towards the other schemes of the Church, the said visitation to be held on the nineteenth day of July next.

# QUEEN'S COLLEGE.

The annual report of the Trustees of Queen's College was read. It was moved by George Bell, seconded by J. Greenshields:

1. That the Synod learn with gratitude the general success of Queen's College during the past year, and rejoice that the Trustees have secured for the College and the Church, the services of a gentleman so eminently qualified for the office of Principal, as the Rev. William Leitch,

2. That the best hope of continued and enlarged success in the training up of ministers is, under God, in prayer, and the Synod therefore cordially recommend all ministers to give increased attention to this subject in the devotions of the sanctuary.

convenient Sabbath thereafter, on the call to the Gospel Ministry, setting forth the wants of the Church and the existing destitution of our land, and at the same time to hold up for consideration such things as will recommend the Gospel Munistry as a calling, in order that parents and youth may give its claims respectful hearing; and the Synod further appoint the said Sabbath as a day of special prayer for the outpouring of the Holy Spirit on the rising generation, and upon the officers and students of Queen's College.

4. That this Synod earnestly and affectionately recommend parents to lend their children to the Lord, and to dedicate such as in their judgment possess the requisite qualifications to the office of the Holy

5. That the Synod earnestly urge Presbyteries to guard with a becoming caution and a firm vigilance, the door to the holy office of the ministry, so as not to admit to that sacred calling men wanting in mental or moral qualifications for its high and holy functions.

Which motion being put pa-sed unanimously. It was also moved by Dr. Cook, seconded by G. Neilson, That Dr. Williamson, Dr. Muir, Dr. Cook, and J. Greenshields, be a Committee to prepare a petition to the Provincial Parliament, claiming for Queen's College a share of the public provision for academical education in Upper Canada,-which motion passed by a vote of 54 to 11, and the Moderator declared accordingly.

#### BURSARY SCHEME.\*

The Synod having called for the report of the Committee on the Bursary Scheme, it was read by Dr. Machar, Convener. It was moved by Dr. George, seconded by  $\Lambda$  Morris, That the Synod have heard with satisfaction the report of the Bursary Committee, and again record their sense of the importance and usefulness of this scheme; that the Synod having appointed the second Sabbath of February as a day of special prayer for Queen's College, and for bringing the claims of the College under the notice of their congregations, do earnestly recommend that upon the said day, or such other Sabbath as may be more convenient, a collection be taken up in aid of Queen's College Bursary Fund; and that the committee be re-appointed, with the addition of the Rev. William Leitch, D. D., and Profe sor Mowat,—which motion being put passed unanimously.

# APPLICATIONS FOR AID IN BUILDING CHURCHES.

Applications from Caledon, Port Hope, Ross, and Kincardine, to the Colonial Committee of the Church of Scotland, for aid in building Churches, were referred to a Committee consisting of R. Dobie, Convener, J. Macmurchy, J. H. Mackerras, G. Nolson, and R. Dennistoun, with instructions to report at an early day.

# PROTEST AND APPEAL, - JOHN ROBERTSON AGAINST THE PRESBYTERY OF TORONTO.

The Synod took up a Protest and Appeal of John Robertson against a judgment of the Presbytery of Toronto, of date 15th November 1859, refusing to interfere with the mode of conducting the public psalmody of the congregation of St. Andrews Church, Toronto, with the aid of a melodeon. The documents having been read, parties were called. Mr. Robertson appeared for himself and Rev. James Bain and Dr. Barclay for the Presbytery, and having been heard at length they were removed. The Synod defer their deliverance till to-morrow morning.

The Synod adjourned to meet in this place tomorrow morning, of which public intimation was made, and this diet was closed with prayer.

# DIET IV.

At St. Andrew's Church, Kingston, Saturday, the Second Day of June, Eighteen Hundred and Sixty Years :-

Which day the Synod of the Presbyterian Church of Canada in connection with the Church of Scotland met according to adjournment and was constituted; devotional exercises were conducted by the Rev. James Gordon; and the minutes of yesterday's proceedings were read and sustained.

The Synod proceeded to give judgment in the case of John Robertson against the Presbytery of Toronto. It was moved by Dr. George, seconded by A. Mann ,- That the use of musical instruments in the worship of God is not warranted either directly or indirectly by anything contained in the New Testament or by any evidence furnished by the practice of the Church in Apostolic times and throughout many hundred years thereafter, that the use of musical instruments in this way is positively condemned by the uniform practice of the Church of Scotland ever since the period of the Reformation, and by the Act of the General Assembly, 1707, against innovations in the public worship of God-which Act all ministers of this Church have solemnly promised to obey -as well as by the practice of the other Presbyterian Churches in Scot-

... That all the ministers of this Church be earnestly recommended land; the instrumental music in the service of the sanctuary, so far to preach on the second Sabbath of February in each year, or the first from being essential or subservient to a healthy devotion, is both unnecessary and pernicious, and any encouragement given by this Synod to its continuance by one congregation, or its introduction by others, would assuredly be exceedingly offensive to many office-bearers and members of this Church, and would likely be productive of painful heart-burnings and serious divisions, Therefore the Synod resolve to sustain the Appeal, and issue this their injunction to the Session of St. Andrew's Church, Toronto, to cause the musical instrument which has been for some time in use in that Church to be removed without unnecessary delay after this date, and enjoin the Presbytery of Toronto to see this decision carried into effect.

> It was moved in amendment by G. Zell, seconded by R. Dobie, That whereas a prudent and becoming use of musical instruments in worship is not prohibited in the word of God, and the standards of this Church, and it appears that the Session of St. Andrew's Church, Toronto, have acted with prudence in this matter, the Synod dismiss the Appeal of Mr. Robertson and sustain the decision of the Presbytery of Toronto in so far as it sustains that of the Session.

> It was also moved in amendment by G. Neilson, seconded by A. Mitchell, That the finding of the Presbytery of Toronto against which

> Mr. Robertson has appealed be sustained. The first amendment was carried against the second by a vote of 5 to

> 3, and the motion against the first amendment by a vote of 36 to 7.

The Moderator declared accordingly.

A question of order having arisen, it was moved by R. Dobie, seconded by A. Mitchell, That any members of the Presbytery of Toronto who please be permitted to enter their dissent. This motion was lost on a

vote of 35 to 14. Against the finding of the Synod, George Bell, Robert Dobie, William

Johnson, William C. Clark, James McEwen, Frederick P. Sym, and Alexander Mitchell dissented, because.

- 1. In the opinion of the dissentients a prudent use of instrumental music in worship is not contrary to the word of God or the standards of this Church.
- 2. The deliverance of the Synod makes a fundamental change in the constitution of this Church and requires a new and hitherto unknown term of communion, such change being made by the Synod without a single Overture asking for it or any reference of the matter to Presbyteiers, and that in the constrained absence of the largest Presbytery of the Church.
- 3. The Appeal has, in a great measure, been decided by the Synod not on the true merits of the case of St. Andrew's Church, Toronto, which was the case in review, but with reference to evils which are alleged to flow from instrumental music improperly employed by others in a totally different way and for a different purpose.

4. The reference to the Act of Assembly, 1707, is irrevelant, musical instruments not being so much as mentioned in said Act.

5. While the dangerous consequences assumed as to follow from encouragement given by the Synod, would only follow from gross imprudence on the part of Sessions, the deliverance of the Synod is exceedingly offensive to the dissentients, and is directly calculated to produce painful heart-burnings and serious divisions.

6. The deliverance is a very serious innovation, which, if carried out, would annihilate the inherent right of Kirk Sessions to regulate the worship of congregations in accordance with the word of God, and the

standards of the Church.

7. It is ultra vires of the Synod to enjoin the Session as a spiritual Court to order the removal of the furniture of a church, the management of which of right belongs to a body of temporal office-bearers.

8. The allegation that instrumental music "so far from being essential or subservient to a healthy devotion is both unnecessary and pernicious," is contrary to fact in so far as the experience of St. Andrew's Church, Toron's, is concerned, who have found and still declare its use to be in a high degree helpful to devotion, and it is submitted that the opinion of those who speak from a lengthened experience of its advantages is entitled to the greater respect, they being better fitted to furnish reliable testimony on that point, than those who speak from mere theory, or a very limited acquaintunce with its use.

Dr. Mathieson adhered to the Dissent for the 1st, 2nd, 3rd, 4th, 5th, 6th, and 7th reasons, Dr. Muir, Professor Mowat, James Sieveright, and

Archibald Walker, for the 1st, and Archibald Barker for the 5th.

George Macdonnell, John Davidson, William Bain, Dr. Urquhart.

Kenneth Maclennan, George Neilson, and Alexander Morris dissented, because,

- 1. Though the aim of the motion which has been carried in the Synod be a proper one, it is set forth upon grounds not expressly authorized by the Word of God, and by the constitution and standards of the Church of Scotland and of this Church.
- 2. In consequence of the extreme view taken in the preamble of the motion, the decision is less likely to commend itself to the judgment of the Church than if it had been surer and milder.
  - 3. The only grounds upon which this Syno dcan object to the intro-

#### TEMPORALITIES FUND !

The report of the Committee on papers from the Temporalities Board having been called for was read by Dr. Cook, Convener. It was moved by Judge Logie, seconded by G. Neilson, and unanimously resolved, That the Synod approve of the report as ample and satisfactors, and they appoint the Moderator to convey to the chairman and members of the board, their cor hal thanks for their careful and judicious management of the trust committed to them. The Synod observe with much satisfaction the zeal and diligence of the Board, and of the members and office-bearers of the Church, who co-operated with the Board in commencing and prosecuting the Home Mission Scheme of the Church; and also the prompt liberality with which rich and poor have contributed to this Scheme, in the congregations whose subscriptions have been reported. They trust the Board will, as they propose, continue to prosecute this Scheme with energy and perseverance, and that with the blessing of God it may, over all the land, be attended with a like measure of success. Smith, a Minister of the Old School Presbyterian Church in the United States be declared eligible for a charge in this Church, and that Presbyteries be authorized to receive and settle him according to the rules of the Church, if he shall obtain a call, and that the standing rule requiring one year's previous service be in his case dispensed with.

The Committee further recommended that James Douglas, Student of Divinity, shall in his peculiar circumstances, in lieu of the last regular session in the Divinity Hall, be permitted to study under Dr. Cook during the summer months, and during the wirter follow a course of study to be prescribed by Dr. Cook, and in the event of his doing so he shall be eligible to come before the Examining Committee next year with a view to License. # MAINTENANCE OF MINISTERS.

The report of the Committee on the maintenance of ministers having been called for was read. It was moved by J. Greenshields, seconded by J. Cameron, that the following recommendation be transmitted to Presbyteries as an interim Act, with instructions to report to next Synod, and Presbyteries not reporting shall be considered as approving.

HAT in every case where the settlement of a Minister is about to take place, it is absolutely necessary that the minimum stipend, exclusive of any allowance from the Temporalities Board, be not less than four hundred dollars; that Presbyteries be enjoined to do all in their power to see that the congregations within their respective bounds, implement all pecuniary promises made by them to Ministers; and that the Sy nod retain all discretionary power in its own hands.'

It was moved in amendment by G. Neilson, seconded by W. Miller, That inasmuch as the stipends of a large number of the Ministers of this Church are madequate for their maintenance in a position becoming their office, and as Ministers hereafter to be settled may be to a larger extent dependent upon the people for support, the Synod determine that in the settlement of any Minister, Presbyteries shall use their influence with congregations to induce them to insure, if possible, a stipend which, together with the allowance from the Temporalities Fund, shall be not less than two hundred pounds currency; and that Presbyteries be strict-

William Barr to the charge of Wawanosh on a bond for stipend amounting to only one hundred dollars, and the Rev. Francis Nicol to the charge of London, without any provision being made for his support; that in the Records of the Preshytery of Glengarry, the Christian names of members of sederants are not recorded, nor the Christian names of parties when mentioned in the mi-

cords of the Presbytery of Hamilton show that the Records of the Kirksession of St. Andrew's Church, Hamilton, were produced to the Presbytery and examined by them; and explanations having been given, the Synod instruct the members of this Court appointed to meet with the Presbytery of Hamilton on the third Wednesday of July next, and when sitting with said Presbytery, to call up the Records of that Session and see that all reference therein to the case of Colonel Macdougall be deleted. The Synod's attention was also called to a minute in the Records of the Hamilton Presbytery, page 341, reflecting upon the character of certain statements made by a member of that Court, on the occasion of the induction of the Rev. David Stott to the charge of Brantford, and the Synod ordered the said minute to be deleted. The Synod enjoins Presbyteries to attend to the foregoing notes and make corrections as far as possible, and with these remarks the aforesaid Presbytery Records are ordered to be attested by the Clerk.

# SARBATH SCHOOLS.

The report of the committee on Sabbath Schools was read by G. Macdonnell, Convener. It was moved by J. Gordon, seconded by J. S. Douglas, and unanimously resolved,—That the Synod in reappointing the committee thank them for their diligence, and rejoice to hear of the growing interest felt in this important scheme; enjoin Kirk-sessions to give faithful attention to this matter; instruct Presbyteries to take order that the various members attend to the injunctions of Synod on this subject, and earnestly commend it to the serious consideration of the members of the Church.

# UNION WITH OTHER PRESBYTERIAN CHURCHES.

The Synod heard an Overture from Dr. George on a union between this Church and other Presbyterian Churches in this Province. It was moved by the Rev. J. Macmurchy, seconded by D. Watson, That it is unwise and would be perilous to the harmony and peace of this Church to entertain the Overture at present. It was moved in amendment by G. Bell, seconded by A. Stirling, That a Committee consisting of Dr. George, Convener, Dr. Cook, Dr. Urquinari, G. Bell, D. Morrison, A. Morris, J. Greenshields, and G. Neilson, be appointed, to consider the subject and to be ready to meet with brethren belonging to the other Synods to ascertain their views and feelings on the matter, and report to next Synod. It was also moved in amendment by J. Gordon, seconded by J. Daridson, That the Synod express their approbation of the sentiments contained in the Overture, but inasmuch as they have had no official expression of the sentiments of the other Presbyterian denominations on this most important matter, that the memorial do lie on the table. The first amendment was carried against the second by a vote of 35 to 12, and the first amendment against the motion by a vote of 31 to 17. The Moderator declared accordingly. From this deliverance, Rev J. Macmurchy, J. Campbell (Nottawasaga), J. S. Douglas, H. Niven, and D. Watson dissented, because (1) the motion for union should come from the Dissenters, and not from this Synod; (2) as we are successfully establishing our Church upon an endowed basis, we view it as a forsaking of our principle to seek union with pure voluntaries; (3) it is calculated to endanger the successful progress of the Home Mission Scheme . (4) the hodies with which union is sought have tampered with standards which we solemnly hold sacred and Scriptural; and (5) the contemplated union would be dangerous to our harmony as a Church.

### SARRATH ORSERVANCE.

A report from the Committee on Subbath observance was submitted by W. Bain, Convener. The Synod unanimously resolve to receive and adopt the report; re-appoint the Committee and request them to continue their exertions in this truly Christian and praiseworthy effort; and approve of the suggestions regarding Railways, in the hope of a successful issue to their endeavours.

ADDRESS OF THE MODERATOR, THE REV. A. MATHESON, D. D., &c.

REVO. PATREES AND BESTHERS, M'NISTERS AND ELDERS OF THE PRESENTERIAN CHURCH OF CANADA IN CONNECTION WITH THE PENERABLE THE CHERCH OF SCOTLAND, MERRERS OF THE

It is now my duty in conformacy with the uniform practice of this Court to address to you a few general exhortations at the close of our proceedings. They shall be very few, for the honour you have conferred on me in elevating me to the chair, which I have so unwarthily filled, was so unexpected that I had made no preparation for the proper discharge of its duties, and these have been so incessant that I have not had a moment either to arrange or mature my thoughts on any subject of general interest. I fling myself on your indulgence, which in the course of our proceedings has been so largely extended to me, and coase that you will receive with lement commeration the exhartations which from the folness of my beart I now beg leave to offer

But, previous to entering on this dury permit me to return to you my warmest thanks for the honor you did me in unanimously choose ing me to preside over your deliberations as your Moderator, and for the kind support you have given me in sastaining the order of this

Twenty-eight years ago, by the kindness of my Brethren, I had the honor to occupy the chair which I now fill I could not therefore expect that your partiality would have called me a second time to discharge its honorable and important duties. The circumstances that have directed your attention to me at this time are such as enhance the favor, and render more than my thanks due. I esteem the distraction to warch you have raised me as the highest honor of my life. I appreciate your respect, I thank you for it. And I trust I shall ever retain a grateful recollection of your kirdnesi.

I have not the vanity to suppose; of my debcienerce no one has a deeper sense than I have myself, but my endeavour has been to act faithfully and with the strictest impartiality. Thave reviewed my conduct in this chair, and acknowledge that there are many things which might have been better done, some timt ought to have been otherwise done and some that would have been better left undone. For these errors and defects I claim your indulgence, but, conscious that my aim has been to not fairly and to the best of my abilities, I am not aware that for a single word or act I have to crave your forgiveness.

Rerd. Fathers and Brethren-You have brought the business of this Synod to a conclusion. It does not become me to express an opinion on the decisions to which you have come, or the legislative measures you have enacted. With some of these I have cordially concurred From others I have conscientionals differed. My prayer is that, overraled by the Supreme Head of the Church, they may alike advance the spiritual comfort and prosperity that I have discharged my daties perfectly tof llusown people, and redound to the glory of His name. In every convocation, constituted as this Synod is, differences of views and dirersity of opinions will preeseatily arise.

And, if in the course of discussion there may have occurred a warmth of feeling and an terruption to the full flow of your generous sympathies as Brethren. If warmth of feeling and keenness in debate Is any where allowable, it is surely in the discussion of the great ques-tions that involve the prosperity and peace of the Church on earth, and the fittest means for preparing the children of God for their inheritance in heaven. All the higher and nobler! principles of our nature are brought into oneration. Conscience is quickened. Zeal is inflamed. Concentrated energy is put forth, and, if Christian charity does not largely prevail, does not not as a moderator in every breast, in the conflict of opinion a want of harmony and an unseemly departure from the courtesies and decorum of social life may disgrace deliberations that ought to be conducted in love and in peace. The Odium Theologicum, the asperity of which has acquired unenviable notoricty, may spread its withering breath over brethren dwelling together in unity.

Suffer me to congratulate you, my Brethren on the mutual forbearance and kindly dispositions evinced by every one of you in your deliberations, and the warm sentiments expressed for the religious prosperity of all men, especially those who are of the household of faith. If there has been warmth of language, I am persunded it flowed from the impelling convictions of truth. If there was ardour of feeling, it spring from principle, not from passion. If there was burning zeal it was pure and disinterested, unmixed with vanity, ostentation or selfishness.

Inadequately, Lirregularly paid, he is too often driven from a field where his affections centred, and they are left without the regular administration of Divine ordinance, or to find a successor whose qualifications seldom rise above the miserable pittance they bestow. It is the natural effect of the voluntary system that the ability of the labourer is generally in proportion to the price paid for his work. In a worldly-minded age such as this, and where men are so indifferent to their true interests, that they must be pressed into the Ringdom of Heaven, there can be little expectation that under such a system Religion will flourish, or the knowledge of the Gospel be greatly extended.

They that serve at the altar shall live by the altar. That they may wholly devote themselves to their work, their maintenance must be adequate, and statedly and regularly paid. It is mournful enough to be obliged to confess that in this country, and especially in the rural congregations, this has seldom been done. Of the alleged causes, some may have been unavoidable, but surely with a deeper sense of responsibility and more system this might have been ameliorated. A movement in a right direction has from necessity been forced on the Church. The secularization of the Clergy Reserves, which the enemies of our Church imagined would be fatal to her very existence in these Provinces, has aroused the slumbering energies of her people. A noble scheme, arising out of the ecclesiasticism and liberality of the commuting ministers, has been entered on, and nobly responded to by the people, in so far as they have yet been called upon, and, I have no doubt, will meet a general response throughout its, and despairing of success, he neglects his the whole Church. The Report from the Temporalities Board is most cheering. It develops a plan for supplementing the stipends of Ministers, wisely and carefully concocted and spiritedly begun, and, if carried into execution with the judicious energy which has marked its commencement, it cannot fail to set all the institutions of the Church on a more stable foundation and a better working order.

The Report from the Board of Management of the Ministers' Widows' and Orphans' Fund is also very gratifying. The progress of the Scheme has been slow, but onward and steady. If the minds of Christian people were universally awakened to the importance of this Scheme and the influence it indirectly has on their own spiritual advancement, it would be soon put on a foundation so secure and stablished as would allow the congregational contributions, that now flow into it, to be devoted to some other plan of practical benevolence. The Ministers' Widows' and Orphans' Fund and the Home Mission Fund I hold to be two of the most important Schemes in The hardships and privations incident to which the Synod is engaged. They are, under new settlements have hitherto prevented and God, the external bulwarks of the Church, and,

the executive department of our Church polity can be wisely, prudently and economically carried out. The work of these committees has been ardnous. They have amassed an amount of information truly valuable. It belongs to the Synod not to leave their labours fruitless but turn them to some practical purpose in settling and confirming the institutions of the Church.

The Reports on the Observance of the Sabbath and Sabbath Schools, are also of a highly interesting nature. It is a ground of thankfulness to Almighty God that He bath put it into our hearts to take up these subjects, and assign them a prominent place among the matters that annually occupy the attention of the Synod. The consecration of the Sabbath will be regarded as a matter of the utmost moment by every one who wishes the prosperity of the Church and the salvation of immortal souls. Lying at the foundation of morals, as well as of Religion, we cannot hope for the blessing of God, nor for the material prosperity of the land, nor for the spread of godliness where the Day of the Lord is descerated. The mournful history of many nations warns us of the fatal consequences of Sabbath profauation. As guardians of public morals, as servants of the Lord Jesus Christ, it is peculiarly the duty of Ministers and Elders to stand in the dignified position of watchmen in Israel and cry aloud that the Sabbath is the "Lord's day, and not man's. It is peculiarly their business to put forth the most strengous efforts to pro-mote the peace and security of her people by promoting the sanctification of the Sabbath.

There is no duty more important, more interesting, more hopeful than that of preparing a people for the Lord. Nothing more delightful than in the accomplishment of this work taking theyoungand leading them gently to the Saviour. In this country, where Ponish intolerance and Sectarian bigotry would exclude from common Schools the lible as a class-book, it becomes more eminently the duty of this Synod and especially the Ministers of the Church to take care that the principles of the Christian religion be taught to the young, who are under their pastoral care purely from the word of God. The duty of training up children in the nurture and admonition of the Lord is by the Almighty committed to parents. Though no kind of religious instruction whatsoever will compensate for the want of parental training, yet it is a subject of encouraging hope that by well managed Sabhath Schools much good may be done. In the important work of the religious education of the young it is a matter for thankfulness, that the Synod has wisely, and, we would hope, with much advantage placed Sabhath Schools asan auxiliary appliance among the useful institutions of the Church. Not only to the neglected children of ignorant and vicious parents would the Sabhath School prove an inestimable blessing but the advantages must be great to the children of those who are faithful in the discharge of their parental duties. The early associations and the habits formed in the Sabbath School leave on the minds of children a lasting and practical apprehension of the lessons they receive. The minds of the young men and women who devote a part of their time to teaching in the Sabhath School will be expanded, and their views of Divine truth will be greatly enlarged, by the preparatory study of God's Word in which they engage. But there is much danger, arising from the popularity of these institations, and the systematised form on which they are now conducted, that they supersede the Sabbath School in the House and the

to inculcate on the minds of parents their of the children you now instruct, He will bless duty to their children. They should be taught that they cannot shift responsibility from themselves by committing the work of religious instruction to another. No teaching awakens either such thoughts or leaves such devout impressions on the infant mind as that of a mother as she trains her child to kneel every evening by her side, and in sweetest tones of maternal love teaches it to say, Our Father, who art in Heaven, &c. Thoughts, holy and great and good, arise in the young mind-inadequate it is granted-but inadequate are the thoughts of the greatest intellect, when turned unto God, But the thoughts, awakening and struggling in the young mind into definite conceptions beneath such influences, are perhaps the loftiest, the purest that arise before the Throne of Jehovah. Out of the mouths of babes and sucklings hath He perfected praise-such ennobling influences should not be disturbed on any pretence whatsoever. The teaching of the Sabbath School should correspond to the teachings of the Household. They should be simple and full of heavenly love, and such as awaken a reverent interest in God's Word.

The teaching of the Sabbath Schools under our inspection ought to be confined to simplest instructions from God's Word, and committing to memory the Westminster Assembly's Shorter Catechismand some of the beautiful paraphrases of our Church and of the inimitable version of the Psalms-in fact by repetition and reiteration incorporating the truths of that admirable summary of Christian doctrine and duty with the mind, and making them the food for future thought and the principles for future action. Kirk Sessions should take the work under their immediate inspection. They should suffer no remarks to be made by the teachers except a few explanatory observations on the lessons of the day. Long harangues, which, I am sorry to learn, prevail in some Sabbath Schools, are injurious and defeat the object of the Institution. They weary and disgust the young mind.

Fathers and Brethren-I think it is well that you have committed the general superintendence of such an important work to a committee, who, I have no doubt, will carefully prepare such a plan of instruction, and will issue such directions, having first obtained your revision and sanction, as will guide both Ministers and Kirk Sessions to a uniform course and united action.

The Jewish Mission Scheme and the Indian Orphanage Scheme are the beautiful efflorescences of your charity wreathed around the nobler columns, may I be permitted the expression, of your Home Mission Schemes. In the Children's Mission to the Orphan Children of India there is a character of beauty and simplicity which it is delightful to contemplate, awakening, as it must do, in the hearts of your own children a Christian interest in the condition of the heathen brothers and sisters of the same tender years, and cherishing in their hearts the spirit of benevolence and love towards these benighted Gentile children. Your Child's Mission must be effectual for good, even though your Indian schools do not prosper, thought not one convert be made to the faith of Christianity, though no religious inquiry be awakened. Still you are doing a great and a good work, which the great Head of the Church in His own good time will bless. You are not only refreshing with the waters of life the arid wilderness, scattering the good seed of the Word, where some will find lodgement in the heart and spring up, but you are also refreshing the springing crops in the better cultivated portions of the Lord's vineyard. But it

Fathers, brethren and elders, to these and other matters for the good order and extension of the Church, that have been brought under your consideration, you have given much of your time, and have now brought the business of this Synod to a conclusion. You are now about to return to your houses, your families and your flocks, and to engage again in the great work to which these measures are only subservient. Your special work is to preach the Gospel of the Lord Jesus Christ and to diffuse a pure, a healthy, an enlightened religion throughout the land. This is the most important work that can be committed to you, and your responsibility in the execution of this trust is in proportion to its excellency. this conviction be an abiding principle of your conduct, cherish it, act upon it, and you will be drawn from all dependence on yourselves to lay hold on the arm of Him who can sustain you. Well might you tremble in consideration of the magnitude of the work, and in view of the interests you are called to promote. "Who is sufficient for these things," might well exclaim with the apostle to the Gentiles. But in consideration of the heavenly aid promised you, and the all-prevailing cooperation of the Spirit given unto you, if you prayerfully ask it, you can also say with Paul and say it with all confidence: "Through Christ Jesus I can do all things." The very responsibility of your offices becomes a powerful stimulus to exertion. And the illuminating, strengthening, guiding influences of the Holy Spirit are an animating motive to be faithful in season and out of season in prosecuting the duties of your high and holy calling. With this heavenly power through your instrumentality operating on the Church, I need not dwell on the discouragements of your condition or the difficulties of your work. Greater is He that is for you than all that are against you, and by the exercise of a living faith you will be more than conquerors.

It is a general impression, but it is a very erroneous one, that the life of a minister of the Gospel is a life of case, of comfort and enjoyment, that he has little else to do than to appear in the pulpit one day in seven, deliver a short discourse, and, while others in the sweat of the brow eat the bread of carefulness, he can walk abroad when he pleases, enjoy the beauties of nature and the luxuries of life. Every one of them who is faithful to the duties of his office can tell a different tale. It is not, as is generally supposed, the labour of one day in the week that is exacted and the recompense and respect, due to the most dignified servant, that is always bestowed; nay, it is sometimes contempt for his ministrations and indifference to the messages he brings, aggravated by poverty and neglect. His life is a ceaseless round of anxiety and care. Besides much study, which is a weariness of the flesh, there are a thousand little things that must be attended to, which exhaust his spirits and wear down his strength. Even Sunday shines no holiday to him. That day, though it has its toils, and is distinguished by an intensity of mental anxiety into which few can enter, has at the same time its calm and holy preaching of God's word by His constituted is a matter for derout thankfulness that the pleasures that render it to him as well as to Ministers. These are divinely appointed ordi- Giver of all good has in some measure blesses, others, comparatively speaking, a day of rest. His labours, though in a great measure hid to remind you that you are under the most from public view, are nevertheless incessant solemn obligations to give yourselves and from public view, are nevertheless incessant and fatiguing. Who, but those who have experienced them, can form a right conception of the overwhelming feelings that arise from a just sense of the responsibility that is attached to the care of immortal souls? Who can estimate the weight and importance of the duties imposed on him who has the riches of Divine grace committed to him, that he may dispense them to a perishing world, as a minister does who trembles under a sense of his insufficiency for these things? Who can enumerate the diversified cares and anxieties that harass them, and the distractions of thought to which they are continually liable, the disappointments of hope which they constantly experience, the frequent trials to which they are subjected that result from the indifference of some and the opposition of others to the great truths they proclaim, and the disrespect shown both to them and their office by many who should honor them highly for their work's sake. These are trials of minor importance but they are hard to be borne. It is far from a light burden that a minister bears. It is far from a tranquil and easy mind that he carries about with him. Even amid the innocent engagements of life there is an under current of secret anxious thought silently and slowly wasting and wearing the soul. The very recreations, which are necessary to recruit the worn and weary frame, and renew the exhausted mind, are often attended with circumstances that tend to vex and annoy minds that education and refinement have made more keenly alive to such trials. To the common trials of life they have many peculiar to themselves, which gives the language of the apostle in reference to his ministerial labour peculiar weight and meaning,"I travail in birth again until Christ be formed in you."

But, though a Minister has his trials peculiar to himself, he has also his joys, with which "a stranger intermeddleth not." These sustain and support him amidst many hours of weakness and Liguing thought. He has One mightier than all others ever near him to strengthen and encourage him. Endeavour to realise His promise, "Lo, I am with you all ways." Take courage, Brethren, and go forth to the discharge of your duties in His sustain-ing strength. Think of His exalted nature—on the greatness of His work-on the intensity of His love for man-for those very beings He has committed to your special care. Endeavour to have a just sense of the honor He has conferred on you in making you fellow-workers with Himself in bringing many sons into glory. These reflections, lovingly and prayerfully cherished, will animate you with the purest zeal and the highest Christian motives. Before the ministrations of the Gospel can be well sustained or effective, you must be constrained by the love of Christ. There must be love to God-love of the Gospel-love of souls-love for one another. Animated by love, and sustained by constant ferrent prayer, you will go forth to your work with alacrity. You will prosecute it exmestly-and you will be rewarded by seeing the work of the Lord prospering in your hands. Brethren, to God and the Word of His grace I commend you.

Brethren in the Eldership, one word to you before I have done. You occupy a most important station in the Church of Christ. You form the links of connection between Pastors and people. Your peculiar duties relate to both—and your influence extends to both for good or for evil. By your council and your agency you may mightily strengthen the hands of your Ministers and promote the prosperity and peace of the congregations over whom Dr. Rowand, "God hath given you to bear rule.
