

FREDERICTON,

TUESDAY, the 4th day of FEBRUART, 1812.

THE GENERAL ASSEMBLY having been prorogued by several Proclamations until this day, then to meet for the despatch of business: The House met, when a sufficient number of Members to proceed to business, not attending, the House adjourned until to-morrow at 12 o'Clock.

WEDNESDAY, the 5th day of FEBRUARY, 1812.

It appearing by the return of the Sheriff of Westmorland, that *Titus Knapp* and *James Easterbrooks*, Esquires, have been duly elected to serve in General Assembly: It is Ordered that Mr. *Wetmore*, and Mr. *Chapman*, be a Committee to attend the Commissioner, and see the said returned Members duly qualified. Mr. *Wetmore*, and Mr. *Chapman*, being returned report that, they have attended the Commissioner with Mr. *Knapp*, and Mr. *Easterbrooks*, and that the Oaths prescribed by law have been duly administered to them; upon which Mr. *Knapp* and Mr. *Easterbrooks*, took their seats.

It appearing, also, by the return of the Sheriff of King's County, that, George Leonard, Junior, and Jasper Belding, Esquires, have been duly elected to serve in General Assembly in the room of John Coffin, and George Pitfield, Esquires: It is Ordered, that Captain Agnew, and Mr. Campbell, do attend the Commissioner, and see the said Members duly qualified.— Captain Agnew reports, that the Committee appointed for that purpose have attended the Commissioner, and that the usual Oaths have been duly administered to George Leonard, Jun. and Jasper Belding, Esquires; upon which Mr. Leonard and Mr. Belding took their seats.

Xenophen Jouett, Esquire, Gentleman Usher of the Black Rod, delivers the following Message:

"His HONOR the PRESIDENT requires the attendance of this Honora-"able House in the Council Chamber,"—upon which the House immediately attended His Honor in the Council Chamber : and having returned : Read a first time a Bill for the better regulating the Registry of Deeds

The Speaker then reported that the House had attended His Honor the PRESIDENT in the Council Chamber, and that he was pleased to make the following Speech to both Houses, a copy of which he read in his place, and is as follows:---

Gentlemen of the Council, and

" Gentlemen of the Assembly,

"In addition to the ordinary provisions for the public service, which at this time require your meeting in General Assembly, I have now again to recommend to your most serious consideration the importance of making such arrangements as may be requisite for our defence against the hostility with which we are threatened.

" If our neighbours did but know their own true interest, it is indeed ob-" vious that instead of assuming from time to time, a menacing aspect, they " would long since have made a common cause with Great-Britain as the " only remaining bulwark against the progress of that military despotism " which has already desolated the greatest part of Europe, and continues " to threaten the subversion of every independent State within the reach " either of open invasion or treacherous delusion. But experience proves " that nations as well as individuals, may be misled to their own ruin by the " united influence of prejudice and passion. When therefore we see these " combined against us, we have nothing further to ask, than how may we " most effectually prepare for our security. By due preparations for reso-" lute defence, we may contribute to prevent that hostility, which otherwise " our supineness might invite. But if not, to be at times so prepared as not " to be taken by surprise, especially in these eventful days, is the first duty " of every people possessing the happy constitution which we inherit. In " this view of our present situation, I cannot but anticipate your best efforts " not only to give every legal aid in your power for the more perfect regu-" lation of our Militia, but also to provide; to the extent of your ability, for " defraving a part of the expense that may be incurred in the defence of " this Province, while the enormous weight of the national expence presses " so heavily upon the mother Country. By such a mark of zeal and pub-" lic spirit, we may justify our confidence in that support, on which in all " events we must rely-

"His MAJESTY'S Order in Council giving the Royal Assent and Approbation to the Act, passed during the last Session in addition to the Law for regulating Elections of Representatives in General Assembly in this Province, has been transmitted to me and shall be laid before you.

" Gentlemen of the Assembly,

"A statement of the public accounts, with such other documents as may be requisite for your information shall be laid before you. You will see that, in the improvements made on the Road from Fredericton to Saint John, an expence of about sixty pounds has been incurred, beyond the amount appropriated for that service, for which I doubt not your readiness to make provision.

" Gentlemen of the Council, and

" Gentlemen of the Assembly,

"While we have cause to lament the continuance of that war of ambition and usurpation, which has desolated so many Countries, I have the satisfaction to congratulate with you on the splendid achievements, which also continue to add fresh lustre to His MAJESTY's arms, and to sustain the national character in every part of the world."

On Motion of Captain Agnew, Resolved, that an Address be presented to His HONOR the PRESIDENT, in answer to his Speech. Ordered, that

Captain Agnew, Mr. Campbell, Mr. Allen, and Mr. Leonard, be a Committee to prepare the same.

The House in Committee, Mr. Peter Fraser in the Chair;—went into consideration of His HONOR the PRESIDENT's Speech. The Speaker resumed the Chair, and the Chairman reported progress; and that the Committee were of opinion, that a Committee should be appointed to examine what Laws are near expiring. Whereupon Ordered, that the consideration of His HONOR the PRESIDENT'S Speech be postponed until to-morrow; and that Mr. Wetmore, Mr. James Fraser and Mr. M. Donald be a Committee to examine what Laws have lately expired, or are near expiring.

The House then adjourned until to-morrow morning at 10 o'Clock.

THURSDAY, the 6th day of FEBRUARY, 1812.

PRAYERS.

The Committee appointed to inquire what Laws have expired or are near expiring, report that, an Act for regulating, laying out, and repairing Highways and Roads, and for appointing Commissioners and Surveyors of Highways, within the several towns and parishes in this Province.

And an Act for better regulating the Militia in this Province.

And an Act to continue an Act, intituled "An Act for raising a Revenue in this Province," will expire on the fourteenth day of the month of March next.

Mr. Campbell moves for leave to bring in a Bill to continue and amend an Act, intituled, "An Act for better regulating the Militia in this Province," which is granted.

Ordered, that Mr. Robert Pagan, Mr. Easterbrooks, and Mr. Humbert, be a Committee to bring in a Bill to continue and amend an Act, intituled, "An Act for better regulating, laying out, and repairing Highways and Roads, and for appointing Commissioners and Surveyors of Highways within the several Towns and Parishes in this Province."

Ordered, that Mr. Peters, Mr. James Fraser, and Mr. Knapp, be a Committee to bring in a Bill to continue and amend an Act, intituled, "An Act for raising a Revenue in this Province," and an Act in amendment thereof.

The Committee, (Mr. Wetmore and Mr. William Pagan,) appointed at the last Session to join a Committee of the Council for the purpose of purchasing such books, &c. as might be deemed necessary ;—Report, that the joint Committee, not being able to procure the continuation of the Statutes at large, have purchased an entire set, in twenty-one Volumes, down to the forty-ninth year of the present Reign, inclusive, the first cost of which amounted to the whole sum granted for that service, and that the freight, insurance, and charges remain unpaid, and on Motion of Mr. Attorney General, Resolved, that the old Set of the Statutes at large be delivered to the joint Committee of the General Assembly, to be disposed of to defray the expences of importing the new set of the Statutes, and further to execute the order of the House. Ordered, that the above resolution be sent up to the Council for concurrence.

Mr. Humbert moves for leave to bring in a Bill to alter and amend an Act, intituled, "An Act for regulating Marriage and Divorce, and for preventing and punishing, Incest, Adultery, and Fornication;" which is read a first and second time, and ordered to be committed.

Captain Agnew, of the Committee appointed to prepare an Address in answer to His HONOR the PRESIDENT'S Speech, reported a draught thereof, which he read in his place, and the same being delivered and read at the Clerk's table—is as follows, viz.

To His HONOR Major-General MARTIN HUNTER, President of His MA-JESTY'S Council, and Commander in Chief of the Province of New-Brunswick, &c. &c.

The Humble Address of the House of Assembly: "May it please your Honor,

"The House of Assembly will pay immediate attention to the objects re-"commended in your HONOR'S Speech, not only in providing for the Or-"dinary Service of the Province, but in making the arrangements requisite "for the defence of the country.

"The House are sensible that the menacing aspect of their neighbors is "by no means calculated to promote their true interests, and they are "equally so that, the military despotism which has already desolated the "greatest part of Europe, threatening the subversion of the whole, can only "be restrained by the power of Great-Britain, exerted to preserve her own, and the remaining independence of the world. It is then much to be la-"mented that, the American Government have not made a common cause with us against the common enemy of mankind, and is a proof, not only of that treacherous delusion, practised against them, but of its unhappy influence over those passions and prejudices which have misled nations to "their ruin.

"It is the continuation of this hostile temper against us, which renders it "necessary now, to make effectual preparation for the security of the coun-"try; and the House acknowledge that, in times eventful like the present, "it is their first duty. They will therefore realize your HONOR's just anticipation of their best efforts for this purpose, with all the practicable resources of the country, not only in improving the Militia Law, but cheerfully incurring every expence the Province can bear.

"The House beg leave to assure your HONOR. how deeply sensible they "are of the enormous weight of the national expense, nor will they fail to "justify the confidence of the people in the support of the Mother Country, "by such previous exertions of their own, as may best entitle them to it.

"The House thank your HONOR for the communication of His MAJES-"TY's gracious assent to the Act in addition to the Law for regulating Elec-"tions, and that you will be pleased to order the same to be laid before them.

"The improvements in Roads, call upon the House for a public acknow-"ledgment of the exertions of your Hoxon in this particular, and which "they entreat you to accept, nor will they be unmindful to provide for the "expence incurred beyond the amount appropriated for that purpose.

"When the House contemplate the splendid achievements which continue to add fresh lustre to His MAJESTY'S Arms, they bow to the Divine Power, and reciprocate with your HONOR, all those feelings which must animate the breasts of Loyal Subjects."

And being read a second time, Resolved unanimously, that the same be engrossed and signed by the Speaker, and presented to His HONOE the PRESIDENT, by the whole House.

Captain Agnew, moves for leave to bring in a Bill, to amend an Act, intituled, "An Act to repeal all the Acts now in force relating to Trespasses, and for making new regulations to prevent the same;" which is granted.

Mr. Taylor, moves for leave to bring in a Bill, to amend an Act, intituled, "An

"An Act to explain and amend the laws now in force for regulating the exportation of fish and lumber;" which is granted.

Mr. Peters, from the Committee appointed to bring in a Bill, to continue and amend an Act, for raising a Revenue in this Province, and the Act in amendment thereof, reported the same, which was read a first and second time, and ordered to be committed.

Mr. M. Donald, moves for leave to bring in a Bill to regulate the Assize of Bread wherever the same may be found necessary in this Province; which is granted.

Mr. Campbell, moves for leave to bring in a Bill for laying certain duties, upon goods imported into this Province by persons not residing therein ; which is granted.

The further consideration of His HONOR the PRESIDENT'S Speech, is postponed until Saturday next.

The House then adjourned until to-morrow morning at 10 o'Clock.

FRIDAY, the 7th day of FEBRUARY, 1812.

PRAYERS.

Mr. Leonard presented a Petition from the Wardens and Vestry of the Parish of Norton, King's County, for themselves and in behalf of the said Parish, praying assistance towards finishing a Church, already begun, in the said Parish, which was read, and ordered to lay on the table.

Mr. Leonard presented a Petition from sundry inhabitants of the Parish of Hampton, King's County, praying some assistance towards enabling them to finish and complete a Church already erected in the said Parish; which was read, and ordered to lay on the table.

Mr. Leonard presented a Petition from sundry inhabitants of this Province, praying, that the third Section of the Act, intituled, "An Act for regulating Marriage and Divorce, and for preventing and punishing Incest, Adultery and Fornication," may be repealed; which was read, and ordered to lay on the table.

Mr. Peter Fraser, moves for leave to bring in a Bill to compel the attendance of the Justices of the Peace, at the several General and Quarter Sessions of the Peace, for the respective Counties of this Province; which is granted.

Mr. Taylor, moves for leave to bring in a Bill, to alter and amend an Act, intituled, "An Act against the profanation of the Lord's day, commonly called Sunday, and for the suppression of immorality;" which is granted.

The House in Committee, Mr. Robert Pagan in the Chair;—went into consideration of a Bill, to alter and amend an Act, intituled, "An Act for regulating Marriage and Divorce, and for preventing and punishing Incest, Adultery, and Fornication." The Speaker resumed the Chair, and the Chairman reported, that the Committee had made progress in the business teferred to them, and asked leave to sit again; which was agreed to by the House.

Mr. Attorney General, moves for leave to bring in a Bill, to authorise the Common Council of the City of Saint John, to appoint Constables for such wards of the City, as shall omit to choose the same ; which is granted. The House then adjourned until to-morrow morning at 10 o'Clock.

Mr. Leonard and Mr. Johnston, are appointed a Committee to wait on His Honor the PRESIDENT, to know when he will be pleased to receive the House with their Address.

Mr. Leonard, of the Committee, appointed to wait on His Honor the PRESIDENT, to know when he will be pleased to receive the House with their Address, reported, that His Honor the PRESIDENT, said he would receive the same this day at one o'clock in the Council Chamber.

The House in Committee, Mr. James Fraser in the Chair;—went into the consideration of the Bill to continue and amend an Act, intituled, "An Act for raising a Revenue in this Province, and an Act in amendment thereof." The Speaker resumed the Chair, the Chairman reported, that the Committee had agreed to the same, and had ordered him to report it, which was read as reported, agreed to, and ordered to be engrossed.

Mr. Robert Pagan, the Chairman of the Committee appointed to bring in a Bill to continue and amend an Act, intituled, "An Act for regulating, laying out, and repairing Highways and Roads, and for appointing Commissioners and Surveyors of Highways, within the several Towns, and Parishes in this Province," reported a draught of the Bill which was read a first and second time, and ordered to be committed.

Ordered, that the further consideration of His Honor the PRESIDENT'S Speech be postponed until Monday next.

The House waited upon His Honor the PRESIDENT with their Address in answer to His HONOR'S Speech, and being returned, Mr. Speaker reported, that the House had presented their Address, and that His HONOR was pleased to make the following reply, viz.

" Gentlemen,

" I thank you for this Address, which I receive with sincere satisfaction, being confident that the zeal and firmness which you now manifest, will contribute greatly to encourage and confirm that patriotic and loyal spirit, by which your Constituents have at all times been distinguished."

Mr. Campbell brought in a Bill for laying certain duties upon goods imported into this Province by non-residents, which was read a first and second time, and ordered to be committed.

Mr. Robert Pagan brought in, by leave, a Bill more effectually to prevent the encumbering or filling up of Harbours, and to authorise the appointment of Harbour Masters, which was read a first time.

The Committee of Correspondence, appointed by the House, laid sundry communications before the House, which were read.

Read a second time, a Bill more effectually to prevent the encumbering or filling up of Harbours, and to authorise the appointment of Harbour Masters, and ordered to be committed.

The House then adjourned until Monday morning next at 10 o'Clock.

MONDAY, the 10th day of FEBRUARY, 1812.

The House in Committee, Mr. M'Donald in the Chair;-went into the consideration of the Supplies to be granted to His MAJESTY for the Public The Speaker resumed the Chair, and the Chairman of the Com-Service. mittee reported, that the Committee had made some progress, and begged leave to sit again.

Ordered, that Mr. Attorney General and Mr. Leonard, be a Committee of this House, to deliver the Resolution of this House, of the sixth day of this instant February, respecting the disposal of the old Statutes at large, to the Council.

The Treasurer's Accounts, by order of His Honor the PRESIDENT, were laid before the House.

Mr. Leonard, Mr. Peter Fraser, and Mr. Robert Pagan, are appointed a Committee to examine the Treasurer's Accounts.

Mr. Leonard, by leave, brings in a Bill to provide for the due notification to the several Town or Parish officers in this Province, of their appointment to their several and respective offices, which is read a first time.

Mr. Peter Fraser brings in a Bill to compel the attendance of the Justices of the Peace, at the several General and Quarter Sessions of the Peace, for the respective Counties of this Province, which is read a first time.

Mr. Allen moves for leave to bring in a Bill to regulate Winter Roads in the Counties of York and Sunbury; which is granted.

The House in Committee, Mr. Campbell in the Chair, went into consideration of a Bill to continue for a limited time, an Act, entituled, " An Act for regulating, laying out, and repairing Highways and Roads, and for appointing Commissioners and Surveyors of Highways, within the several Towns and Parishes in this Province."-The Speaker resumed the Chair.

The Honorable Mr. Odell, with a Message from the Council, informed the House that, the Council concurred, with this House, in the resolution this day, sent up by Mr. Attorney General and Mr. Leonard.

The House again went into Committee on the Bill to continue for a limited time, "An Act for regulating, laying out and repairing Highways, &c."

" MESSAGE to the HOUSE of ASSEMBLY.

" The PRESIDENT directs to be herewith laid before the House of Assem-" bly, sundry returns which have been made by persons intrusted with the " expenditure of monies granted for Roads and Bridges. " M. H."

The House in Committee, Mr. James Fraser in the Chair, went into consideration of a Bill to amend and continue for a limited time, an Act, intituled, "An Act for better regulating the Militia in this Province." The Speaker resumed the Chair and the Chairman reported that the Committee had gone into the consideration of the Bill before them, and had made some progress, and asked leave to sit again, which the House agreed to.

Ordered that, Mr. Robert Pagan, Mr. Johnston and Mr. Allen, appointed last Session a Committee to examine and liquidate sundry accounts, be a standing Committee, to examine, liquidate and report on all public and private accounts presented to this House.

The House in Committee, Mr. Leanard in the Chair, went into consideration of "A Bill more effectually to prevent the incumbering or filling up of Harbours, and to authorize the appointment of Harbour Masters."— The Speaker resumed the Chair, the Chairman reported that the Committee had gone into consideration of the Bill and had agreed to the same, which being read as reported, the House agreed to the report and ordered the said Bill to be engrossed.

The House in Committee, Mr. M: Donald in the Chair, went into the further consideration of the supplies to be granted to HIS MAJESTY, for public services. The Speaker resumed the Chair, and the Chairman reported that the Committee had come to the following resolutions, and that they asked leave to sit again.

Resolved that, the following sums be allowed and paid out of the Province Treasury, to the following persons, viz:

To the Speaker of the House of Assembly, the sum of fifty pounds.

To the Members of the House of Assembly, for defraying the expenses of their attendance during the present Session, and for travelling charges, reckoning twenty miles for each days travel, to be certified by the Speaker; ten shillings per diem.

To the Chaplain of the Council in General Assembly, the sum of twenty pounds.

To

To the Chaplain of the House of Assembly, the sum of *twenty pounds*, and the further sum of *five pounds*, for travelling charges.

To the Clerk of the Council in General Assembly, the sum of *fifty pounds*, and *fifteen shillings* per diem during the present Session.

To the Clerk of the House of Assembly, the sum of fifty pounds, and fifteen shillings per diem during the present Session.

To the Serjeant at Arms, attending the Council in General Assembly, fifteen shillings per diem during the present Session.

To the Serjeant at Arms, attending the House of Assembly during the present Session, *fifteen shillings* per diem.

To the Door-Keepers and Messengers attending the Council and Assembly, seven shillings and sixpence per diem each, during the present Session.

E-Jacob S. Mott's account for printing Journals, amounting to $\pounds 59$: 11:S, of which $\pounds 30$, has been paid by a grant of the last Session leaving a balance of $\pounds 29:11:3$.—Which report was read.

A Message from His Honor the President, by Xenophen Jouett, Gentleman Usher of the Black Rod.

" Mr. Speaker;

"His Honor the President commands this Honorable House to attend "His Honor immediately in the Council Chamber."

Accordingly

Accordingly Mr. Speaker with the House, went up to attend His Honor the President in the Council Chamber; where the Speaker addressed His Honor the President to the effect following:

" May it please your Honor,

"His Majesty's faithful subjects, the Commons of New-Brunswick, im-"pressed with the importance of the trust reposed in them and the indis-"pensable duty incumbent on them, at this critical period to provide for the defence of the Province, have made that subject the principle object of their attention; this could in no way be provided for but by large and libe-"ral grants; other important objects have also claimed a share of their at-"tention, new sources of revenue have been resorted to.

"The House flatter themselves, the many instances of loyalty of the Pro-"vince will meet with Royal approbation, that the several Acts will receive "the Royal assent, meet a gracious reception and be expended to their full "satisfaction."

A Bill to establish a Winter Road from Bates's Mill Pond to the River Kennebeckacis, at or near the site of the old Court House in King's County.

A Bill to alter and amend an Act, intituled an Act, for the further regulation of Fisheries and for preventing their decay.

A Bill authorising the Mayor, Aldermen and Commonalty of the City of Saint John to make regulations for the more effectual prevention of Fires within the said City.
