FOLLOWING IS TEXT OF JOINT COMMUNIQUE ISSUED AT END OF THIRD CDA JAPAN MINISTERIAL MTG SEP5.

1.THE THIRD MTG OF THE CDA-JAPAN MINISTERIAL CTTEE WAS HELD AT THE MINISTRY OF FOREIGN AFFAIRS, TOKYO, ON SEP4 AND 5. 2.JAPAN WAS REPRESENTED AT THIS MTG BY THE HON ETSUSABURO SHIINA, MINISTER FOR FOREIGN AFFAIRS, HON KAKUEI TANAKA, MINISTER OF FINANCE, HON MUNENORI AKAGI, MINISTER OF AGRIC AND FORESTRY, HON YOSHIO SAKURAUCHI, MINISTER OF INTERNATIONAL TRADE AND INDUSTRY, HON MAMORU TAKAHASHI, DIRECTORGEN OF THE ECONOMIC PLANNING AGENCY AND MR HISANAGA SHIMAZU, AMBASSADOR TO CDA.

CDA WAS REPRESENTED BY THE HON PAUL MARTIN, SSEA, HON WALTER L GORDON, MINISTER OF FINANCE, HON NITCHELL SHARP, MINISTER OF TANDC, HON HEDARD ROBICHAUD, MINISTER OF FISHERIES AND MR RICHARD P BOWER, ANDASSADOR TO JAPAN.

3.THE CTTEE DISCUSSED THE INTERNATIONAL SITUATION IN GENERAL, PROBLEMS PERTAINING TO INTERNATIONAL TRADE AND ECONOMY, TRADE AND ECONOMIC RELATIONS BETWEEN CDA AND JAPAN, THE ECONOMIC SITUATIONS AND PROSPECTS IN THE TWO COUNTRIES AND OTHER MATTERS. THE DISCUSSIONS TOOK FLACE IN A FRIENDLY AND FRANK ATMOSPHERE AND GREATLY CONTRIBUTED TO FURTHER PROMOTION OF MUTUAL UNDERSTANDING BETWEEN THE TWO COUNTRIES.

4. THE MINISTERS NOTED THE NUMEROUS OCCASIONS ON WHICH DELS OF BOTH COUNTRIES HAVE WORKED TOGETHER AT THE UN.THEY REAFFIRMED BOTH COUNTRIES BELIEF IN THE UN AS THE MAIN HOPE FOR THE PROMOTION OF WORLD PEACE, AND EXPRESSED THEIR BELIEF THAT THE ORGANIZATION SHOULD BE STRENGTHENED AND ITS FINANCES ASSURED; THEY STRESSED IN PARTICULAR THE IMPORTANCE OF THE UN ROLE IN PEACE KEEPING.

5. THE MINISTERS OF THE TWO COUNTRIES EXCHANGED VIEWS ON OTHER INTERNATIONAL PROELEMS OF MUTUAL CONCERN SUCH AS EAST-WEST RELATIONS AS THEY HAVE BEEN AFFECTED BY THE SINO-SOVIET DISPUTE, AND THE SITUATION IN ASIA.

THE MINISTERS EXPRESSED THEIR CONCERN OVER THE MALAYSIAN ISSUE AND THEIR HOPE THAT THE DISPUTE MIGHT BE SETTLED BY PEACEFUL MEANS, IN ACCORDANCE WITH THE CHARTER OF THE UN.

THEY REVIEWED CLOSELY RECENT DEVELOPMENTS IN THE VIETNAMESE SITUATION AND AGREED ON THE URGENT NECESSITY OF RESTORING STABILITY AND OF IMPROVING THE WELL-BEING OF THE PEOPLE IN THE AREA. THE MINISTERS OF THE TWO COUNTRIES AGREED THAT THE CHINA PROBLEM WAS ONE OF THE MOST IMPORTANT PROBLEMS FACING NOT RPT NOT ONLY ASIA BUT THE WHOLE WORLD, AND THAT A PEACEFUL, REALISTIC AND EQUITABLE SOLUTION MUST BE WORKED OUT THROUGH CAREFUL EXAM OF ALL THE RELATED FACTORS.

6. THE TWO DELS EXPRESSED THEIR SATISFACTION WITH THE OBSERVANCE BY ALL COUNTRIES, WHETHER SIGNATORIES OR NOT RPT NOT, OF THE TREATY TO END NUCLEAR TESTING, AND THEIR EARNEST HOFE THAT THIS OBSERVANCE

WOULD CONTINUE.

7. THE CITEE AGREED THAT, IN VIEW OF THE GREAT INFLUENCE WHICH THE DEVELOPMENTS OF INTERNATIONAL SITUATIONS, PARTICULARLY IN ASIA, HAVE ON WORLD PEACE, CDA AND JAPAN AS NEIGHBOURING COUNTRIES ACROSS THE PACIFIC SHOULD CONTINUE TO MAINTAIN CLOSE COOPERATION AND CONTACT FOR THE STABILITY AND DEVELOPMENT OF THE ASIAN AND PACIFIC REGIONS, 8. AFTER EXCHANGING VIEWS ON THE CURRENT AND FUTURE ECONOMIC SITUATIONS IN BOTH JAPAN AND CDA, THE TWO DELS DISCUSSED THEIR RESPECTIVE TRADE RELATIONS WITH OTHER COUNTRIES AND IN PARTICULAR THE STATUS OF THE NULTILATERAL TRADE AND TARIFF NEGOTIATIONS INITIATED BY THE MAY MINISTERIAL MTG UNDER GATT IN GENEVA. THEY EMPHASIZED THE INPORTANCE OF THE SUCCESSFUL CONCLUSION OF THESE NEGOTIATIONS WHICH SEEK A SIGNIFICANT LIBERALIZATION OF WORLD TRADE IN BOTH INDUSTRIAL AND AGRICL PRODUCTS, AND ARE TO COVER BOTH TARIFF AND NONTARIFF OBSTACLES TO TRADE.BOTH JAPAN AND CDA WERE DETERMINED TO MAKE THEIR FULL CONTRIBUTION TO THE ACHIEVEMENT OF THE IMPORTANT OBJECTIVES OF THESE NEGOTIATIONS.IT WAS AGREED THAT CLOSE COOPERATION WOULD BE MAINTAINED BETWEEN THEIR RESPECTIVE DELS FOR THIS PURPOSE.

9. THE CTTEE EXCHANGED VIEWS ON THE POSITIONS OF THE TWO COUNTRIES RESPECTING EAST-WEST TRADE, AND EXPRESSED INTEREST IN THE FURTHER DEVELOPMENT OF SUCH TRADE ON A MUTUALLY ADVANTAGEOUS BASIS, THE JAPANESE MINISTERS EMPHASIZED THEIR POLICY THAT SUCH TRADE SHOULD BE FREE FROM ANY POLITICAL CONDITIONS.

10.THE MINISTERS RECOGNIZED THE URGENT NEED FOR CONCERTED INTER-NATIONAL EFFORTS TO ASSIST THE ECONOMIC DEVELOPMENT OF THE LESS ADVANCED COUNTRIES.THEY RECOGNIZED THE IMPORTANCE OF BETTER ACCESS TO THE MARKETS OF INDUSTRIALIZED COUNTRIES FOR THE EXPORTS OF DEVELOPING COUNTRIES.THE MINISTERS WELCOMED THE WORK BEGUN AT THE RECENT UN CONFERENCE ON TRADE AND DEVELOPMENT AT GENEVA.THEY STATED THE INTENTION OF THEIR TWO COUNTRIES TO FLAY CONSTRUCTIVE ROLES.IN HELPING FIND SOLUTIONS TO THE PROBLEMS OF THE LESS ADVANCED COUNTRIES THROUGH THE PROPOSED UN TRADE AND DEVELOPMENT BOARD AND OTHER APPROPRIATE FORUMS.

11.THE MINISTERS EXCHANGED VIEWS ON THE QUESTION OF INTERNATIONAL LIQUIDITY AND THE INCREASE OF RESOURCES OF THE INF.THEY AGREED THAT INTERNATIONAL LIQUIDITY SHOULD BE MAINTAINED AT LEVELS ADEQUATE FOR INTERNATIONAL TRADE AND FINANCE AND EXPRESSED THEIR SUPPORT FOR BOTH GENERAL AND SELECTIVE INCREASES IN FUND QUOTAS. 12.THE MINISTERS CAREFULLY REVIEWED TRADE AND ECONOMIC RELATIONS BETWEEN JAPAN AND CDA.THEY NOTED WITH SATISFACTION THE CONTINUED AND SUBSTANTIAL GROWTH OF TRADE BETWEEN THE TWO COUNTRIES SINCE THE TRADE AGREEMENT OF 1954 AND THE EXPECTATION OF EXPANSION IN THE FUTURE.THE MINISTERS AGREED THAT THERE WERE A VARIETY OF OPPORTUNITIES FOR JAPAN FURTHER TO DIVERSIFY ITS SALES TO CDA.THE CTTEE WELCOMED THAT IN THIS REGARD THE JAPANESE GOVT WOULD BE SENDING A HIGH LEVEL ECONOMIC MISSION TO CDA IN OCT. 13.THE JAPANESE MINISTERS DREW ATTENTION TO THE FACT THAT THE

JAPANESE EXPORTS TO CDA WERE SUBSTANTIALLY LOWER THAN THE CDN EXPORTS TO JAPAN AND EXPRESSED THEIR CONCERN ABOUT THE INHIBITION TO JAPANESE EXPORTS REPRESENTED BY VOLUNTARY RESTRAINTS ON THE EXPORT OF CERTAIN PRODUCTS.THE CTTEE RECOGNIZED THAT THESE VOLUNTARY RESTRAINTS AFFECTED IMPORTANT ELEMENTS OF JAPANESE TRADE AND RELATED TO SENSITIVE FORTION OF CDN PRODUCTION.THE MINISTERS AGREED THAT RECOURSE TO VOLUNTARY RESTRAINTS SHOULD BE KEPT TO A MINIMUM AND THAT CONSULTATIONS IN THIS REGARD SHOULD BE DEALT WITH EXPEDITIOUSLY AND ON A BASIS OF MUTUAL UNDERSTANDING. 14.CDN MINISTERS DREW ATTENTION TO THE EFFECTS ON CDN EXPORTS OF CERTAIN JAPANESE OBSTACLES TO TRADE.THEY NOTED THE PROGRESS MADE BY JAPAN IN ITS IMPORT LIBERALIZATION PROGRAM AND EXPRESSED HOPE FOR THE FURTHER REMOVAL OF REMAINING OBSTACLES AND THUS THE OPENING UP OF NEW OPPORTUNITIES FOR CDN SALES TO JAPAN.

15.THE MINISTERS OF THE TWO COUNTRIES EXPRESSED THEIR SATISFACTION THAT THE NEGOTIATIONS HELD BETWEEN THEIR GOVTS WITH A VIEW TO ENTERING INTO AN AGREEMENT FOR THE AVOIDANCE OF DOUBLE TAXATION AND THE PREVENTION OF FISCAL EVASION WITH RESPECT TO TAXES ON INCOME HAD BEEN SUCCESSFULLY CONCLUDED.THE AGREEMENT WAS SIGNED BY THE MINISTER OF FINANCE OF CDA AND THE MINISTER FOR FOREIGN AFFAIRS OF JAPAN IN TOKYO ON SEP5,1964, AND WILL BE SUBMITTED TO THE LEGISLATURES OF THE TWO COUNTRIES FOR APPROVAL BEFORE RATIFICA-TION.THE MINISTERS OF THE TWO COUNTRIES NOTED WITH SATISFACTION THAT NOTES FOR THE MUTUAL WAIVER OF VISA REQUIREMENTS WERE EX-

CHANGED BETWEEN THE SSEA OF CDA AND THE MINISTER FOR FOREIGN AFFAIRS OF JAPAN IN TOKYO ON SEP 1964. THE NOTES WILL COME INTO FORCE ON SEP20, 1964, AND WILL HELP PROMOTE THE EXCHANGE OF PERSONS BETWEEN THE TWO COUNTRIES.

16,THERE WAS A DISCUSSION OF POLICIES ON EMIGRATION AND IMMIG IN WHICH CDN MINISTERS OUTLINED THEIR COUNTRYS POLICY ON IMMIG MATTERS,WITH ITS PROVISION FOR THE ENTRY INTO CDA OF TRAINED OR PROFESSIONAL CANDIDATES FROM ANY COUNTRY WITHOUT DISCRIMINATION. THE CDN MINISTERS OUTLINED CDN FLANS FOR A WORLD FAIR IN MONTREAL IN 1967 AND THEIR HOPE THAT THE JAPANESE GOVT WOULD BE ABLE TO PARTICIPATE.

NINISTERS EXAMINED THE PROGRESS MADE IN THE DEVELOPMENT OF COMMUNICATION SATELLITES, AND THEIR GRATIFICATION WITH THE PROSPECT OF FUTURE COOPERATION BETWEEN THEIR TWO COUNTRIES IN THIS SPHERE,

17 THE MINISTERS OF THE TWO COUNTRIES EXCHANGED VIEWS ON FISHERIES PROELEMS, WITH REF TO THE FOSITION OF EACH COUNTRY AT THE FORTHCOMING MTG OF THE PARTIES TO THE INTERNATIONAL NORTH PACIFIC FISHERIES CONVENTION. THEY EXPRESSED THE HOPE THAT AT THE FORTHCOMING MTG IN OTT AN ACCEPTABLE FORMULA WILL BE FOUND TO NEET THE PROBLEMS FACING THE TWO COUNTRIES IN THIS FIELD. THEY FURTHER EXCHANGED VIEWS ON THE TERRITORIAL SEA AND THE FISHING ZONES ACT OF CDA WHICH RECENTLY CAME INTO FORCE.

18, THE MINISTERS OF THE TWO COUNTRIES EXPRESSED SATISFACTION THAT THIS MTG, LIKE THE TWO PREVIOUS NTGS, CONTRIBUTED GREATLY TOWARD BETTER UNDERSTANDING BETWEEN CDA AND JAPAN.

THE CTTEE ACCEPTED THE INVITATION OF THE CDN GOVT TO HOLD THE NEXT NTG IN OTT.
