

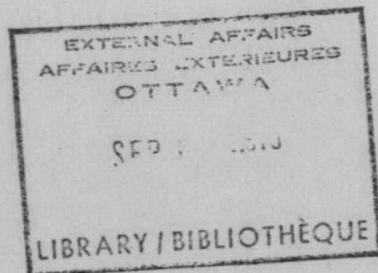

DIPLOMATIC APPOINTMENTS

DEPARTMENT OF EXTERNAL AFFAIRS
MINISTÈRE DES AFFAIRES EXTÉRIEURES

The Secretary of State for External Affairs, the Honourable Allan J. MacEachen, announces the following appointments which will take effect over the course of the next few months.

Mr. Kenneth C. Brown, 51, from Toronto, to be Ambassador to Sweden.

Mr. Brown (B.A., University of Toronto; Rhodes Scholar and B.A., Oxford) joined the Department of External Affairs in 1948 and has served abroad in Havana (1951-54), Berne (1957-60), Washington (1963-67) and, as Ambassador, in Havana with simultaneous accreditation to Haiti (1970-73). Since 1973 he has been Director of the United Nations Political and Institutional Affairs Division at departmental headquarters.

Mr. Brown succeeds Mr. R. Harry Jay, whose appointment as Ambassador and Permanent Representative to the United Nations (Geneva) was announced earlier.

Mr. Pierre Charpentier, 50, originally from Ottawa, to be Ambassador to Algeria.

Mr. Charpentier (B.A. Université de Montréal; certificat de philosophie, Collège dominicain, Ottawa; licencié en droit, Université de Montréal; M.A. (Rhodes Scholar) Oxford) joined the Department of External Affairs in 1952 and has served abroad in Madrid (1954-57), Warsaw (1959-61), Paris (1965-69), and, as Ambassador to Peru with concurrent accreditation to Bolivia (1970-73). Since 1973 he has been Director of the Latin American Division at departmental headquarters.

Mr. Charpentier replaces Mr. R. Elliott whose appointment as Minister at the Canadian Embassy in Paris was announced earlier.

Mr. P. Stewart Cooper, 60, originally from Revelstoke, British Columbia, to be High Commissioner to Sri Lanka.

Mr. Cooper has spent most of his professional career with the Department of National Defence. He has served as Chief of Staff, Western Command (Edmonton) (1954-56), Military Adviser to the Canadian Delegation to the International Commission for Control and Supervision in Laos (1956-57), Commandant of Royal Roads Military College (1957-60), Military Advisor to the ICSC in Laos (1961-62), Vice Adjutant-General of the Army (1962-64), Director-General, Personnel Plans and Requirements, Canadian Forces (1964-66), and as Canadian Commissioner with the ICSC in

Laos (1966-69). Mr. Cooper joined the Department of External Affairs in 1969, and has since then been Minister Counsellor (Administration) at the High Commission in London.

Mr. Cooper replaces Miss Marion Macpherson, whose next assignment is announced below.

Mr. C.F.W. Hooper, 51, originally from Toronto, to be High Commissioner to Jamaica.

Mr. Hooper (B.A., University of Toronto; A.M., Harvard; B.Litt., Oxford) joined the Department of External Affairs in 1950 and has served abroad in Caracas (1952), Buenos Aires (1953-56), New Delhi (1958-61), Dar-es-Salaam (1964-66) and London (1966-70). From 1972 Mr. Hooper was Co-ordinator at External Affairs headquarters for the Conference on Security and Co-operation in Europe, and since 1974 he has been Director of the Eastern European Division.

Mr. Hooper succeeds Mr. John M. Harrington who returns to Canada to take up an assignment as Academic Visitor at the University of Toronto.

Miss Marion Macpherson, 52, to be Consul-General in Boston.

Miss Macpherson (B.A., University of Saskatchewan; M.A., University of Toronto) has served abroad with the Department of External Affairs in Washington (1950-53), Indochina (1956-58), Accra (1958-59) and New York (1963-68). Since 1973 she has been High Commissioner to Sri Lanka.

Miss Macpherson succeeds Mr. Jean-Louis Delisle who retires at the end of this year.

Mr. H. Morton Maddick, 57, originally from St. John's, Newfoundland, to be Ambassador to Poland.

Mr. Maddick joined the Trade Commissioner Service in 1947 and has been assigned abroad in New York (1947-49), Washington (1949-50), Lisbon (1950-53), Madrid (1953), Rio de Janeiro (1954-57), Santiago (1957-60), London (1963-67) and, as Consul and Senior Trade Commissioner, in Cleveland (1967-68). From 1969-72 Mr. Maddick was the General Director of the Trade Commissioner Service and, in 1972, was appointed Ambassador to Ireland.

Mr. Maddick succeeds Mr. A. F. Hart who takes up an assignment in departmental headquarters.

Mr. Victor C. Moore, 58, originally from Esquimalt, British Columbia, to be High Commissioner in Zambia.

Mr. Moore (B.A., University of British Columbia), joined the Department of External Affairs in 1948 and has served abroad in Bonn and Berlin (1951-55), Moscow (1956-58), Karachi (1960-62), The Hague (1962-65), as Ambassador, Head of Canadian Delegation in Saigon and Hanoi (1965-67) and, as High Commissioner in Kingston, Jamaica with concurrent accreditation to the Bahamas and Belize (1968-72). Since 1972 he has been Director of the Commonwealth Institutions Division at External Affairs headquarters.

Mr. Moore succeeds Mr. Arthur F. Broadbridge who returns to Canada to retire.

Mr. Joseph Elmo Thibault, 55, originally from Embrun, Ontario, to be Ambassador to Romania.

Mr. Thibault (B.A., B.Ph., University of Ottawa) joined the Department of External Affairs in 1946 and has served abroad in Cape Town and Pretoria (1947-50), New York (1953-58), Belgrade (1958-60), Buenos Aires (1964-67), and, as Ambassador, in Yaounde (1967-69). Since 1974 he has been Director of Security Services Division at departmental headquarters.

Mr. Thibault, Canada's first resident Ambassador to Romania, assumes responsibilities previously held by the Canadian Ambassador resident in Belgrade, Mr. R. P. Cameron.
